2. 1. This matter is taken up through hybrid mode.

5. Mr. Mohanty, learned counsel appearing for Opposite Party Nos.2 and 3 submits that the issue involved in this writ petition is similar to W.P.(C) No.7990 of 2026 and batch of writ petitions, disposed of on 13th August, 2026.
