1. An explanatory statement pursuant to section 102 of the Companies Act, 2013 relating to Special Businesses 3 & 4 is annexed hereto and forms part of this notice.
2. A Member entitled to attend and vote at the 42nd Annual General Meeting (the "Meeting") is also entitled to appoint a proxy to attend and vote instead of himself/herself and the proxy need not be a Member of the Company.

A BLANK PROXY FORM IS ENCLOSED.

A person can act as a proxy on behalf of members not exceeding fifty and holding in the aggregate not more than ten percent of the total share capital of the Company carrying voting rights. A member holding more than ten percent of the total share capital of the Company carrying voting rights may appoint a single person as proxy and such person shall not act as a proxy for any other member. The instrument of Proxy in order to be effective, should be deposited at the Registered Office of the Company, duly completed and signed, not less than 48 hours before the commencement of the Annual General Meeting. Proxies submitted on behalf of the companies, societies etc., must be supported by an appropriate resolution/ authority, as applicable.

The Instrument appointing a proxy shall be in writing and be signed by the appointer or his/her attorney duly authorized in writing or, if the appointer is a body corporate, be under its seal or be signed by an officer or an attorney duly authorized by it.

Pursuant to Section 108 of the Companies Act, 2013, read with Rule 20 of the Companies (Management & Administration) Rules, 2014 as substituted by the Companies (Management and Administration) Amendment, Rules 2015, and Regulation 44 of the SEBI (Listing Obligation and Disclosure Requirement) Regulations, 2015, the Company is pleased to provide members facility to exercise their rights to vote on resolutions proposed in this notice by electronic means ("remote e-voting") and the business may be transacted through e-voting services, the said resolutions will not be decided on a show of hands at the AGM. The Company has engaged the services of National Securities Depository Limited (NSDL) to provide remote e-voting facilities and for security and enabling the members to cast their vote in a secure manner.

The instructions for members for voting electronically are as under: - In case of members receiving e-mail:

The voting period begins on Sunday, 27, September, 2026 at 9.00 A.M. and ends on Tuesday, 29, September, 2026 at 5.00 P.M. 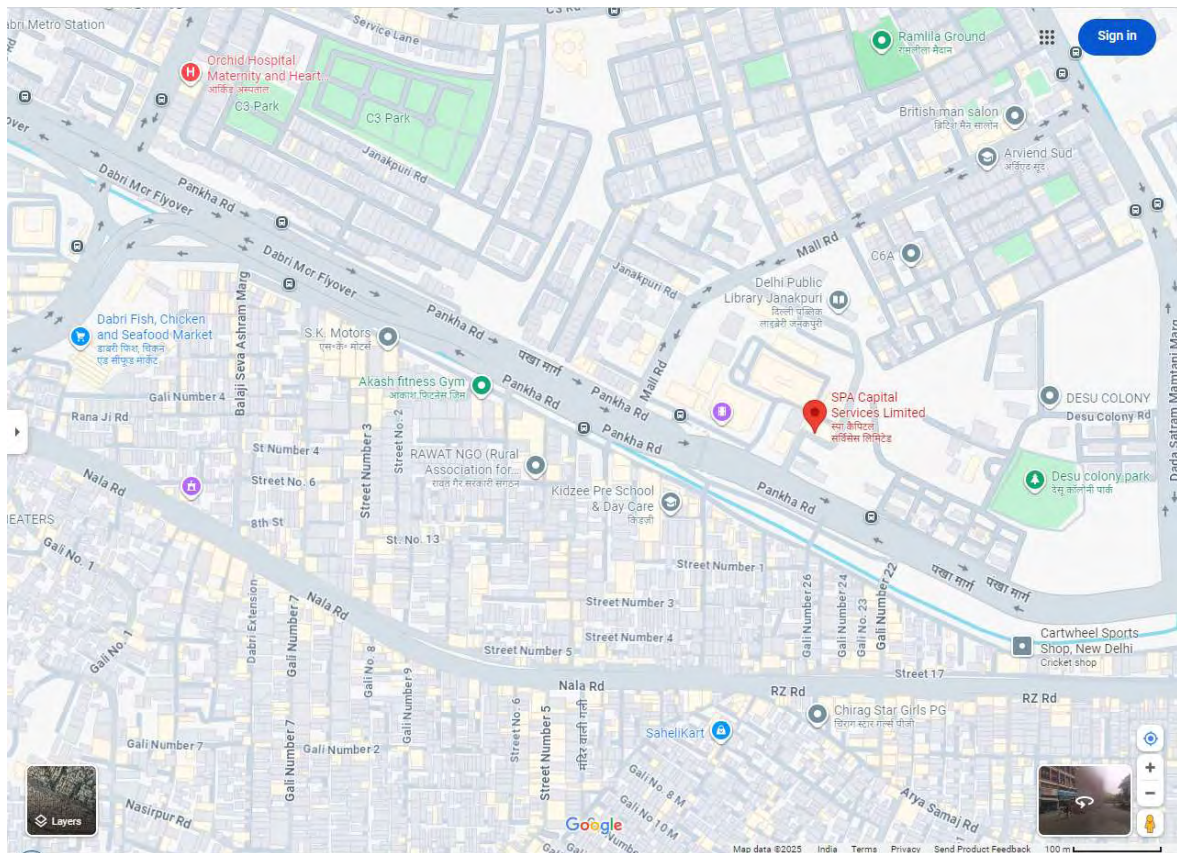

STATE OF COMPANY'S AFFAIRS

The Company's revenue primarily consist of revenue from sale of securities, brokerage income from distribution of Mutual Fund, other financial products, income from interest and dividend etc.

The Main object of the Company is to carry on business activities of leasing and hire-purchase, to finance the industrial enterprises by way of lending and advancing money etc., to manage investment pools, mutual funds, issue of shares, stocks, securities, etc. The Company is registered with the Reserve Bank of India ("RBI") as a Non-Banking Financial Company – Non Deposit, vide registration no. B-14.00790. The Company is also registered as a Mutual Fund Distributor/Advisor and holding AMFI (The Association of Mutual Funds in India) Certification.

The Company has not accepted any deposits from the public during its tenure of registration as NBFC-Non Deposit.

During the year, the Company reported total revenue of Rs. 3,86,210 and EBIDTA of Rs. 17,204 (**Rs. in Thousand**)

OPERATIONS REVIEW

In order to strengthen its market share, the Company has taken steps to improve the business, operation and growth strategy. Besides, efficiency improvement and cost optimization have been followed vigorously across all the functions of the organization, across the Country during the year.

It is one of the fastest growing financial service oriented company in India and enjoys strong brand equity from customers across segments/services.

During the year under review, the Company continued to focus on enhancing the capability of the organization and towards the achievement of this goal, the Company has been taking a number of initiatives.

DIVIDEND

Keeping in view the requirements of the Company for future, your Directors do not recommend any dividend for the financial year 2025-26 under the review.

TRANSFER TO RESERVE

In terms of Section 45-IC of the RBI Act 1934, the Company registered as NBFC with RBI is required to transfer at least 20% of its Profit after tax to a Reserve Fund before dividend is declared. As at the year end, an amount of Rs. 10,355/- (In Thousand) has been transferred to the Reserve Fund.

MATERIAL CHANGES AND COMMITMENTS AFFECTING THE FINANCIAL POSITION

No material changes and commitments have occurred from the date of close of the financial year till the date of this Report, which might affect the financial position of the Company.

SHARE CAPITAL

The Authorised Share Capital of the Company as on 31st March, 2026 was Rs. 50,000,000/- (Rupees Five Crore Only). The paid - up share capital of the Company as on 31st March, 2026 was Rs. 30,742,250/- (Rupees Three Crore Seven Lakh Forty Two Thousand Two Hundred Fifty Only) divided into 30,74,225

(Thirty Lakh Seventy Four Thousand Two Hundred Twenty Five) shares of Rs. 10/- (Rupees Ten each) each.

During the year, the Company has not made any alteration in share capital of the Company.

TRANSFER TO INVESTOR EDUCATION AND PROTECTION FUND

In the FY 2025-26, no amount has been transferred to the Investor Education and Protection Fund in pursuance of Section 125 of the Companies Act, 2013.

However, the Company is planning to broaden its operations by adopting competitive business strategy for strengthening existence and to reach amongst the larger consumer base to enhance its turnover and operating revenue.

SUBSIDIARY COMPANIES, JOINT VENTURES AND ASSOCIATE COMPANIES

The Company does not have any subsidiary and joint venture Company during the financial year 2025-26.

Further, during the year under review, the Company divested a portion of its shareholding in Booming Investment Advisor Private Limited (formerly known as SPA Investment Adviser Private Limited), resulting in a reduction of its shareholding from 40.20% to 4.95%. Consequently, the Company ceased to exercise significant influence over the said entity, and Booming Investment Advisor Private Limited ceased to be an Associate Company of the Company with effect from the date of such transfer of shares.

DEPOSITS

In FY 2025-26 the Company has not accepted or invited any amount falling within the purview of provisions of Section 73 of the Act read with the Companies (Acceptance of Deposits) Rules, 2014 (as amended).

SECRETARIAL STANDARDS OF ICSI

The Ministry of Corporate Affairs has mandated SS-1 and SS-2 with respect to Board meetings and General meetings respectively. The Company is in compliance with the same.

AUDITORS AND AUDITORS' REPORT

Statutory Audit

M/s Dhana & Associates, Chartered Accountants, holding FRN: 510525C, were appointed as Statutory Auditors of the Company at 39th AGM, shall hold office until the conclusion of 44th AGM of the Company. The Auditor's have put certain qualifications in their report to which the management has put forward the below mentioned replies;

Qualification and response to Auditor's Report

- A. The company has taken various loans, which were outstanding as on 31st March, 2026. The management has not provided the interest on some of the loans, which constitute a departure from the Accrual basis of accounting. The company's records indicate that an amount of Rs. 7,706/- (in Thousands) for the year ended on March 31, 2026 has not been provided as interest expenses on these loans, which would have decreased the profit by Rs. 7,706/- (in Thousands) for the year ended on March 31, 2026 and also increased the loan liability by same amount.
- B. The Company has given loans to various parties, which were outstanding as on 31st March, 2026 of Rs. 31,420/- (in Thousands), however the company has not charged any interest on such loans given by the company, so in absence of the same the loans are loss assets as per the NBFC guidelines issued by RBI, however the company has not made any Provision for loss assets, which constitute a departure from the NBFC guidelines and in view of the same the company's records indicate that profit of the company is overstated by Rs. 31,420 (in Thousands) on account of non-provision of loss assets and also the provision for loss assets is understated by Rs. 31,420 (in Thousands) and the loan assets are overstated by Rs. 31,420 (in Thousands) for the year ended on March 31, 2026.

Management Response:

Interest of Rs. 7,706/- (in Thousands) has not been provided in the books as there is some dispute going on with the concerned parties and management is of the view that no provision of interest is required in the books of accounts.

The Companies to whom loans are provided are not doing good in terms of current operations. Due to this interest has not been provided on the request of the parties but management is of the view that principle will be recovered. Due to this provision has not been provided in the books.

Secretarial Audit

Pursuant to the provisions of Section 204 of the Companies Act 2013 read with Rule 9 of the Companies (Appointment and Remuneration of Managerial Personnel) Rules, 2014, the Board has appointed M/s. HKB & Associates, A firm of Company Secretaries in Practice (COP No.: 21001), having office at 1/10072 D/B, St. No. 3J, DDA Colony, West Gorakh Park, Shahdara, Delhi-110032, as Secretarial auditor of the Company to undertake the Secretarial Audit for FY 2025-26. The secretarial audit report certified by the secretarial auditors, in the specified form MR-3 is annexed herewith and forms part of this report and enclosed as **Annexure - I**.

The Secretarial audit report does not contain any qualifications, reservations or adverse remarks.

Internal Auditor

Pursuant to provisions of section 138 of the Companies Act, 2013 the Company has appointed M/s. MANAGEMENT DISCUSSION AND ANALYSIS REPORT

GLOBAL

India's financial services industry continued to witness strong growth during FY2025-26, supported by increasing financialisation of household savings, rising retail investor participation, expanding capital-market activity and rapid adoption of digital financial services. The continued development of India's asset and wealth-management ecosystem presents significant long-term opportunities, supported by increasing participation from retail and institutional investors and the growing demand for investment and wealth-management products.

The Indian mutual fund industry continued its strong expansion during FY2025-26. According to data reported by the Association of Mutual Funds in India (AMFI) and cited by IBEF, mutual fund Assets Under Management (AUM) stood at ₹73.73 lakh crore as of March 31, 2026, compared with ₹66.70 lakh crore as of March 31, 2025. The industry also witnessed sustained growth in investor participation, with the total number of mutual fund folios reaching 28.10 crore as of March 2026. Equity-oriented schemes continued to account for a significant share of folios, reflecting increasing retail participation in financial markets.

Digital financial services continued to expand rapidly during FY2025-26. The Unified Payments Interface (UPI) emerged as a dominant component of India's digital payments ecosystem, processing approximately 24,161.69 crore transactions during FY2025-26, with a total transaction value of approximately ₹314.23 lakh crore. UPI accounted for around 84% of India's digital payments and represented approximately 49% of global real-time payment transaction volume in 2025, highlighting India's leadership in real-time digital payments.

The UPI ecosystem also continued to broaden its reach, with 741 banks live on the platform by July 2026. Monthly UPI transaction volumes reached a record 2,366 crore transactions in July 2026, reflecting continued adoption of digital payments by consumers, merchants and businesses.

With rising financialisation of household savings, increasing retail investor participation, continued growth in mutual fund assets, expanding wealth-management opportunities and widespread adoption of digital payments, India's financial services sector remains well positioned for sustained long-term growth. The combination of India's digital public infrastructure, growing household financial savings, deeper capital-market participation and increasing demand for investment and wealth-management products is expected to support the continued development of India's financial-services ecosystem.

INDIAN FINANCIAL INDUSTRY

India has a diversified and rapidly evolving financial services sector comprising commercial banks, small finance banks, payments banks, cooperative banks, non-banking financial companies (NBFCs), insurance companies, mutual funds, pension funds, capital-market intermediaries and other financial institutions. The sector has expanded significantly, supported by regulatory reforms, increasing financial inclusion, digitalisation and growing participation from private-sector institutions. The banking sector continues to remain a key component of India's financial system, while the importance of NBFCs, insurance companies, mutual funds and capital markets has increased steadily. India's financial services sector is undergoing a significant transformation, supported by rising domestic savings, deeper capital-market participation, increasing investor base, fintech adoption and the expansion of digital financial services.

The Government of India and the Reserve Bank of India (RBI) continued to implement measures aimed at strengthening financial stability, promoting financial inclusion and improving access to institutional credit. For Micro, Small and Medium Enterprises (MSMEs), the Credit Guarantee Scheme for Micro and Small Enterprises (CGTMSE) saw its credit guarantee ceiling enhanced from ₹5 crore to ₹10 crore for guarantees approved on or after April 1, 2025. The revised

framework also provides guarantee coverage of up to 90% for eligible categories, thereby supporting increased access to collateral-free credit for MSMEs.

The Government also continued to expand the role of the Pradhan Mantri MUDRA Yojana (PMMY) in supporting micro and small enterprises and promoting financial inclusion. As of March 27, 2026, PMMY had sanctioned over 57.79 crore loans aggregating ₹40.07 lakh crore, including ₹5.65 lakh crore sanctioned during FY2025–26 up to March 27, 2026. The continued scale of the scheme reflects the growing access to formal institutional credit among micro and small enterprises and entrepreneurs.

The Government has also strengthened credit-support mechanisms for MSMEs through the Mutual Credit Guarantee Scheme for MSMEs (MCGS-MSME). The scheme provides guarantee cover of up to 60% for eligible loans of up to ₹100 crore for the purchase of plant and machinery. During FY2025–26, the Government further modified the scheme to expand eligibility, including extending coverage to service-sector MSMEs, reducing compliance requirements and improving access to finance.

Digital infrastructure is increasingly becoming an important enabler of financial intermediation. The Reserve Bank of India's Unified Lending Interface (ULI) is intended to facilitate faster and more seamless credit delivery by enabling lenders to access standardised digital information from multiple sources. ULI has the potential to improve access to formal credit, particularly for underserved borrowers and MSMEs. In parallel, public-sector banks have introduced digital-footprint-based Credit Assessment Models to enable automated and objective credit assessment for MSME borrowers, thereby improving the efficiency and speed of loan appraisal.

The insurance industry remains a key pillar of India's financial services sector and continued to expand, supported by increasing awareness, rising incomes, greater private-sector participation, digital distribution and regulatory reforms. According to IBEF, total premium income of the Indian insurance industry stood at approximately ₹7.05 lakh crore in FY2024–25, representing a year-on-year increase of 5.6%. In the non-life insurance segment, gross direct premiums written increased from ₹2,89,673 crore in FY2023–24 to ₹3,07,611 crore in FY2024–25 and further to ₹3,35,918 crore in FY2025–26, reflecting sustained growth in general and health insurance demand.

The life-insurance segment also maintained strong momentum during FY2025–26. New business premiums (first-year premiums) increased by 15.70%, from ₹3,97,336.75 crore in FY2024–25 to ₹4,59,713.41 crore in FY2025–26, reflecting continued growth in policy issuance and expansion across individual and group insurance segments.

The regulatory environment also witnessed significant reforms during FY2025–26. The Sabka Bima, Sabki Raksha (Amendment of Insurance Laws) Act, 2025 introduced important changes to the insurance sector, including increasing the permitted foreign direct investment (FDI) limit in Indian insurance companies from 74% to 100%. The Act also reduced the net-owned-fund requirement for foreign reinsurers from ₹5,000 crore to ₹1,000 crore and introduced measures aimed at simplifying regulatory requirements and improving ease of doing business. These reforms are intended to attract additional capital, facilitate greater participation, strengthen reinsurance capacity and deepen insurance penetration in India.

With continued expansion across banking, NBFCs, insurance, mutual funds, pensions, digital payments and capital markets, India's financial services industry remains well positioned for sustained long-term growth. Increasing financial inclusion, rising household financial savings, digital public infrastructure, expanding access to formal credit, deeper capital-market participation and continued regulatory reforms are expected to support the further development of the sector and contribute to India's broader economic growth.

OUTLOOK

MUTUAL FUND FOLIOS

The Indian mutual fund industry enters FY 2026–27 on a strong growth trajectory, supported by increasing financialisation of household savings, rising retail participation, systematic investment plans (SIPs), digital adoption and growing investor awareness. During FY2025–26, the industry's Assets Under Management (AUM) increased to ₹73.73 lakh crore as of March 31, 2026, registering a 12.2% year-on-year growth. The continued expansion of the industry reflects the growing acceptance of mutual funds as an important vehicle for long-term investment and wealth creation. (amfiindia.com)

Investor participation continued to broaden during FY2025–26. The total number of mutual fund folios increased to 27.39 crore as of March 31, 2026, supported by continued retail participation and wider access to mutual fund products. The number of folios subsequently increased to 28.09 crore as of July 31, 2026, of which approximately 21.40 crore were in equity, hybrid and solution-oriented schemes, where the maximum investment is from the retail segment. (amfiindia.com)

The increase in folios demonstrates the continued deepening of mutual fund penetration across investor segments. The expansion of digital investment platforms, wider distribution networks and increasing financial awareness are expected to facilitate further participation, including from investors in smaller towns and cities.

SIP Flows

Systematic Investment Plans continued to be one of the key structural drivers of the mutual fund industry during FY2025–26. Monthly SIP contributions crossed the ₹32,000 crore mark for the first time, reaching a record **₹32,087 crore in March 2026**, representing a **23.8% year-on-year increase**. The number of contributing SIP accounts increased to **9.72 crore** in March 2026, compared with 9.44 crore in February 2026. (amfiindia.com)

SIP assets stood at approximately **₹15.11 lakh crore in March 2026**, representing around **20.5% of the industry's total AUM**. The continued growth in SIP assets and contributions demonstrates the increasing preference among investors for disciplined, periodic investment over longer investment horizons. (amfiindia.com)

The momentum continued into FY2026–27, with monthly SIP contributions standing at **₹31,961 crore in July 2026**. The sustained level of SIP contributions provides a relatively stable source of domestic flows and is expected to remain an important contributor to mutual fund industry growth during FY2026–27.

Demographics

Individual investors continued to be a key contributor to the growth of the Indian mutual fund industry. As of March 2026, individual investors held approximately ₹45.96 lakh crore in mutual fund assets. Of these assets, approximately 63.1% or ₹28.99 lakh crore was invested in equity-oriented schemes, while hybrid schemes accounted for 17.7%. This asset mix highlights the significant role played by individual investors in supporting equity-oriented and long-term investment products. (amfiindia.com)

The geographical penetration of mutual funds is also broadening. In January 2026, cities beyond the Top 30 (B30) accounted for approximately 18.9% of mutual fund assets, while Top 30 (T30) cities accounted for approximately 81.1%. Equity-oriented schemes represented a relatively higher share of assets in B30 locations, accounting for approximately 64.1% of B30 assets, compared with 38.2% in T30 locations. (amfiindia.com)

The continued growth of B30 participation, supported by distributor networks, digital platforms and increasing financial awareness, is expected to remain an important opportunity for the industry during FY2026–27.

INDIAN MUTUAL FUND INDUSTRY TRENDS

The Indian mutual fund industry continued to demonstrate resilience during FY2025–26 despite periods of market volatility. Equity funds recorded positive net inflows for the 61st consecutive month in March 2026, with net inflows of approximately ₹40,450 crore. Flexi-cap funds led the equity category during the month, recording net inflows of approximately ₹10,054 crore.

FUTURE PROSPECTS AND OUTLOOK

The outlook for the Indian mutual fund industry during FY2026–27 remains positive. The industry enters the year with a significantly expanded asset base, a growing investor population and sustained SIP participation. Continued financialisation of household savings, increasing retail participation, rising financial awareness and the expansion of digital investment platforms are expected to remain key structural drivers of growth.

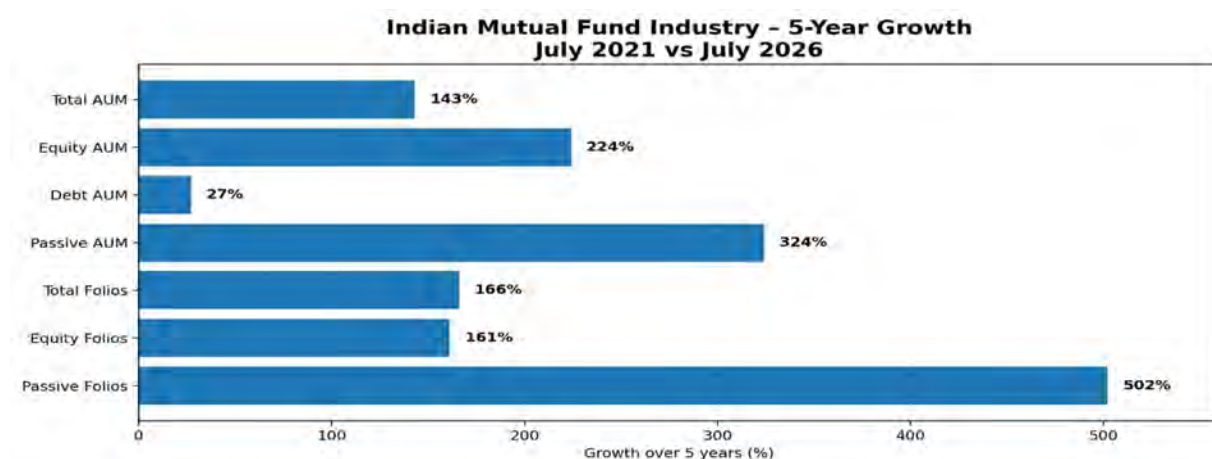
The industry's AUM stood at ₹73.73 lakh crore at the end of FY2025–26 and subsequently increased to ₹85.76 lakh crore by July 2026, while total folios increased to 28.09 crore. These developments indicate continued momentum in investor participation and asset mobilisation at the beginning of FY2026–27. (amfiindia.com)

SIP-based investing is expected to remain an important source of stable retail flows, with monthly contributions reaching ₹32,087 crore in March 2026 and remaining strong at ₹31,961 crore in July 2026. The continued adoption of SIPs is likely to support disciplined long-term investment behaviour and deepen retail participation in capital markets. (amfiindia.com)

The expansion of mutual fund penetration in B30 locations, growing adoption of digital investment platforms and increasing interest in equity, hybrid and passive products are expected to create additional opportunities for industry growth. At the same time, market volatility, global economic conditions, interest-rate movements and changes in investor sentiment may influence short-term asset valuations and investment flows.

Overall, the Indian mutual fund industry is well positioned for continued long-term expansion during FY2026–27. The combination of a growing investor base, increasing financialisation of savings, sustained SIP flows, expanding digital distribution and broader product availability is expected to support further growth in mutual fund assets and folios and contribute to the continued deepening of India's capital markets.

Qualified Opinion

We have audited the accompanying standalone Ind AS financial statements of **SPA CAPITAL SERVICES LIMITED** ("the Company"), which comprise the Balance sheet as at March 31, 2026, the Statement of Profit and Loss including the statement of Other Comprehensive Income, the Cash Flow Statement and the Statement of Changes in Equity for the year then ended, and notes to the financial statements, including a summary of significant accounting policies and other explanatory information.

In our opinion and to the best of our information and according to the explanations given to us, except for the possible effects of the matter described in the 'Basis for Qualified Opinion' section of our report, the aforesaid standalone Ind AS financial statements give the information required by the Companies Act, 2013, as amended ("the Act") in the manner so required and give a true and fair view in conformity with the accounting principles generally accepted in India, of the state of affairs of the Company as at March 31, 2026, its profit including other comprehensive income, its cash flows and the changes in equity for the year ended on that date.

Basis for Qualified Opinion

1. The company has taken various loans, which were outstanding as on 31st March, 2026. The management has not provided the interest on some of the loans, which constitute a departure from the Accrual basis of accounting. The company's records indicate that an Rs. 7,706/-(in Thousands) for the year ended on March 31, 2026 has not been provided as interest expenses on these loans, which would have been decrease the profit Rs. 7,706/-(in Thousands) for the year ended on March 31, 2026 and also increase the loan liability by same amount.
2. The company has given loans to various parties, which were outstanding as on 31st March, 2026 of Rs 31,420 (in Rs Thousands), however the company has not charged any interest on such loans given by the company, so in absence of the same the loans are loss assets as per the NBFC guidelines issued by RBI, however the company has not made any Provision for loss assets, which constitute a departure from the NBFC guidelines and in view of the same the company's records indicate that profit of the company is overstated by 31,420(in Rs Thousands) on account of non-provision of loss assets and also the provision for loss assets is understated by Rs 31,420 (in Rs Thousands) and the loan assets are overstated by 31,420 (in Rs Thousands) for the year ended on March 31, 2026

Key Audit Matter(s)

Key audit matters are those matters that, in our professional judgment, were of most significance in our audit of the standalone financial statements of the current period. These matters were addressed in the context of our audit of the standalone financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters.

Information other than Financial Statements and Auditors Report Thereon

The Company's management and Board of Directors are responsible for the other information. The other information comprises the information included in the Company's annual report, but does not include the financial statements and our auditors' report thereon. Our opinion on the Standalone Financial Statements does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the Standalone Financial Statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the Standalone Financial Statements or our knowledge obtained in the audit or otherwise appears to be materially misstated. If, based on the work we have performed, we conclude that there is a material misstatement of this other information; we are required to report that fact. We have nothing to report in this regard.

NOTES TO FINANCIAL STATEMENTS FOR THE YEAR ENDED MARCH 31, 2026

1 Company overview and Significant Accounting Policies

1.1 Corporate Information

SPA Capital Services Limited ("the Company") is a public limited company incorporated on July 20, 1984 under the provisions of the Companies Act, 1956. The Company is engaged in providing Wealth Management and Financial Advisory services to institutions, corporate and individuals. The Company is also registered with Reserve Bank of India as a Non-Deposit Accepting Non Banking Financial Institution.

2.1 Basis of Preparation of Financial Statements

These financial statements have been prepared in accordance with Indian Accounting Standards (IndAS), under the historical cost convention on the accrual basis except for certain financial instruments which are measured at fair values, the provisions of the Companies Act, 2013 ('the Act') (to the extent notified) and guidelines issued by the Securities and Exchange Board of India (SEBI). The IndAS are prescribed under Section 133 of the Companies Act read with Rule 3 of the Companies (Indian Accounting Standards) Rules, 2015 and relevant amendment rules issued thereafter.

Historical cost is generally based on the fair value of the consideration given in exchange for goods and services. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

All assets and liabilities are classified as Current and Non-Current as per company's normal operating cycle of 12 months which is based on the nature of business of the Company. Current Assets do not include elements which are not expected to be realised within one year and Current Liabilities do not include items which are due after one year, the period of one year being reckoned from the reporting date.

Accounting policies have been consistently applied except where a newly issued accounting standard is initially adopted or are vision to an existing accounting standard requires a change in the accounting policy hitherto in use.

Rounding off

All amounts in the financial statement and accompanying notes are presented in Lacs and have been rounded-off to two decimal place unless stated otherwise.

2.2 Use of Estimates and Judgement

The preparation of financial statements requires management to exercise judgement and make estimates and assumptions that affects the reported amounts of revenue, expenses, assets and liabilities. These estimates and assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances. Actual results may differ from these estimates. These estimates and underlying assumptions are reviewed on a periodic basis. Revisions to accounting estimates are recognised in the period in which the results are known/materialise.

The areas involving significant estimates and judgement include determination of useful life of Property, Plant and Equipment (Refer note 1.4), measurement of defined benefit obligations, and recognition of deferred tax assets/liabilities (Refer note 5).

2.3 Property, Plant and Equipment

Property, Plant and Equipment are stated at cost of acquisition or construction less accumulated depreciation and impairment, if any. For this purpose, cost includes deemed cost which represents the carrying value of Property, Plant and Equipment recognised as at 1st April, 2016 measured as per the previous GAAP.

Cost is inclusive of inward freight, duties and taxes and incidental expenses related to acquisition. In respect of major projects involving construction, related pre-operational expenses form part of the value of assets capitalised. Expenses capitalised also include applicable borrowing costs for qualifying assets, if any. All Upgradation / enhancements are charged off as revenue expenditure unless they bring similar significant additional benefits.

An item of property, plant and equipment is derecognized upon disposal or when no future economic benefits are expected to arise from the continued use of asset. Any gain or loss arising on the disposal or retirement of an item of property, plant and equipment is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognised in the Statement of Profit and Loss.

The useful lives have been determined based on technical evaluation done by the expert's which are in line those specified by Schedule II to the Companies Act 2013. The residual values are not more than 5% of the original cost of the asset. The depreciation methods, assets' residual values and useful lives are reviewed, and adjusted if appropriate, at the end of each reporting period.

Advances paid towards the acquisition of property, plant and equipment outstanding at each Balance Sheet date is classified as capital advances under Other Non-Current Assets and the cost of assets not put to use before such date is disclosed under 'Capital work-in-progress'.

The cost and related accumulated depreciation are eliminated from the financial statements upon sale or retirement of the asset and the resultant gains or losses are recognized in the Statement of Profit and Loss.

2.4 Intangible Assets

Intangible assets are stated at cost less accumulated amortization and impairment. Intangible assets are amortized over their respective individual estimated useful lives on a straight-line basis, from the date they are available for use. The estimated useful life of an identifiable intangible asset is based on a number of factors including the effects of obsolescence, demand, competition, and other economic factors (such as the stability of the industry, and known technological advances), and the level of maintenance expenditures required to obtain the expected future cash flows from the asset.

2.5 Investments :

Investments are classified as Current or Non-Current based upon management intent at the time of acquisition. Investments that are intended to be held for not more than one year from the date of acquisition are classified as Current Investments. All other investments are classified as Non-Current Investments.

2.6 Inventories

The shares and securities acquired with the intention of trading are considered as Stock in trade and disclosed as Current Assets. The stock in trade of securities is valued at lower of aggregate cost or aggregate market price / aggregate net asset value in case of unquoted, as per the provisions of ICDS. The cost is determined on First In First Out (FIFO) basis.

2.7 Financial Instruments, Financial Assets, Financial Liabilities and Equity Instruments

Recognition

Financial assets include Investments, Trade receivables, Advances, Security Deposits, Cash and Cash Equivalents. Such assets are initially recognised at transaction price when the Company becomes party to contractual obligations. The transaction price includes transaction costs unless the asset is being fair valued through the Statement of Profit and Loss.

Classification

Management determines the classification of an asset at initial recognition depending on the purpose for which the assets were acquired. The subsequent measurement of financial assets depends on such classification.

Financial assets are classified as those measured at:

Amortised cost

Where the financial assets are held solely for collection of cash flows arising from payments of principal and/ or interest.

Fair Value Through Other Comprehensive Income (FVTOCI)

Where the financial assets are held not only for collection of cash flows arising from payments of principal and interest but also from the sale of such assets. Such assets are subsequently measured at fair value, with unrealised gains and losses arising from changes in the fair value being recognised in Other Comprehensive Income.

Fair Value Through Profit or Loss (FVTPL)

Where the assets are managed in accordance with an approved investment strategy that triggers purchase and sale decisions based on the fair value of such assets. Such assets are subsequently measured at fair value, with unrealised gains and losses arising from changes in the fair value being recognised in the Statement of Profit and Loss in the period in which they arise.

Measurement

Trade receivables, Advances, Security Deposits, Cash and cash equivalents etc. are classified for measurement at amortised cost while investments may fall under any of the aforesaid classes. However, in respect of particular investments in equity instruments that would otherwise be measured at fair value through profit or loss, an irrevocable election at initial recognition may be made to present subsequent changes in fair value through other comprehensive income.

Impairment of Financial Assets

The Company assesses on a forward looking basis the expected credit losses associated with its assets carried amortized cost and FVOCI debt instruments. The impairment methodology applied depends on whether there has been a significant increase in credit risk.

For trade receivables only, the Company applies the simplified approach permitted by Ind AS 109 Financial Instruments, which requires expected lifetime losses to be recognized from initial recognition of the receivables.

Derecognition of Financial Assets

A financial asset is derecognised only when

- The Company has transferred the rights to receive cash flows from the financial asset; or
- Retains the contractual rights to receive the cash flows of the financial asset, but assumes a contractual obligation to pay the cash flows to one or more recipients.

Where the entity has transferred an asset, the Company evaluates whether it has transferred substantially all risks and rewards of ownership of the financial asset. In such cases, the financial asset is derecognised. Where the entity has not transferred substantially all risks and rewards of ownership of the financial asset, the financial asset is not derecognised.

Where the entity has neither transferred a financial asset nor retained substantially all risks and rewards of ownership of the financial asset, the financial asset is derecognised if the Company has not retained control of the financial asset. Where the Company retains control of the financial asset, the asset is continued to be recognised to the extent of continuing involvement in the financial asset.

Income Recognition

Dividend income is recognised in the Statement of Profit and Loss when the right to receive dividend is established.

Offsetting Financial Instruments

Financial assets and liabilities are offset and the net amount is reported in the balance sheet where there is a legally enforceable right to offset the recognised amounts and there is an intention to settle on a net basis or realise the asset and settle the liability simultaneously. The legally enforceable right must not be contingent on future events and must be enforceable in the normal course of business and in the event of default, insolvency or bankruptcy of the Company or the counterparty.

Financial Liabilities

i) Trade Payables and Other Financial Liabilities

Trade Payables and Other Financial Liabilities are initially recognised at the value of the respective contractual obligations. Trade and other payables represent liabilities for goods and services provided to the Company prior to the end of financial year which are unpaid. The amounts are unsecured and presented as current liabilities unless payment is not due within 12 months after the reporting period.

ii) Borrowings

Borrowings are removed from the balance sheet when the obligation specified in the contract is discharged, cancelled or expired. The difference between the carrying amount of a financial liability that has been extinguished or transferred to another party and the consideration paid, including any non-cash assets transferred or liabilities assumed, is recognized in profit or loss as other gains/(losses).

Borrowings are classified as current liabilities unless the Company has an unconditional right to defer settlement of the liability for at least 12 months after the reporting period. Where there is a breach of a material provision of a long-term loan arrangement on or before the end of the reporting period with the effect that the liability becomes payable on demand on the reporting date, the entity does not classify the liability as current, if the lender agreed, after the reporting period and before the approval of the financial statements for issue, not to demand payment as a consequence of the breach.

Equity Instruments

Equity shares are classified as equity. Incremental costs directly attributable to the issue of new shares or options are shown in equity as deduction, net of tax, from the proceeds.

2.8 Revenue Recognition

(a) Sale of Shares & Securities

Revenue from sales is recognized at the completion of each settlement of the capital market segment of the Stock Exchange.

In respect of non-delivery based transactions in capital market segment, the profit/loss is accounted for at the end of each settlement.

Revenue from derivative market segment:-

- in respect of settled contracts the difference between the transaction price and settlement price is recognized in the Statement of Profit and Loss; and

- in respect of open interests as on the balance sheet date, the derivatives are valued at fair value, and the difference between the fair value and the transaction price, is recognized in the Statement of Profit and Loss.

Income from Dividend is recognized when the right to receive payment is established.

(b) Other Income

Gain on Sale of Investment is recorded on transfer of title from the Company and is determined as the difference between the sale price and carrying value of the investment.

The revenue from Interest & Other Income is recognized on accrual basis as part of Other Income in the Statement of Profit and Loss.

2.9 Employee Benefits

a. Short-term Obligations

Liabilities for wages, salaries and bonus, including non-monetary benefits that are expected to be settled wholly within 12 months after the end of the period in which the employees render the related service are recognised in respect of employees' services up to the end of the reporting period and are measured at the amounts expected to be paid when the liabilities are settled. The liabilities are presented as current employee benefit obligations in the balance sheet.

b. Post-Employment Obligations

The Company operates the following post-employment schemes:

- defined benefit plans for gratuity, and
- defined contribution plans for provident fund.

Defined Benefit Plans

The liability or asset recognised in the balance sheet in respect of defined benefit gratuity plans is the present value of the defined benefit obligation at the end of the reporting period less the fair value of plan assets. The defined benefit obligation is calculated annually by actuaries using the projected unit credit method. The present value of the defined benefit obligation is determined by discounting the estimated future cash outflows by reference to market yields at the end of the reporting period on government bonds that have terms approximating to the terms of the related obligation.

The net interest cost is calculated by applying the discount rate to the net balance of the defined benefit obligation and the fair value of plan assets. This cost is included in employee benefit expense in the statement of profit and loss. Remeasurement gains and losses arising from experience adjustments and changes in actuarial assumptions are recognised in the period in which they occur, directly in other comprehensive income. They are included in retained earnings in the statement of changes in equity and in the balance sheet. Changes in the present value of the defined benefit obligation resulting from plan amendments or curtailments are recognised immediately in profit or loss as past service cost.

Defined Contribution Plans

The Company pays provident fund contributions to publicly administered provident funds as per local regulations. The Company has no further payment obligations once the contributions have been paid. The contributions are accounted for as defined contribution plans and the contributions are recognised as employee benefit expense when they are due. Prepaid contributions are recognised as an asset to the extent that a cash refund or a reduction in the future payments is available.

2.10 Impairment of Non-Financial Assets

Intangible assets and property, plant and equipment are evaluated for recoverability whenever events or changes in circumstances indicate that their carrying amounts may not be recoverable. For the purpose of impairment testing, the recoverable amount (i.e. the higher of the fair value less cost to sell and the value-in-use) is determined on an individual asset basis unless the asset does not generate cash flows that are largely independent of those from other assets. In such cases, the recoverable amount is determined for the cash generating unit to which the asset belongs.

2.11 Borrowing Costs

Borrowings are measured at amortized cost. Fees paid on the establishment of loan facilities are recognized as transaction costs of the loan to the extent that it is probable that some or all of the facility will be drawn down. To the extent there is no evidence that it is probable that some or all of the facility will be drawn down, the fee is capitalized as a prepayment for liquidity services and amortized over the period of the facility to which it relates.

General and specific borrowing costs that are directly attributable to the acquisition, construction or production of a qualifying asset are capitalised during the period of time that is required to complete and prepare the asset for its intended use or sale. Qualifying assets are assets that necessarily take a substantial period of time to get ready for their intended use or sale. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation. Other borrowing costs are expensed in the period in which they are incurred.

2.12 Income Tax

Income tax expense comprises current tax expense and the net change in the deferred tax asset or liability during the year. Current and deferred tax are recognised in the Statement of Profit and Loss, except when they relate to items that are recognised in Other Comprehensive Income or directly in equity, in which case, the current and deferred tax are also recognised in Other Comprehensive Income or directly in equity, respectively.

(i) Current tax:

Current tax expenses are accounted in the same period to which the revenue and expenses relate. Provision for current income tax is made for the tax liability payable on taxable income after considering tax allowances, deductions and exemptions determined in accordance with the applicable tax rates and the prevailing tax laws.

Current tax assets and current tax liabilities are offset when there is a legally enforceable right to set off the recognised amounts and there is an intention to settle the asset and the liability on a net basis.

(ii) Deferred tax :

Deferred income tax is recognised using the balance sheet approach. Deferred tax assets and liabilities are recognised for deductible and taxable temporary differences arising between the tax base of assets and liabilities and their carrying amount in financial statements, except when the deferred tax arises from the initial recognition of goodwill, an asset or liability in a transaction that is not a business combination and affects neither accounting nor taxable profits or loss at the time of the transaction.

Deferred income tax assets are recognised to the extent that it is probable that taxable profit will be available against which the deductible temporary differences and the carry forward of unused tax credits and unused tax losses can be utilised.

Deferred tax liabilities are generally recognised for all taxable temporary differences except in respect of taxable temporary differences associated with investments in subsidiaries, associates and interests in joint ventures where the timing of the reversal of the temporary difference can be controlled and it is probable that the temporary difference will not reverse in the foreseeable future.

Deferred tax liabilities and assets are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset realised, based on tax rates (and tax laws) that have been enacted or substantially enacted by the end of the reporting period.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to set off current tax assets against current tax liabilities and when they relate to income taxes levied by the same taxation authority and the Company intends to settle its current tax assets and liabilities on a net basis.

Minimum Alternative Tax ("MAT") credit forming part of deferred tax assets is recognised as an asset only when and to the extent there is convincing evidence that the Company will pay normal income tax during the specified period. Such asset is reviewed at each Balance Sheet date and the carrying amount of the MAT credit asset is written down to the extent there is no longer a reasonable certainty to the effect that the Company will pay normal income tax during the specified period.

2.13 Ind AS 12 Appendix C, Income Tax

On March 30, 2019, the Ministry of Corporate Affairs has notified Ind AS 12 Appendix C, Uncertainty over Income Tax Treatments which is to be applied while performing the determination of taxable profit (or loss), tax bases, unused tax losses, unused tax credits and tax rates, when there is uncertainty over income tax treatments under Ind AS 12. According to the appendix, companies need to determine the probability of the relevant tax authority accepting each tax treatment, or group of tax treatments, that the companies have used or plan to use in their income tax filing which has to be considered to compute the most likely amount or the expected value of the tax treatment when determining taxable profit (tax loss), tax bases, unused tax losses, unused tax credits and tax rates. The standard permits two possible methods of transition - i) Full retrospective approach - Under this approach, Appendix C will be applied retrospectively to each prior reporting period presented in accordance with Ind AS 8 - Accounting Policies, Changes in Accounting Estimates and Errors, without using hindsight and ii) Retrospectively with cumulative effect of initially applying Appendix C recognized by adjusting equity on initial application, without adjusting comparatives. The effective date for adoption of Ind AS 12 Appendix C is annual periods beginning on or after April 1, 2019. The Company will adopt the standard on April 1, 2019 and has decided to adjust the cumulative effect in equity on the date of initial application i.e. April 1, 2019 without adjusting comparatives. The effect on adoption of Ind AS 12 Appendix C would be insignificant in the standalone financial statements.

2.14 Earnings Per Share

a. Basic Earnings Per Share

Basic earnings per share is calculated by dividing:

- the profit attributable to owners of the Company
- by the weighted average number of equity shares outstanding during the financial year

b. Diluted Earnings Per Share

Diluted earnings per share adjusts the figures used in the determination of basic earnings per share to take into account the after-income tax effect of interest and other financing costs associated with dilutive potential equity shares, and the weighted average number of additional equity shares that would have been outstanding assuming the conversion of all dilutive potential equity shares.

2.15 Cash Flow Statement

Cash flows are reported using the indirect method, whereby profit/loss for the period is adjusted for the effects of transactions of a non-cash nature, any deferrals or accruals of past or future operating cash receipts or payments and item of income or expenses associated with investing or financing cash flows. The cash flows from operating, investing and financing activities of the Company are segregated.

2.16 Events occurring after the Balance Sheet date

There have been no material events other than disclosed in the financial statements after reporting date which would require disclosure or adjustments to the financial statements as of and for the year ended 31 March 2026.
