We are pleased to inform that the 70th Annual General Meeting (“AGM”) of NLC India Limited (“Company”) is scheduled on Tuesday, September 29, 2026 at 15-00 (IST) through Video Conference (“VC”) / Other Audio-Visual Means (“OAVM”) to transact the business as set out in the Notice convening the AGM for the financial year (FY) 2025-26.

In compliance with the MCA and SEBI Circulars, the Notice of the 70th AGM, along with the Annual Report for the FY 2025-26, is being sent through electronic mode to those shareholders whose email addresses are registered with the Depository Participant(s) (DP) or the Registrar and Transfer Agent (RTA). As your email address is not registered with the DP or RTA in accordance with Regulation 36(1)(b) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, please find below the web link to access the Annual Report of the Company for FY 2025-26, the Notice of the AGM:

The said Notice of AGM is also available on the website of National Securities Depository Limited (“NSDL”) at www.evoting.nsdl.com and the websites of the Stock Exchanges, i.e. BSE Limited and National Stock Exchange of India Limited at www.bseindia.com, www.nseindia.com, respectively.

Pursuant to the applicable provisions of MCA and SEBI circulars, this AGM is being held through VC / OAVM, without the physical presence of the shareholders at a common venue. The proceedings of the AGM shall be deemed to be conducted at the Registered Office of the Company, which shall be the deemed venue of the AGM. The Company is providing to the shareholders the facility to exercise their right to vote by electronic means, i.e. remote e-voting and e-voting during the AGM (together referred to as “e-voting”). The facility of casting votes through e-voting and attending AGM through VC / OAVM is being provided by NSDL. The Notice of AGM inter-alia contains the process and manner for e-voting and attending the AGM through VC / OAVM. The Notice also contain instructions/ details with regard to the process of obtaining login credentials for shareholders, holding shares in physical form or in electronic form, who have not registered their e-mail address. The remote e-voting timelines for e-voting and attending the AGM are provided overleaf.

An equity shareholder, whose name is recorded in the Register of Members or in the Register of Beneficial Owners maintained by the RTA / Depositories as on the Cut-off Date, only shall be entitled to vote through remote e-voting and attend the AGM. A person who is not a shareholder as on the Cut-off Date, should treat the Notice for information purpose only. Voting rights of a shareholder shall be in proportion to the shareholding in the paid-up equity share capital of the Company as on the Cut-off Date. KYC details for shares held in physical mode

The Board of Directors of the Company at its meeting held on 13th May, 2026, has recommended Final Dividend of Rs. 0.25 per equity share of Rs.10/- each (i.e.2.5%) for the year ended 31st March 2026, subject to the approval of members at the ensuing Annual General Meeting (AGM).

For shares held in physical form, the said Final dividend will be paid only through electronic mode, upon furnishing the PAN and KYC details, in entirety. It is requested that duly filled KYC forms, signed by shareholder(s), including joint holders, if any, along with self-attested proofs / relevant enclosures, as specified in the respective forms, shall be sent / submitted to the RTA on or before September 22, 2026.

Bank details to be updated in demat account for shares held in demat mode

Shareholders holding shares in demat mode are requested to ensure that their core banking bank account details including the IFSC / MICR code of their bank branch is properly updated in the demat account. Please note that the dividend would be credited only through electronic mode to the bank account details available in the demat account. Hence, shareholders are requested to contact their Depository Participant (DP) to update their bank details, in case of any change.

As per the recent amendments of SEBI (LODR) Regulations, 2015, in case the dividend credited through electronic mode are rejected for any reason, such dividend will be credited only through electronic mode only upon updation of correct bank details in the respective Folio / Demat account. Dividend warrant / Cheque / Demand Draft will not be issued against such rejection cases.

Information on Deduction of Tax at Source from Final Dividend for FY 2025-26

As per the provisions of the Income Tax Act, 2025, the Company would be required to withhold taxes at the prescribed rates on the dividend paid to its shareholders. Shareholders are requested to submit the tax exemption forms, if any directly through the below link on or before September 22, 2026:
