1. The Applicant has filed the present application seeking following prayers:
 - i. *To schedule an urgent hearing of IA 41/2022 concurrently with this application.*
 - ii. *That further proceedings in CP 114/2018 be stayed until translations of all Gujarati annexures are in compliance with Rule 27(2) of the NCLT rules.*
 - iii. *To Issue an immediate injunction to halt all hazardous and unlawful commercial activities conducted on the Madhapar lands by Respondent No. 1 company and its directors, Respondent Nos. 2 and 3, carried out without requisite permission.*
 - iv. *To hold the directors accountable for their negligence, impose penalties on directors, and cease all hazardous activities, as detailed herein in subparagraphs a, b, and c:*

- a) *Hold Directors, Respondent No. 2, Smt. Jyotsanaben Vadalia, and Respondent No. 3, Shri Maheshkumar Vadalia, of Respondent No 1 company accountable for negligence in authorizing hazardous activities on the Madhapar lands.*

- c) *Order the immediate cessation of all unauthorized and life-threatening hazardous activities on the Madhapar lands.*
