ORDER

New IA-2155/2026:-

This matter is passed over twice on the request made on behalf of the Applicant. Despite being passed over, arguing Counsel has not appeared. Therefore, the matter is adjourned to 26.05.2026.

Thereafter, at about 12.25 pm, Mr. Abhishek Anand the arguing Counsel mentioned the matter at the end of the board and submitted that there is an urgency in the matter inasmuch as the RP is going to conduct an auction under Regulation 29 of the IBBI (CIRP) Regulations and the auction is going to be conducted tomorrow i.e. 16.05.2026 whereby plant and machinery belonging to the applicant is sought to be put to auction.

Mr. Abhishek Anand submitted that the RP as well as Counsel appearing Mr. Shivam Gautam Ld. Counsel for the RP have been duly informed about the mentioning. Mr. Abhishek Anand also produced a copy of email (15.05.2026 at 11.22 am) informing the RP at email id (ipscojha@gmail.com) about the mentioning. He also stated that whatsapp messages had been sent to Mr. Shivam Gautam, Ld. Counsel for the RP. However, no one has appeared on behalf of the RP.

Ld. Counsel has made out a prima facie case that the property belongs to the Applicant and the Applicant will suffer loss and injury in case the properties are subjected to auction.

Having regard to the fact that the properties in question will be put to auction tomorrow i.e. 16.05.2026, we deem it appropriate to direct that the auction may be conducted, but the final outcome will be subject to the order passed by this Adjudicating Authority.

Mr. Abhishek Anand undertakes to intimate the RP as well as Ld. Counsel for the RP about the order passed today. **Dasti order is allowed.**

Instead of 22.05.2026, we are listing this matter for Monday i.e. **18.05.2026.**
