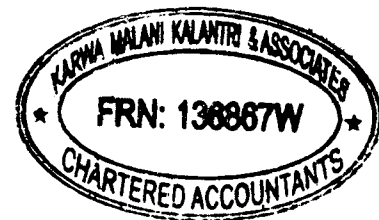

To the Board of Directors of Thakkers Group Limited

2. 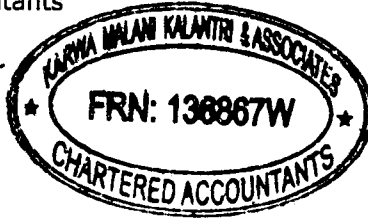
