PROCEEDINGS OF 28th ANNUAL GENERAL MEETING HELD ON SEPTEMBER 29, 2026

The 28th Annual General Meeting (“AGM”) of the Company was held on Tuesday, September 29, 2026 at 11.00 a.m. through Video Conference (“VC”). The meeting was held in accordance with General Circular No. 20/2020 dated May 05, 2020, as amended from time to time and most recently amended by Circular No. 03/2025 dated September 22, 2025, issued by the Ministry of Corporate Affairs (“MCA”), read with SEBI Circular No. SEBI/HO/CFD/CFD-PoD-2/P/CIR/2024/133 dated October 03, 2024, issued by the Securities and Exchange Board of India (“SEBI”) (collectively, the “Circulars”) and as per other applicable provisions of the Companies Act, 2013 and the Rules made thereunder.

The Company Secretary welcomed the members on behalf of the Company. With permission of the members of the Company, Mr. Manish Kiri, Chairman and Managing Director occupied the Chair and carried out the further proceeding of the meeting. After ascertaining the requisite quorum, the meeting was called in order. Mr. Manish Kiri briefed the members about the financials of the Company for the year ended March 31, 2026, Industry scenario, Financial Performance of the Company, update of court case in Singapore, Status of our new venture, etc.
