1. To consider and adopt the Standalone and consolidated Financial Statements of the Company for the financial year ended March 31, 2026 the Statement of Profit & Loss and Cash Flow Statement, for the year ended on that date and reports of the Board of Directors (**“Board”**) and Auditors thereon.
2. To appoint a director in place of Mr. Harsh Prashant Vora (DIN: 07861487), who retires by rotation and being eligible, offers himself for re-appointment.

(all inclusive) with an authority to the Nomination & Remuneration Committee or Board of Directors to consider and give increment from time to time or on yearly basis within the grade as specified here above and on such other terms and conditions as may decided and approve during the tenure of his re-appointment, subject to requisite approval if required under Schedule V Part II Section II B of the Companies Act, 2013.

meets the criteria for independence under Section 149(6) of the Act and the Rules made thereunder and Regulation 16(1)(b) of the SEBI (LODR) Regulations and in respect of whom the Company has received a notice in writing from a member under Section 160(1) of the Companies Act, 2013, be and is hereby re-appointed as an Independent Director of the Company, for a second term of 5 (Five) consecutive years effective from 10th May, 2027 till 9th May, 2032, and that she shall not be liable to retire by rotation.

RESOLVED FURTHER THAT Mrs. Meghna Gala, upon re-appointment, shall be entitled to receive such sitting fees, commission and/or remuneration as may be permissible under the provisions of the Act and the SEBI LODR Regulations and as approved by the Board of Directors from time to time, subject to such limits as may be prescribed under applicable law.

1. Pursuant to General Circular No. 03/2025 dated September 22, 2025 read with General Circular Nos., 09/2024 dated September 19, 2024, 14/2020 dated April 08, 2020, 17/2020 dated April 13, 2020, 20/2020 dated May 05 2020, 02/2022 dated May 05, 2022, 03/2022 dated May 05, 2022, 10/2022 dated December 28, 2022, 11/2022 dated December 28, 2022 and 09/2023 dated September 25, 2023 issued by the Ministry of Corporate Affairs (collectively referred as 'MCA Circulars'), permitted the holding of the Annual General Meeting ('AGM' or 'Meeting') through Video Conferencing facility / Other Audio Visual Means ('VC/OAVM'), till further orders, in accordance with the requirements laid down in Para 3 and Para 4 of the General Circular No. 20/2020 dated 5th May 2020.

Accordingly, in compliance with the provisions of the Companies Act, 2013 ("Act"), SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations") read with the MCA Circulars as well as applicable SEBI Circulars, the 9th AGM of the Company is being conducted through VC / OAVM, without the physical presence of Members, at a common venue. The deemed venue for the 9th AGM. Additionally, a letter providing the web link to access the Notice of the 9th AGM and Annual Report is being sent to those Members whose e-mail Ids are not registered with the Company / RTA or the Depositories.

2. An Explanatory Statement pursuant to Section 102 of the Act, relating to Ordinary & Special Business to be transacted at the AGM, is annexed hereto and forms part of this Notice.

The Additional information required under the Act, Regulations 36(3) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations") and Secretarial Standard on General Meetings (SS-2) issued by the Institute of Company Secretaries of India ("ICSI"), in respect of Director seeking appointment / re-appointment at this AGM is annexed as Annexure II to this Notice. Requisite declaration has been received from the Directors for seeking Re-appointment.

3. Pursuant to the provisions of the Act, a member entitled to attend and vote at the AGM is entitled to appoint a proxy to attend and vote on his/her behalf and the proxy need not be a Member of the Company. Since this AGM is being held pursuant to the MCA Circulars through VC / OAVM, physical attendance of Members has been dispensed with. Accordingly, the facility for appointment of proxies by the Members will not be available for the AGM and hence, the proxy form, attendance slip and route map of AGM are not annexed to this Notice. Members attending the AGM through VC/OAVM shall be counted for the purpose of determining the quorum. [Section 103 of the Companies Act, 2013 ("Act")].
4. Institutional / Corporate Shareholders (i.e. other than individuals, HUF, NRI, etc.) are required to send a scanned copy (PDF/JPG Format) of its Board or governing body Resolution/ Authorization etc., authorizing its representative to attend the AGM through VC / OAVM on its behalf and to vote through remote e-voting. The said Resolution/Authorization shall be sent to the Company at info@parshvaenterprises.co.in with a copy marked to evoting@nsdl.co.in
5. As per Regulation 40 of SEBI Listing Regulations, as amended, as mandated by SEBI, effective April 01, 2019 except in case of transmission or transposition of securities, requests for effecting transfer of securities shall not be processed unless the securities are held in dematerialised mode with a depository. Accordingly, the Members of the Company were requested to open a demat account and submit physical securities to their DP's. Members can contact the Company or Company's Registrar and Transfer Agents, Bigshare Services Private Limited (BSPL) for assistance in this regard.
6. To support the 'Green Initiative', Members who have not yet registered their email addresses are requested to register the same with their DPs in case the shares are held by them in electronic form and with Parshva Enterprises Limited at info@parshvaenterprises.co.in in case the shares are held by them in physical form.
7. Members are requested to intimate changes, if any, pertaining to their name, postal address, email address, telephone/ mobile numbers, Permanent Account Number (PAN), mandates, nominations, power of attorney, bank details such as, name of the bank and branch details, bank account number, MICR code, IFSC code, etc., to their DPs in case the shares are held by them in electronic form.
8. As per the provisions of Section 72 of the Act, the facility for making nomination is available for the Members in respect of the shares held by them. 10. 11. Those Members who have registered themselves as a speaker will only be allowed to express their views / ask questions during the AGM.
12. The Company reserves the right to restrict the number of questions and number of speakers, as appropriate to ensure smooth conduct of the AGM.
13. In compliance with the aforesaid MCA Circulars and SEBI Circular dated May 12, 2020, Notice of the AGM along with the Annual Report 2025-26 is being sent only through electronic mode to those Members whose email addresses are registered with the Company/Depositories. 14. The Board of Directors has appointed Mr. Jenish Sanjaybhai Doshi (Membership No. ACS: 50447 /CP: 18523) as the Scrutinizer to scrutinize the voting during the AGM and remote e-voting process in a fair and transparent manner.
15. Instructions for e-voting and joining the AGM are as follows:

A. VOTING THROUGH ELECTRONIC MEANS

1. In compliance with the provisions of Section 108 of the Act, read with Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended from time to time, Regulation 44 of the SEBI Listing Regulations and in terms of SEBI vide circular no. SEBI/HO/CFD/CMD/ CIR/P/2020/242 dated December 9, 2020 in relation to e-Voting Facility Provided by Listed Entities, the Members are provided with the facility to cast their vote electronically, through the e-Voting services provided by NSDL, on all the resolutions set forth in this Notice. The instructions for e-Voting are given herein below.
2. In accordance with the aforesaid MCA Circulars and pursuant to the Circular Nos. SEBI/HO/CFD/CMD1/CIR/P/2020/79 dated May 12, 2020, SEBI/HO/CFD/CMD2/CIR/P/2021/11 dated January 15, 2021, SEBI/HO/CFD/CMD2/CIR/P/2022/62 dated May 13, 2022, SEBI/HO/CFD/ PoD-2/P/CIR/2023/4 dated January 5, 2023 and SEBI/HO/CFD/CFD-PoD-2/P/ CIR/2023/167 dated October 07, 2023 issued by Securities Exchange Board of India (collectively referred to as "SEBI Circulars"), the Company is sending this AGM Notice along with the Annual Report 2025-26 in electronic form only to those Members whose e-mail addresses are registered with the Company/ Depositories/RTA. The physical attendance of the Members to the EGM/AGM venue is not required and annual general meeting (AGM) be held through video conferencing (VC) or other audio visual means (OAVM). Hence, Members can attend and participate in the ensuing AGM through VC/OAVM.
3. The remote e-Voting period commences on Tuesday, September 15, 2026 (9:00 a.m. IST) and ends on Thursday, September 17, 2026 (5:00 p.m. IST). During this period, Members holding shares either in physical form or in dematerialized form, as on Friday, September 11, 2026 i.e. cut-off date, may cast their vote electronically. The e-Voting module shall be disabled by NSDL for voting thereafter. Members have the option to cast their vote on any of the resolutions using the remote e-Voting facility either during the period commences September 15, 2026 to September 17, 2026 or e-Voting during the AGM.

Members who have voted on some of the resolutions during the said voting period are also eligible to vote on the remaining resolutions during the AGM.

4. The Members who have cast their vote by remote e-Voting prior to the AGM may attend / participate in the AGM through VC / OAVM but shall not be entitled to cast their vote on such resolution again.
5. The voting rights of Members shall be in proportion to their shares in the paid-up equity share capital of the Company as on the cut-off date.
6. Any person holding shares in physical form and non-individual shareholders, who acquires shares of the Company and becomes a Member of the Company after sending of the Notice and holding shares as of the cut-off date, may obtain the login ID and password by sending a request at evoting@nsdl.co.in. However, if he / she is already registered with NSDL for remote e-Voting then he /she can use his / her existing User ID and password for casting the vote. In case of Individual Shareholders holding securities in demat mode and who acquires shares of the Company and becomes a Member of the Company after sending of the Notice and holding shares as of the cut-off date may follow steps mentioned below under “Login method for remote e-Voting and joining virtual meeting for Individual shareholders holding securities in demat mode.”

CHANGE IN NATURE OF BUSINESS

During the year there is no material change in the nature of business of the Company.

SCHEME OF DEMERGER – DEMERGER

The scheme of arrangement between Parshva Enterprises Limited (Demerged Company) and Simandhar Impex Limited (Resulting Company) under section 230-234 and other applicable provisions of the Companies Act, 2013 was approved by the Board of Directors of the Company on May 14, 2024. Pursuant to the scheme transfer, Jewellery business of holding Company namely Parshva Enterprises Limited is transferred to Simandhar Impex Limited by way of a demerger in order to Segregation of business of the Jewellery division of the Parshva Enterprises Limited (Demerged Company).

The above Scheme of arrangement was approved by Hon'ble National Company Law Tribunal, Mumbai bench vide its order dated 13th October, 2025. Pursuant to the demerger, shares in the ratio of 3:10 were issued to shareholders of Parshva Enterprises Limited and shares held by Parshva Enterprises Limited in Simandhar Impex Limited were cancelled thereby replicating mirror shareholding pattern of Parshva Enterprises Limited in Simandhar Impex Limited. The Simandhar Impex Ltd had received In-principle approval for listing of 30,56,925 equity shares of Rs.10/- each from BSE Limited ("BSE") on December 03, 2025. Further the equity shares of the Simandhar Impex Ltd were listed and admitted for trading on BSE with effect from December 22, 2025.

MATERIAL CHANGES AFFECTING THE FINANCIAL POSITION OF THE COMPANY

There have been no material changes and commitments, affecting the financial position of the Company, which have occurred between the end of the financial year of the Company and the date of this report.

SHARE CAPITAL OF THE COMPANY

During the year under review, the following changes have taken place in the Share Capital:

Pursuant to the resolution passed by the Shareholders through Postal Ballot on February 21, 2026, the Authorised share capital of increased from ₹ 10,50,00,000/- (Rupees Ten Crores Fifty Lakhs only) to ₹ 15,00,00,000/- (Rupees Fifteen Crores only) with subsequent alteration in the clause V of the Memorandum of Association of the company.

The Company's paid-up equity share capital as on March 31, 2026 continues to stand at ₹1018.97 lakhs divided into 10189749 equity shares of face value of ₹10 each. There was no changes in the Share Capital during the Financial Year under review.

Further, there was no public issue, rights issue, preferential issue, bonus issue etc., during the year. The Company has not issued shares with differential voting rights or sweat equity shares, nor has it granted any stock options or provision of money for shares of the Company to the employees or Directors of the Company during the Financial Year.

The company is in the business of sale and trading of Gold & Diamond jewellery and cut & polished Diamonds. The company supplies the polished diamonds primarily to wholesalers, jewellery manufacturers, traders and retailers based in India.

INDUSTRY STRUCTURE AND DEVELOPMENTS

The Indian diamond industry continues to occupy a significant position in the global gems and jewellery sector and forms an integral part of the country's export economy. The industry also continues to adapt to changing market trends, including the growing acceptance of laboratory-grown diamonds alongside natural diamonds. Despite short-term challenges arising from global economic uncertainties and geopolitical developments, the long-term outlook for the Indian diamond industry remains positive, driven by its strong manufacturing capabilities, established global presence, and sustained demand for diamond jewellery.

India continues to be a global hub for the gems and jewellery industry, supported by cost competitiveness, a highly skilled workforce, and a well-established value chain. The country remains the world's leading centre for diamond cutting and polishing and is among the largest consumers of gold globally. The industry encompasses the sourcing, processing, manufacturing, and retailing of precious metals and gemstones, including gold, silver, platinum, diamonds, and other precious stones. Evolving consumer preferences and changing lifestyles continue to drive demand for innovative jewellery products, while the sector remains a significant contributor to the country's exports, employment generation, and overall economic growth.

INDUSTRY TREND – DIAMOND JEWELLERY

- **Evolving Consumer Preferences:** Rising demand for diamond and coloured gemstone jewellery, particularly among younger consumers.
- **Expanding Demand:** Diamond jewellery is increasingly purchased for occasions beyond weddings, including gifting and self-purchase.
- **Organised Market Growth:** Growth in organized retail, digital channels and innovative jewellery designs continues to support industry expansion.

OUTLOOK

The Gems and Jewellery sector continues to be a key focus area for export promotion by the Government, considering its significant growth potential and value addition. The long-term outlook for the industry remains positive, supported by the expansion of organised retail and established jewellery brands, which are expected to further strengthen the organised segment and drive sustained industry growth.

India's Gems and Jewellery sector significantly contributes to the national economy, accounting for about 7% of GDP and 7-9% of total merchandise exports. India's gold demand is projected to remain in the range of 600–700 tonnes in 2026, with rising investment demand offsetting weaker jewellery consumption due to elevated gold prices.

As of January 2026, the market size stood at US\$ 85 billion and is projected to expand to US\$ 130 billion by 2030. The Government of India aims to reach US\$ 100 billion in jewellery exports over the next few years (until 2027), up from US\$ 35 billion in 2020. The country is also the second-largest consumer of gold jewellery globally.

India's gem and jewellery exports recorded strong growth in June 2026, reflecting improving global demand and enhanced export competitiveness. According to the Gem and Jewellery Export Promotion Council (GJEPC), gross exports increased 26.51% year-on-year to Rs. US\$ 2.21 billion during the month.

OPPORTUNITIES AND THREATS

(a) Opportunities/Strength

- Induction of widely experienced and specialized personnel on the Board.
- Rising disposable incomes, urbanisation, and strong demand during weddings, festivals, and other special occasions continue to support long-term growth in the gold jewellery market.
- Some of the world retail majors have decided sometime back to source part of their requirements from India. This shall further the growth of the Diamond industry in India.

(b) Threats

- Jewellery being a vital fashion and lifestyle statement, demands the players to be more agile, and responsive to the constantly evolving trends and consumer preferences.
- Intense competition from organised and unorganised market participants, along with rapidly changing consumer preferences and fashion trends, requires continuous product innovation and efficient inventory management to sustain market competitiveness.

RISK AND CONCERNS

The gold jewellery industry is exposed to risks arising from fluctuations in gold prices, changes in consumer preferences, economic conditions, regulatory developments, and competition from organised and unorganised market participants. Variations in import duties, taxation policies, BIS hallmarking requirements, and foreign exchange rates may also impact the Company's operations and profitability.

The Company has implemented an effective risk management framework supported by robust internal controls, well-defined policies, and regular monitoring of market and regulatory developments. These measures enable the Company to identify, assess, and mitigate potential risks in a timely manner, thereby supporting operational efficiency, financial stability, and sustainable business growth.

FACTORS AFFECTING OUR OPERATIONS

• Gems and Jewellery Industry

The gold jewellery industry is influenced by factors such as fluctuations in gold prices, consumer demand, economic conditions, regulatory changes, and seasonal buying patterns. Demand is primarily driven by weddings, festivals, and investment preferences, while increasing consumer inclination towards organised retailers, BIS hallmarked jewellery, and contemporary designs continues to shape the industry. The Company's operations may also be affected by changes in import duties, taxation policies, foreign exchange rates, and overall market sentiment.

• High Working Capital Intensive Industry vis-a-vis Low Priority Sector for Bankers

In the diamond industry, there is a norm of longer credit period and high inventory levels, considering which it becomes high working capital intensive industry, whereas it is a low priority sector from the perspective of bankers.

Financial Performance with respect to Operational Performance

On a consolidated basis, The Total Turnover of the Company is ₹ 2475.76 (In Lacs) in current year and ₹ 2477.50 (In Lacs) in previous year indicating declined by 0.07%. The Company has earned a Profit of ₹ 25.96 (In Lacs) as compared to ₹ 18.69 (In Lacs) in the previous year.

Pursuant to the Scheme of Demerger sanctioned by the Hon'ble National Company Law Tribunal (NCLT), Mumbai Bench, vide its Order dated 13th October, 2025, the Jewellery Division of the Company stands transferred to Simandhar Impex Limited. The demerger has enabled the Company to achieve greater business focus and operational efficiency. The management remains optimistic about the Company's future prospects and expects sustained growth and improved profitability in the coming years.

The Hon'ble NCLT, Mumbai Bench sanctioned the Scheme vide its order dated 13th October 2025. The Company received the certified true copy of the order on 16th October 2025, and upon filing of the certified copies of the order by the Company and the Resulting Company with the respective jurisdictional Registrar of Companies on 17th October 2025, the Scheme became effective from 17th October 2025.

- 1.8 Pursuant to the Scheme becoming effective, the Jewellery Business of the Company has been demerged, transferred and vested in the Resulting Company on a going concern basis. As per the Scheme, the shareholders of the Company were entitled to receive 3 (Three) fully paid-up equity shares of ₹10 each of the Resulting Company for every 10 (Ten) fully paid-up equity shares of ₹10 each held in the Company, as on the record date i.e. 5th November 2025. Accordingly, on 8th November 2025, the Resulting Company allotted 30,56,925 fully paid-up equity shares of face value ₹10 each to the shareholders of the Company. The equity shares of the Resulting Company were listed on BSE Limited on 22th December 2025. The demerger has been accounted for in accordance with the accounting treatment specified in the sanctioned Scheme, treating the transaction as a common control transaction. Accordingly, the assets and liabilities of the Jewellery Business have been transferred to the Resulting Company at their respective book values. The losses included in the above Statement of Profit and Loss due to Discontinue operation of jewellery business pursuant to scheme of arrangement (Demerger) into a separate Company viz. Simandhar Impex Limited (BSE Scrip code : 544662).

2.1 Corporate Information

Parshva Enterprises Limited ("the Company") is a company limited by shares incorporated under the Companies Act, 2013.

The Company's Registered Office is situated at Thane. The Company's shares are listed on the Bombay Stock Exchange (BSE) with the Scrip Code 542694

2.2 Basis of preparation of Financial Statements

The Financial statements are prepared under the historical cost convention and on accrual basis in accordance with applicable Indian Accounting Standards prescribed under section 133 read with rule 7 of the Companies (Accounts) rules, 2014.

Accounting policies not specifically referred to, otherwise are consistent and in accordance with the generally accepted accounting principles.

2.3 Revenue Recognition

Sales are recorded exclusive of Taxes

2.4 Property, Plant and Equipments

Property, Plant and Equipments are stated at cost of acquisition or construction less accumulated depreciation, including financial cost till such assets are ready for its intended use.

2.5 Depreciation

Depreciation is charged on written down value method as per Companies Act 2013.

2.6 Impairment of Assets

Impairment of assets if any is ordinarily assessed by comparing recoverable value of individual assets with its carrying cost.

2.7 Inventories

Inventories are valued at cost or net realizable value whichever is lower. Cost in respect of inventories is ascertained on Weighted Average Method.

2.8 Investments

Long Term Investments if any are stated at cost. Provision for diminution if any in value of assets is only made when the same is of permanent nature.

2.9 Retirement Benefits

- (i) As certified by the management, the company has no liability under the Provident Fund & Super Annuation Fund as the said acts do not apply to the company.
- (ii) It is explained to us that the company does not provide for any leave encashment and any liability arising thereon shall be paid and dealt with in the books of accounts at the actual time of payment.

2.10 Borrowing Cost

Borrowing cost on working capital is charged against the profit & loss account in which it is incurred.

Borrowing costs that are attributable to the acquisition or construction or manufacture of qualifying assets are capitalized as a part of the cost of such assets till the date of acquisition or completion of such assets. In respect of suspended project for extended period, borrowing costs are not capitalized for such period.

2.11 Taxes on Income

Taxes on income of the current period are determined on the basis of taxable income and credits computed in accordance with the provisions of the Income tax Act, 1961.

Deferred tax is recognized on timing differences between the accounting income and the taxable income for the year, and quantified using the tax rates and laws enacted or substantively enacted as on the Balance Sheet date.

2.12 Provision, Contingent liabilities and contingent assets

Provisions involving substantial degree of estimation in measurement are recognized when there is a present obligation as a result of past event and it is probable that there will be an outflow of resources. Contingent liabilities are not recognized but the same is disclosed in the financial statements. Contingent assets are neither recognized nor disclosed in the financial statements.

- 1.7 There is no adjustment required to be made to the profits or loss for complying with ICDS notified u/s 145(2).
- 1.8 The Hon'ble NCLT, Mumbai Bench sanctioned the Scheme vide its order dated 13th October 2025. The Company received the certified true copy of the order on 16th October 2025, and upon filing of the certified copies of the order by the Company and the Resulting Company with the respective jurisdictional Registrar of Companies on 17th October 2025, the Scheme became effective from 17th October 2025.

Pursuant to the Scheme becoming effective, the Jewellery Business of the Company has been demerged, transferred and vested in the Resulting Company on a going concern basis. As per the Scheme, the shareholders of the Company were entitled to receive 3 (Three) fully paid-up equity shares of ₹10 each of the Resulting Company for every 10 (Ten) fully paid-up equity shares of ₹10 each held in the Company, as on the record date i.e. 5th November 2025. Accordingly, on 8th November 2025, the Resulting Company allotted 30,56,925 fully paid-up equity shares of face value ₹10 each to the shareholders of the Company. The equity shares of the Resulting Company were listed on BSE Limited on 22th December 2025. The demerger has been accounted for in accordance with the accounting treatment specified in the sanctioned Scheme, treating the transaction as a common control transaction. Accordingly, the assets and liabilities of the Jewellery Business have been transferred to the Resulting Company at their respective book values. The losses included in the above Statement of Profit and Loss due to Discontinue operation of jewellery business pursuant to scheme of arrangement (Demerger) into a separate Company viz. Simandhar Impex Limited (BSE Scrip code : 544662).

2 Significant Accounting Policies Note : 23

2.1 Corporate Information

Parshva Enterprises Limited ("the Company") is a company limited by shares incorporated under the Companies Act, 2013.

The Company's Registered Office is situated at Thane. The Company's shares are listed on the Bombay Stock Exchange (BSE) with the Scrip Code 542694

2.2 (i) Basis of preparation of Financial Statements

The Consolidated Financial Statements of the Group have been prepared to comply with the Indian Accounting Standards ('Ind AS'), including the rules notified under the relevant provisions of the Companies Act, 2013, (as amended from time to time) and Presentation requirements of Division II of Schedule III to the Companies Act, 2013, (Ind AS Compliant Schedule III) as amended from time to time.

2.2 (ii) Principles of Consolidation:

The consolidated financial statements have been prepared on the following basis:

- i. The financial statements of the subsidiary company used in the consolidation are drawn up to the same reporting date as of the Holding Company, i.e. for the year ended 31 March, 2026.
- ii. The financial statements of the Holding Company and its subsidiary company have been combined on a line-by-line basis by adding together like items of assets, liabilities, income and expenses, after eliminating intra-group balances, intra-group transactions and resulting unrealized profits or losses, unless cost cannot be recovered.
- iii. The excess of cost to the Group of its investments in the subsidiary company over its share of equity of the subsidiary company at the dates on which the investments in the subsidiary company entities were made, is recognized as 'Goodwill' being an asset in the consolidated financial statements and is tested for impairment on annual basis. On the other hand, where the share of equity in the subsidiary company entities as on the date of investment is in excess of cost of investments of the Group, it is recognized as 'Capital Reserve' and shown under the head 'Reserves & Surplus', in the consolidated financial statements. The 'Goodwill' / 'Capital Reserve' is determined separately for each subsidiary company entity and such amounts are not set off between different entities.
- iv. Minority Interest in the net assets of the consolidated subsidiary consist of the amount of equity attributable to the minority shareholders at the date on which investments in the subsidiary company were made and further movements in their share in the equity, subsequent to the dates of investments. Net profit / loss for the year of the subsidiary attributable to minority interest is identified and adjusted against the profit after tax of the Group in order to arrive at the income attributable to shareholders of the Company.
- v. Change in minority interest by acquiring additional shares in the Company is recognized in "Capital Reserve" by any difference between the amount by which the minority interest is adjusted. Remaining amount is distributed in new ratio between parent Company and minority interest.

2.3 Revenue Recognition

2.4 Property, Plant and Equipments

Property, Plant and Equipments are stated at cost of acquisition or construction less accumulated depreciation, including financial cost till such assets are ready for its intended use.

2.5 Depreciation

Depreciation is charged on written down value method as per Companies Act 2013.

2.6 Impairment of Assets

Impairment of assets if any is ordinarily assessed by comparing recoverable value of individual assets with its carrying cost.

2.7 Inventories

Inventories are valued at cost or net realizable value whichever is lower. Cost in respect of inventories is ascertained on Weighted Average Method.

2.8 Investments

Long Term Investments if any are stated at cost. Provision for diminution if any in value of assets is only made when the same is of permanent nature.

2.9 Retirement Benefits

- (i) As certified by the management, the company has no liability under the Provident Fund & Super Annuation Fund as the said acts do not apply to the company.
- (ii) It is explained to us that the company does not provide for any leave encashment and any liability arising thereon shall be paid and dealt with in the books of accounts at the actual time of payment.

2.10 Borrowing Cost

Borrowing cost on working capital is charged against the profit & loss account in which it is incurred.

Borrowing costs that are attributable to the acquisition or construction or manufacture of qualifying assets are capitalized as a part of the cost of such assets till the date of acquisition or completion of such assets. In respect of suspended project for extended period, borrowing costs are not capitalized for such period.

2.11 Taxes on Income

Taxes on income of the current period are determined on the basis of taxable income and credits computed in accordance with the provisions of the Income tax Act, 1961.

Deferred tax is recognized on timing differences between the accounting income and the taxable income for the year, and quantified using the tax rates and laws enacted or substantively enacted as on the Balance Sheet date.

2.12 Provision, Contingent liabilities and contingent assets

Provisions involving substantial degree of estimation in measurement are recognized when there is a present obligation as a result of past event and it is probable that there will be an outflow of resources. Contingent liabilities are not recognized but the same is disclosed in the financial statements. Contingent assets are neither recognized nor disclosed in the financial statements.
