O R D E R

1. The present Miscellaneous Application is filed on behalf of petitioners for modification of order dated 24.11.2025 passed by this Court in Civil Appeal No.15373 of 2025.

2. *Vide* order dated 24.11.2025, this Court has directed the appellant (respondent herein) that he shall be examined by a Medical Board to be constituted by the All India Institute of Medical Sciences (AIIMS), Lucknow, within three weeks from the receipt of the order. The medical examination shall be got done within a period of three (03) weeks from the date of receipt of copy of this order.
