**O R D E R**

1. The instant contempt petition has been filed by the petitioner against the respondent/alleged contemnor for wilful and deliberate breach of the undertaking recorded by this Court vide order dated 19.01.2026 passed in Civil Appeal No. 350 of 2026. During the pendency of the present contempt petition, the petitioner has filed an application seeking a direction to stay further proceedings in Suit No. 4631/2007 pending before the learned City Civil Court, Mumbai until the respondent/alleged contemnor complies with the order dated 19.01.2026.

2. During the course of proceedings, the respondent undertakes to deposit the entire amount in terms of communication dated 21.02.2026 issued by Mrs. Nandini Y Deshpande, 1<sup>st</sup> Assistant to Court Receiver, High Court, Bombay within a period of five months.

3. His statement is taken on record. Accordingly, we direct that the requisite amount be paid in equal installments spread over a period of five months from today. The first installment shall be paid on or before 04.06.2026. Undertaking in this regard, in usual form be filed in the Registry of this Court, within a period of one week from today.
