With reference to your mail dated 06<sup>th</sup> July, 2026 regarding captioned subject, we request you to refer our Letter dated 10<sup>th</sup> June, 2026 in which we disclosed to your Stock Exchange through BSE Listing Centre under Corporate Announcement regarding resignation of Mr. Jasmin R. Raval, Sr. Manager – Design, a Senior Management Personnel w.e.f 10<sup>th</sup> June, 2026 vide his resignation letter dated 10<sup>th</sup> March, 2026 pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations").

However, in the above referred resignation letter of Mr. Jasmin R. Raval, he did not mention the reason of his resignation from the post of Sr. Manager – Design w.e.f. 10<sup>th</sup> June, 2026. (A copy of the said resignation letter dated 10<sup>th</sup> March, 2026 is enclosed herewith for your reference.).

Since disclosure of the reason for resignation is a mandatory requirement under Regulation 30 read with Schedule III of the SEBI LODR Regulations, the Company requested Mr. Jasmin R. Raval to furnish a clarification specifying the reason for his resignation.

Pursuant to the said request, Mr. Jasmin R. Raval submitted a letter dated 04<sup>th</sup> July, 2026, wherein he clarified and confirmed that his resignation from the aforesaid position with effect from 10<sup>th</sup> June, 2026 was solely on account of personal reasons. He further confirmed that his resignation was voluntary and was not attributable to any other reason.

The aforesaid clarification letter dated 04<sup>th</sup> July, 2026 was received by the Company only on 04<sup>th</sup> July, 2026. Accordingly, upon receipt of the said clarification, the Company is submitting the requisite disclosure and the details as required under Regulation 30 read with Schedule III of the SEBI LODR Regulations.
