2. We heard the learned Senior counsel appearing for the petitioner.
3. The High Court declined to entertain the Writ Petition preferred by the petitioner before us seeking to challenge the Order passed by the Additional District Magistrate (Finance and Revenue) on the ground that the petitioner has an alternative remedy of preferring an Appeal under Section 56(1-A) of the Indian Stamp Act, 1899.
4. We are also of the view that the petitioner should avail the remedy of Statutory Appeal.
5. We grant four weeks' time to the petitioner to prefer the Statutory Appeal.
6. With the aforesaid, this petition stands disposed of.
7. Pending applications, if any, also stand disposed of.
