O R D E R

1. On 08.05.2023 this Court had passed the following order:

"Delay condoned.

Issue notice to the respondents.

In the meantime, the petitioner/Insurance Company shall deposit the amount before the MACT concerned. The disbursement of the amount to the claimants can also be made. However, in so far as the liability is concerned, the payment of the amount shall not prejudice the petitioner."

2. We direct that the said amount, if not already paid/disbursed, be so done in favour of the claimant(s) within a period of two weeks from today. The insurer/petitioner shall file an affidavit of compliance to such an effect, before this Court.

3. We also direct the parties to place on record the testimonies of the witnesses, and more specifically that of the owner of the vehicle.
