Subject: Update on Disclosure under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

We refer to our intimation dated August 8, 2024, wherein the Company had informed the stock exchanges regarding receipt of an Order from the Office of the Special Commissioner, Large Taxpayers' Unit, 14, Beliaghata Road, Kolkata-15, raising a GST demand of ₹ 10,35,666/-, interest of ₹ 8,87,282/- and penalty of ₹ 1,03,566/- under Section 73 of the Central Goods and Services Tax Act, 2017 ("the Act") for the period April 2019 to March 2020. Subsequently, the Company filed an appeal against the said Order.

In this regard, please note that the Company has received an Order from Additional Commissioner, State Tax (Appeal), Large Taxpayers Unit on June 24, 2026 at 4:13 p.m. confirming the GST demand of ₹ 10,35,666/-, interest of ₹ 8,87,282/- and penalty of ₹ 1,03,566/-. The Company would pursue an appeal / evaluate any other legal options against the said Order including filing of writ petition. The requisite details of the said Order are enclosed herewith as an **Annexure 1**.

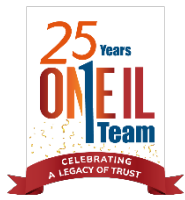
