Condonation of Delay in filing the Appeal.

2.      Order impugned was passed on 03/11/2025 and the Appeal has been  
e-filed on 19/12/2025. We, by our order dated 15/04/2026 has called for a  
Report.

The Report has been received from NCLT, New Delhi, where following is  
stated :-

*“Subject: - In the matter of- Company Appeal (AT) INS. NO. 49 of  
2026 & IA No. 176 of 2026 [Svaryu Energy Limited Versus  
Gautam Solar Pvt. Ltd- Company Appeal filed U/s 61 of the  
Insolvency and Bankruptcy Code, 2016.*

2. As directed by Hon'ble Principal Bench, NCLAT, New Delhi vide order dated 17.03.2026 in Company Appeal (AT) (Ins) No. 49 of 2026 & IA No. 176 of 2026 an enquiry was made and report was sought from the concerned Court Officer. In her reply, concerned court officer has stated the following: -

*"The Applicant applied for a free certified copy on 06.11.2025 and the copy was ready and available on 10.11.2025. However, the applicant collected the copy on 04.12.2025."*

3. A copy of the reply dated 30.03.2026 received from the concerned court officer is enclosed.

4. This issues with the approval of Ld Registrar, NCLT.

3. Applicant applied for a free certified copy on 06/11/2025 and the copy was ready and available on 10/11/2025. However, the Appellant collected the copy on 04/12/2025. The certified copy was applied by the Appellant on 06/11/2025 and it was made ready on 10/11/2025, hence the Appellant shall be entitled for exclusion of 5 days during which the certified copy was under preparation.

4. Delay thus is only 11 days in filing the Appeal. We find that in the Application sufficient cause has been shown for condonation of 11 days delay.

5. Application for condonation of 11 days delay in filing the Appeal is **allowed.**
