Sub.: Disclosure under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015

This is in furtherance to the disclosure made on 14th May, 2026 under Regulations 30(3), 30(4) read with Para B, Part A of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 by Jagran Prakashan Limited ("JPL" / "Company").

The Ld. NCLT, Allahabad had passed an order dated 23rd April, 2026 (which was uploaded on 29th April, 2026) whereby C.A. Nos. 4, 5 and 6 of 2026 had been dismissed, and the stay on the convening of the Extra-Ordinary General Meeting of JPL had been vacated. In furtherance thereto, please note that Jagran Media Network Investment Private Limited ("JMNIPL") has filed an appeal (numbered as C.A. (AT) No. 187 of 2026) before the Hon'ble National Company Law Appellate Tribunal, Allahabad ("Hon'ble NCLAT"). By way of the said appeal, JMNIPL is inter-alia seeking enforcement of the purported resolution dated 14th July, 2023.

Similarly, JPL has also filed an appeal before the Hon'ble NCLAT (numbered as C.A. (AT) No. 189 of 2026) impugning the order dated 23rd April, 2026, seeking reliefs against the en masse removal of the concerned directors.

Both the aforesaid appeals were listed today before the Hon'ble NCLAT, Delhi. When the matters were taken up, counsel appearing on behalf of the appellant/JMNIPL in C.A. (AT) No. 187 of 2026, i.e., JMNIPL, sought deferment on the ground that certain additional documents were required to be filed. Accordingly, both the appeals have now been listed on 22nd May, 2026.

Please note that we shall next provide a disclosure/update when there is a material development in the proceedings.
