4. On such deposit being made, a sum of Rs.5,00,000/- shall be released to the respondent(s)-claimant(s) and the same shall be received by the respondents' father after due verification.

5. The balance amount of Rs.25,00,000/- shall be deposited in any interest bearing fixed deposit account in any nationalised bank or post office account for an initial period of ten years.

6. The respondent(s) are entitled to receive the periodical interest on the said deposit.

7. The aforesaid settlement shall be read as a part and parcel of this order.

8. The Registry may draw up an award accordingly.
