1. 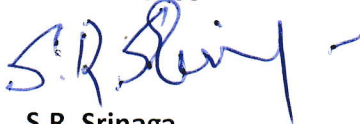

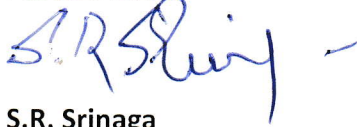
