12.05.2026: All these three appeals raise same questions. The question raised by the Adjudicating Authority was to entertain an application where application was filed for initiating/ filing complaint by the Court under offences under BNS. One of the questions framed was as to whether such application was maintainable and such application can be entertained at the instance of a stranger. Appellant's case further is that application was not maintainable. Issues raised have wide ramification with respect to CIRP proceeding. We, thus, are of the view that issues need to be decided by this Tribunal after giving opportunity to both parties. Issues being purely legal, parties are given liberty to submit their written submissions along with judgments relied till next date.

In the meantime, the Adjudicating Authority may not proceed with the application in which impugned order has been passed.
