Sub: Intimation regarding Receipt of Insurance Claim Settlement Amount pursuant to Fire Incident at Mandideep Manufacturing Facility

Ref: Regulation 30 read with Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Regulations")

Dear Sir/Ma'am

In continuation of our earlier disclosure dated 17th October, 2025 submitted pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, regarding the fire incident that occurred at one of the manufacturing facilities of the Company situated at 35-A/36, Sector-B, Industrial Area, Mandideep District, Raisen - 462046, Madhya Pradesh, India ("Mandideep Factory"), we wish to inform you that the Company has now received the insurance claim settlement amount in respect of the said incident from Cholamandalam MS General Insurance Company Limited.

As previously intimated, the fire incident has resulted in damage to certain Plant & Machinery, inventories and other assets at the Mandideep Factory. Immediately upon occurrence of the incident, the Company had undertaken all necessary measures to contain and control the situation and had informed the concerned insurance company. Subsequently, the insurer had appointed an independent surveyor for assessment and quantification of the loss incurred by the Company.

Based on the final assessment carried out by the surveyor appointed by the insurance company and after completion of the necessary verification and claim settlement formalities, the net insurance claim amount payable to the Company has been assessed at ₹1,84,55,527/- (Rupees One Crore Eighty-Four Lakh Fifty-Five Thousand Five Hundred and Twenty-Seven Only) against stock and fixed assets.

The Company has accepted the said assessment and has received the aforesaid amount from Cholamandalam MS General Insurance Company Limited towards full and final settlement of the insurance claim pertaining to the said fire incident.

The receipt of the aforesaid insurance claim amount substantially mitigates the financial impact arising out of the said incident. Further, the Company confirms that there is no material adverse impact on the overall operations, business continuity, or financial position of the Company on account of the said incident and the same has been adequately addressed.

The details as required under Regulation 30 read with Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and SEBI Master Circular No. SEBI/HO/CFD/PoD2/CIR/P/0155 dated 11th November, 2024, are enclosed herewith as "Annexure I".

1	Insurance amount claimed and realized by the listed entity for the loss/damage	The Company has received an insurance claim amount of ₹1,84,55,527/- (Rupees One Crore Eighty-Four Lakh Fifty-Five Thousand Five Hundred and Twenty-Seven only) from Cholamandalam MS General Insurance Company Limited towards full and final settlement of the insurance claim in respect of the fire incident that occurred at the Company's manufacturing facility situated at 35-A/36, Sector-B, Industrial Area, Mandideep, District Raisen - 462046, Madhya Pradesh.
2	The actual amount of damage caused due to the natural calamity or other force majeure events;	The actual damage caused due to the fire incident was assessed by the surveyor appointed by the insurance company at ₹3,26,60,008/- (Rupees Three Crore Twenty-Six Lakh Sixty Thousand and Eight Only). However, the Company had recognized and booked a loss of ₹1,36,54,993/- (Rupees One Crore Thirty-Six Lakh Fifty-Four Thousand Nine Hundred and Ninety-Three Only) in its books of account in relation to the said incident.
3	Details of steps taken to restore normalcy and the impact of the natural calamity/other force majeure events on production or service, financials of the entity	Immediately after the occurrence of the fire incident, the Company undertook necessary corrective and precautionary measures to contain the situation and minimize operational disruption. Restoration activities at the affected manufacturing facility were initiated promptly and operations at the unit were restored in a phased and timely manner. The receipt of the insurance claim amount has substantially mitigated the financial impact arising out of the incident. The Company does not foresee any material adverse impact on its business operations, production activities or financial position on account of the said incident.
