- 2) In accordance with the Notice of the Postal Ballot dated 29<sup>th</sup> May, 2026, the Company completed the dispatch of the Notice of Postal Ballot & E-Voting to the Shareholders along with the Explanatory Statement as required to all its equity shareholders whose name(s) appeared on the Register of Members/List of Beneficial Owners as on the cut-off date, i.e., 26<sup>th</sup> June, 2026 by prescribed modes and an 'Advertisement' was published pursuant to the rule 22 (3) of Companies (Management and Administration) Rules, 2014 on 30<sup>th</sup> June, 2026 and the e-voting has been commenced on Tuesday, 30<sup>th</sup> June, 2026 (09.00 a.m. IST) and ended on Wednesday, 29<sup>th</sup> July, 2026 (5.00 p.m. IST).
