UPON hearing the counsel the Court made the following

O R D E R

1. The impugned order dated 10.02.2026 restraining the Rajasthan Police Authorities from taking the coercive action against respondent No.1 and its officials or from compelling the University

officials to appear before them was passed by the High Court of Madhya Pradesh. The operation of the said order was stayed by this Court on the first date of hearing, as a result of which three persons have been arrested.

2. That being so, the order dated 10.02.2026 has become defunct and inoperative.

3. The Special Leave Petition is, accordingly, disposed of with liberty to the parties to avail their respective remedies before the High Court.
