1. Since the issues raised in all the captioned appeals are the same, those were taken up for hearing analogously and are being disposed of by this common order.
2. The appellants before us had questioned the legality and validity of the levy of tax on entry of goods into the local area for consumption, use or sale therein under the provisions of the U.P. Tax on Entry of Goods into Local Areas Act, 2007 (U.P. Act No. 30 of 2007) before the High Court. The challenge to the constitutional validity failed. In such circumstances, referred to above, they all have come in appeal before this Court.

O R D E R

1. These appeals by the Union of India, through General Manager, North Central Railway, Allahabad, U.P., are directed against the order dated 03.04.2013, passed by the High Court of Judicature at Allahabad, holding that the Railways is liable to pay entry tax on goods brought into the local area.

2. We need not now adjudicate these appeals in view of the pronouncement of judgment by this Court in Jindal Stainless Ltd. & Anr. vs. State of Haryana & Ors., (2017) 12 SCC 1 as also keeping in view the order passed by this Court in Senior Divisional Mechanical Engineer vs. State of Orissa & Others (C.A. No.4934/2008 and other connected appeals), decided on 07.08.2008.

3. These appeals are, accordingly, dismissed.

4. It is needless to clarify that we have reserved the liberty for the parties to challenge the Assessment Order in accordance with law.
