O R D E R

SLP(C) No. 396/2026

Service was complete on respondent Nos. 2 to 8 & 11 to 14 on 01.04.2026 but none has entered appearance.

Service was complete on respondent Nos. 15, 16, 19 to 26 & 29 to 52 in July, 2026 through dasti but none has entered appearance.
