ORDER

This Criminal Revision Case is filed seeking to call for the records and set aside the order passed in Crl.MP.No.1189 of 2025 dated 21.08.2025, on the file of the District and Sessions Court, Karur in view of the settlement arrived at by both sides and allow the Criminal Revision Petition.

2. The petitioner is an accused in a complaint lodged by the respondent complainant before the learned Judge, Fast Track Court(Magistrate level), Karur in C.C.No.601 of 2017. After a full-fledged trial, the petitioner was convicted and sentenced to undergo one year simple imprisonment. She was later taken into custody. Thereafter, she had preferred a criminal appeal, with a delay of 740 days in filing and this Crl.M.P.No.1189 of 2025 is the condone delay petition seeking to condone the delay of 740 days. The petitioner herein is a Doctor, aged 68 years old. However, the the learned District and Sessions Judge, Karur, allowed the same directing the petitioner to deposit 50% of the cheque amount of Rs.3,42,000/- to the credit of CC.No.601 of 2017 on the file of

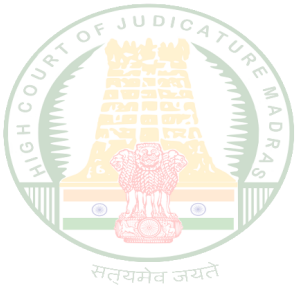

the learned Judicial Magistrate, Fast Track Court @ Magisterial level, Karur. Since, due to her inability to pay the same, the petition was dismissed by order dated 21.08.2025. Pursuant to which she was taken into custody again, and she is now confined at Special Prison for Women, Trichy. In the interagnum, her family had settled the entire cheque amount to the respondent complainant.

3. When the matter came up for hearing, the learned counsel for the petitioner and the respondent had together submitted before this Court that the petitioner has settled the entire amount.

4. Recording the same, the order dated 21.08.2025 passed in CrI.M.P. No. 1189 of 2025 by the learned District and Sessions Court, Karur, is set aside and the conviction order dated 01.06.2023 passed by the learned Judge, Fast Track Court(Magistrate level), Karur in C.C.No. 601 of 2017 is also set aside.
