1. This Application has been filed under Section 60(5) of the Insolvency and Bankruptcy Code, 2016 seeking, inter alia, dismissal of the application for approval of the Resolution Plan dated 13.02.2026, as amended by the Addendum dated 20.05.2026, or, alternatively, appropriate modification of the Resolution Plan in respect of the technology claimed by the Applicant.

2. Upon oral request, the Successful Resolution Applicant (SRA) is impleaded as Respondent No. 2. Necessary amendment in the cause title shall be carried out by the Applicant today itself.
3. Upon hearing the learned Senior Counsel for the Applicant and the learned Senior Counsel appearing for the SRA, it is submitted on behalf of the SRA that an affidavit/undertaking shall be filed stating that the technology in question shall not be used during the pendency of the proceedings before the Hon'ble Supreme Court and, in the event the Resolution Plan is approved, the same shall not be used until an interim or final decision is rendered by the Hon'ble Supreme Court.
4. Let the affidavit/undertaking be filed by the SRA through the Resolution Professional during the course of the day and a copy thereof be served upon all concerned parties.
5. Re-list the matter for further consideration on 22.06.2026
