ITEM 3: Appointment of Mr. Gagan Goel (DIN: 07360059) as an Executive Director of the Company

The Board of Directors, at its meeting held on January 19, 2026, upon the recommendation of the Nomination and Remuneration Committee, appointed Mr. Gagan Goel as an Additional Director (Executive) of the Company with effect from January 19, 2026. In terms of Section 161(1) of the Companies Act, 2013, Mr. Gagan Goel shall hold office as an Additional Director up to the date of the ensuing Annual General Meeting of the Company. The Company has received a notice in writing from Mr. Gagan Goel under Section 160(1) of the Companies Act, 2013, proposing his candidature for appointment as a Director of the Company.

The Nomination and Remuneration Committee, having regard to his qualification, experience, expertise and the requirements of the Company, has recommended to the Board the appointment of Mr. Gagan Goel as an Executive Director of the Company, liable to retire by rotation, and the payment of remuneration to him within the limits prescribed under Sections 196 and 197 read with Schedule V to the Act.

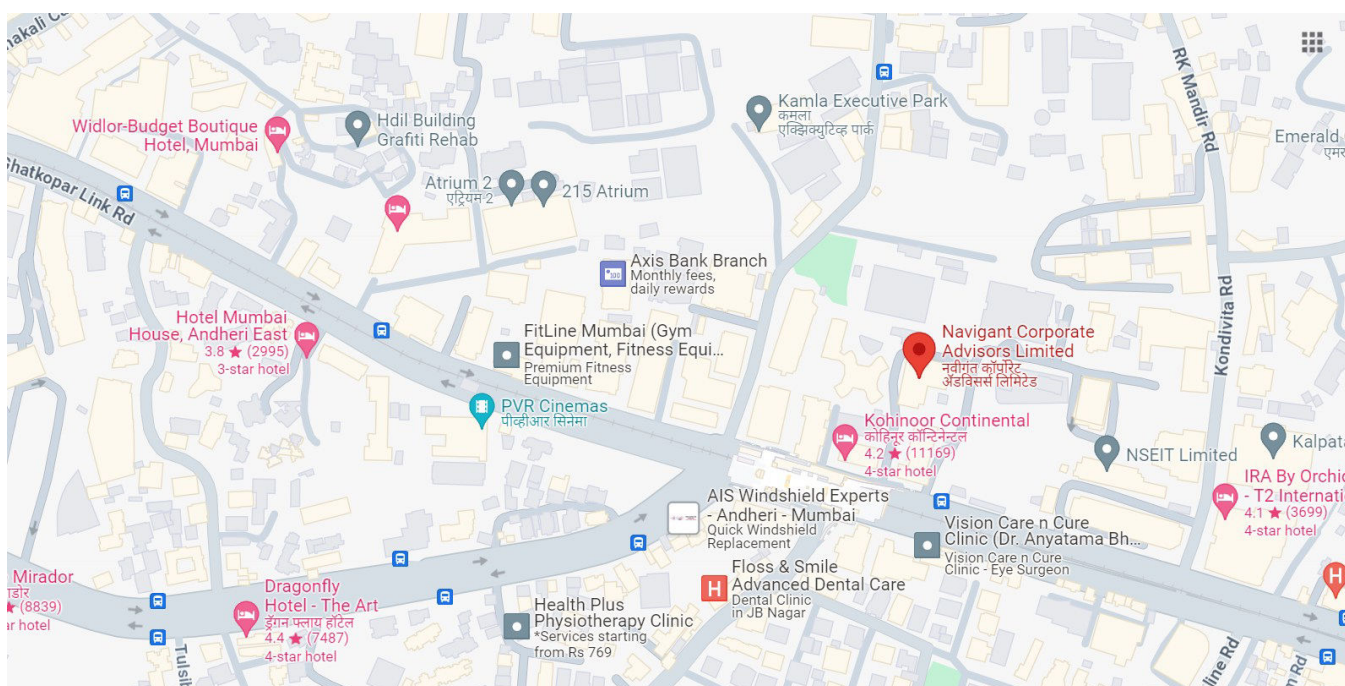

FINANCIAL HIGHLIGHTS

Your directors report that for the year under review, your Company had achieved total revenue of Rs. 490.57 Lacs as compared to Rs. 827.94 Lacs in the previous year. The revenue for the financial year 2026 has decreased by 40.75%. PAT has decreased by 46.13 % from Rs. 165.46 Lacs to Rs. 89.14 Lacs.

STATE OF COMPANY'S AFFAIRS

Company is SEBI Registered Category I Merchant Banker and is engaged into the Merchant Banking Activities. There has been no change in the business of the Company during the financial year ended 31st March, 2026.

CAPITAL STRUCTURE

The Authorized Share Capital of the Company is Rs 325.00 Lacs divided into 32,50,000 (Thirty-Two Lakh Fifty Thousand) Equity shares of Rs 10/- each.

The Paid-up Share Capital of the Company is Rs 315.28 Lacs divided into 31,52,750 (Thirty-One Lakhs Fifty-Two Thousand Seven Hundred Fifty) Equity shares of Rs 10/- each.

During the Financial year, there is no change in paid up share capital of the Company.

DIVIDEND

No dividend is being recommended by the Directors for the year ending on 31st March, 2026. As the Board of Directors wants to plough back the profit in to the business.

DEPOSIT

During the year under review your company has not accepted any deposits from the public and therefore no information is required to be furnished in respect of outstanding deposits.

CHANGES IN NATURE OF BUSINESS

There is no significant change made in the nature of the company during the financial year.

Company has no subsidiary, joint ventures or associate company. At the end of the financial year under review none of the Company have become or ceased to be subsidiary, joint ventures or associate companies.

RISK MANAGEMENT AND INTERNAL CONTROL SYSTEM

The Company has established a well-defined process of risk management, wherein the identification, analysis and assessment of the various risks, measuring of the probable impact of such risks, formulation of risk mitigation strategy and implementation of the same takes place in a structured manner. Though the various risks associated with the business cannot be eliminated

completely, all efforts are made to minimize the impact of such risks on the operations of the Company. The Company on various activities also puts necessary internal control systems in place across the Board to ensure that business operations are directed towards attaining the stated organizational objectives with optimum utilization of the resources.

All related party transactions that were entered into during the financial year were on an arm's length basis and were in the ordinary course of business.

The company is a SEBI Registered Category I Merchant Banker and is engaged in the Merchant Banking Activities and accordingly authorized to carry investments in terms of SEBI guidelines and investments are in accordance with of section 186 of the Companies Act, 2013.

TRANSFER TO RESERVES

The Company has transferred current year's profit of Rs. 89.14 Lacs to the Reserve & Surplus and the same is in compliance with the applicable provisions prescribed under the Companies Act, 2013.

DIRECTORS AND KEY MANAGERIAL PERSONNEL

As of 31st March, 2026, your Company's Board of Directors ("Board") had Six Directors comprising of Three Executive Directors and Three Independent Directors.

Changes in Director:

Mr. Gagan Goel was appointed as an Additional Director (Executive) of the Company with effect from January 19, 2026. Except as stated above, there was no change in the Directors of the Company during the financial year.

Retire by Rotation- Sarthak Vijlani

In accordance with Section 152(6) of the Companies Act, 2013 and Articles of Association of the Company, Mr. Sarthak Vijlani, Chairman & Managing Director (DIN: 05174824) of the company is liable to retire by rotation in the forthcoming Annual General Meeting and being eligible, he offers himself for re-appointment.

In the opinion of the Board, all the Independent Directors possess the integrity, expertise and experience including the proficiency required to be Independent Directors of the Company, fulfill the conditions of independence as specified in the Act and the Listing Regulations and are independent of the management and have also complied with the Code for Independent Directors as prescribed in Schedule IV of the Companies Act, 2013.

BOARD EVALUATION

In compliance with the provisions of the Companies Act, 2013 and other provisions, if any, the Board has carried out an annual performance evaluation of its own performance, the directors individually as well as the evaluation of the working of its Nomination & Remuneration Committee and Shareholder's Grievance Committee.

MANAGEMENT DISCUSSION AND ANALYSIS REPORT

Macro-Economic Environment-Indian Economy at large

The Indian economy sustained its growth momentum during the year under review and continued to be among the fastest growing major economies in the world. As per the Provisional Estimates of National Income released by the Ministry of Statistics and Programme Implementation, real Gross Domestic Product grew by 7.7% in FY 2025-26 as against 7.1% in FY 2024-25, with growth in the fourth quarter at 7.8%. Growth was supported by resilient private consumption, sustained public capital expenditure, double digit expansion in manufacturing and construction and a broad-based recovery in contact-intensive and financial services. During the year the national accounts were also rebased to 2022-23, aligning India's statistical framework with the structure of a rapidly transforming economy.

Nominal Gross Domestic Product for FY 2025-26 is estimated at approximately Rs. 346 lakh crore, and gross fixed capital formation grew by over 8%, reflecting a continuing investment cycle. Inflation remained broadly within the tolerance band, and financial market conditions stayed supportive of capital formation. While external headwinds, including geopolitical developments in West Asia and global trade and tariff uncertainty, remain a risk to the pace of growth in the coming year, the medium-term outlook for the Indian economy and for domestic capital markets continues to be constructive.

Industry Structure and developments:

Our Company is SEBI registered Category I Merchant Banker. Company mainly participates into SME Segment of Primary market issues, Valuation Advisory besides handling various assignments on Rights Issue, Delisting, Open Offers, for Companies on Disseminations Board and various valuation exercise including ESOP advisory.

The SME Platform offers an entrepreneur and investor friendly environment, which enables the listing of SMEs from the unorganized sector scattered throughout India into a regulated and organized sector. The platform provides an opportunity to SME entrepreneurs to raise equity capital for growth and expansion. It also provides an opportunity for investors to identify and invest in good SMEs at an early stage. Over the last few years the SME segment has emerged as one of the most active parts of the Indian primary market, with the number of SME issues in several years exceeding the number of main board issues.

SEBI adopts the principle of a consultative approach for making rules and regulations best suited for the capital market, with the objective of developing and regulating the Indian securities market as well as protecting the interest of investors. During the year under review, the SEBI (Issue of Capital and Disclosure Requirements) (Amendment) Regulations, 2025 notified on 3rd March, 2025 significantly recalibrated the SME IPO framework. The key changes include a minimum operating profit (EBITDA) of Rs. 1 crore in at least two of the three preceding financial years, a cap of 20% of the issue size on the offer for sale component together with a restriction on any selling shareholder offering more than 50% of its pre-issue holding, a phased lock-in on promoter holding in excess of the minimum promoter contribution, a cap on the general corporate purposes component at 15% of the issue size or Rs. 10 crore whichever is lower, a prohibition on the use of issue proceeds to repay loans from promoters and the promoter group, and the extension of related party transaction norms applicable to main board companies to SME listed entities. SME listed entities are also now permitted to undertake further issues of capital beyond the erstwhile threshold without mandatory migration to the main board, subject to compliance with the SEBI (Listing Obligations and Disclosure Requirements) Regulation, 2015 as applicable to main board companies. These measures have shifted the SME segment from volume towards quality, moderating deal flow in the near term while, in the view of the management, improving the credibility and durability of the segment over the medium term.

In addition to that, as per Rule 11UA (2) (b) of the Income Tax Rules, 1962, whenever an Indian unquoted company issues equity shares at a price other than book value it has to obtain a certification from Merchant Bankers on the fair value of unquoted equity shares on a discounted cash flow basis. Your Company had identified this opportunity and was providing services to companies across India including large corporates. However, pursuant to the Finance Act, 2024, Section 56(2)(viib) of the Income Tax Act, 1961 is no longer applicable, and accordingly valuation of shares and securities may no longer be required for the issuance of shares and securities. This has had a substantial adverse effect on the total revenue of your Company, the full year impact of which has been reflected in the results for the year under review.

OPPORTUNITIES AND THREATS

- Opportunities:

- Sustained activity in the Indian equity markets and continued interest in the SME segment support demand for merchant banking services.
- Growth in private equity, venture capital and strategic investments into Indian companies, together with a widening equity investment culture, continues to generate demand for valuation and fairness opinion assignments.
- Fund raising, restructuring, open offer, buy-back, delisting and ESOP related transactions continue to require the services of

a merchant banker, and the recalibrated SEBI framework favours established intermediaries with strong due diligence capability.

• **Threats:**

Despite opportunities, there are significant factors presenting threats to our business viz:

- Uncertainty and low business confidence due to inflationary concerns will adversely impact the business.
- Capital Market gets affected by events such as interest rate hikes, monsoon performance, tax concerns, other global events & domestic political events such as interim & state elections.
- Continuous downward pressure on the fees and commissions caused by heightened competition and willingness of most players to deliver services at very low fees.
- The effect of any of the adverse events on the capital market would pose a threat for the process of capital formation and resource raising.
- Change in Regulatory Policy

Internal Control Systems and Their Adequacy:

The Company has an Internal Control System commensurate with its requirement and size of business to ensure that the assets and interest of the Company assets are safeguarded. The adequacy and effectiveness of the internal control across various activities, as well as compliance with laid down system and policies are comprehensively and frequently monitored by your Company's management at all the levels of the originations. The Company has established well defined policies and process across the originations covering all major activities including authority for approvals in all cases where monetary decisions are involved, various limits and authorities are in place.

The Audit Committee of the Board of Directors review the existing audit procedures and internal systems of control on an ongoing basis keeping in mind the organization's requirements, growth prospects and ever evolving business environment.

They also review the internal audit findings and recommendations and ensure that corrective measures are implemented.

Outlook:

India remains one of the most vibrant global economies, supported by robust banking, insurance and capital market infrastructure and by a sustained domestic investment cycle.

The Indian equity market continues to expand in terms of listed companies and market capitalisation, widening the playing field for intermediaries. The regulatory changes introduced in the SME segment during the year are expected to moderate issue volumes in the near term while improving the quality of issuers coming to market.

With increasing retail participation and growing financial awareness, there remains significant potential in the market. Your Company intends to consolidate its position in valuation advisory and transaction related assignments, strengthen its due diligence and compliance capability in line with the revised regulatory framework, and pursue a broader mix of mandates so as to reduce dependence on any single revenue stream.

Risks And Concern:

Risk is an integral part of the business and we aim at delivering superior shareholder value by achieving an appropriate balance between risks and returns. Our senior management identifies and monitors the risks on an ongoing basis and evolves process/systems to monitor and control the same to contain the risks to minimum levels. Ongoing monitoring by our officials help in identifying risks early. The financial services industry is subject to continuously evolving legislative and regulatory environment due to increasing stringent regulatory framework.

Human Resources:

Navigant Corporate Advisors Limited is part of dynamic and progressive group that actively fosters a challenging work environment and encourages Entrepreneurship. With trust being the critical part of our business belief, we lay a strong emphasis on integrity, teamwork. Our Professional staff with diverse backgrounds brings varied talent, knowledge and experience to the Group, helping our business to remain competitive, achieve greater success and newer milestone.

Review Of Operations:

During this year Company has carried out various other assignments such as Open Offers, Rights Issues, Preferential Issue and valuation exercise including ESOP advisory. The total Revenue from operations during the year has decreased to Rs. 464.07 Lacs as compared to Rs. 779.51 Lacs witnessed in 2024-25. Company has also been able to provide valuation services to few large corporates. The overall financial performance of the Company was impacted by lower volumes of transaction based mandates during the year, following the withdrawal of Section 56(2)(viib) of the Income Tax Act, 1961 and the recalibration of the SME IPO

framework. The Company continues to focus on valuation and advisory services.

Investor Relations:

We consider investor relations to be an important aspect of our business as we believe in building transparent and open relationship with our stakeholders. As a listed Company, we are now laying even greater emphasis on our investor relations program to provide our investors, analysts and other stakeholders with a complete and accurate picture of the Company's past and current performance and the prospects and strategies for the future.

Notes Forming Part of the Financial Statements for the year ended 31st March, 2026

NOTE No. 1

A: CORPORATE INFORMATION

The Company has been incorporated as “S.P. Realtor Estate Private Limited” on 21st May, 2012. The name of company has been changed to “Navigant Corporate Advisors Private Limited” vide fresh certificate of incorporation dated 11th September, 2013. The constitution of the Company has been changed to a public limited company vide fresh certificate of incorporation dated 21st January, 2015.

B: SIGNIFICANT ACCOUNTING POLICIES

1. Basis for Preparation of Financial Statements

The Financial statements have been prepared under the historical cost convention on the accrual basis in accordance with Generally Accepted Accounting Principles in India, and materially comply with the mandatory accounting standards issued by the Institute of Chartered Accountants of India (ICAI) and the provisions of the Companies Act, 2013. Accounting standards have been consistently applied except where a newly issued accounting standard is initially adopted or a revision to an existing accounting standard requires a change in the accounting policy hitherto in use. Management evaluates all recently issued or revised accounting standards on an ongoing basis.

2. Use of Estimates

The preparation of Financial Statements in conformity with GAAP requires that the management of the Company makes estimates and assumptions that affect the reported amounts of income and expenses of the period, the reported balances of assets and liabilities and the disclosures relating to contingent liabilities as of the date of the financial statements. Examples of such estimates include the useful lives of fixed assets and intangible assets, provision for doubtful debts / advances, future obligations in respect of retirement benefit plans, etc. Actual results could differ from these estimates. Difference between the actual results and estimates are recognized in the period in which the results are known/ materialized. Management believes that the estimates used in preparation of financial statements are prudent and reasonable.

3. Fixed Assets and Depreciation

- i. Fixed Assets are shown at historical cost net of recoverable taxes inclusive of incidental expenses less accumulated depreciation.
- ii. Intangible Assets are stated at cost of acquisition net of recoverable taxes less accumulated depreciation.
- iii. Depreciation on fixed assets is provided on Straight Line Method at the rates prescribed under Companies Act, 2013.
- iv. Depreciation on fixed assets sold during the year, is provided on pro-rata basis with reference to the date of addition/ deletion.

4. Revenue Recognition

Revenue is recognized only when it can be reliably measured and it is reasonable to expect ultimate collection.

Revenue from operations includes sale of services,

Dividend income is recognized when right to receive is established. Interest income is recognized on time proportion basis taking into account the amount outstanding and rate applicable.

5. Investments

Investments are stated at cost, Provision for diminution in the value of investments is made only if such a decline is other than temporary.

6. Impairment of Assets

As on Balance Sheet date, the Company reviews the carrying amount of Fixed Assets to determine whether there are any indications that those assets have suffered “Impairment Loss”. Impairment loss, if any, is provided to the extent, the carrying amount of assets exceeds their recoverable amount. Recoverable amount is higher of an asset’s net selling price and its value in use. Value in use is the present value of estimated future cash flows expected to arise from continuing use of an asset and from its disposal at the end of its useful life.

7. Borrowing Costs

Borrowing costs that are attributable to the acquisition or construction of qualifying assets are capitalised as part of the cost of such assets. A qualifying asset is one that takes necessarily substantial period of time to get ready for its intended use. All other borrowing costs are charged to revenue.

8. Taxation

Tax expenses for the year comprise of current tax and deferred tax. Current tax is measured after taking into consideration the deductions and exemptions admissible under the provision of Income Tax Act, 1961 and in accordance with Accounting Standard 22 on "Accounting for Taxes on Income", issued by ICAI.

Deferred Tax assets or liabilities are recognized for further tax consequence attributable to timing difference between taxable income and accounting income that are measured at relevant enacted tax rates. At each Balance Sheet date the company reassesses unrecognized deferred tax assets, to the extent they become reasonably certain or virtually certain of realization, as the case may be.

9. Leases

Finance Lease

Leases which effectively transfer to the company all the risks and benefits incidental to ownership of the leased item, are classified as Finance Lease. Lease rentals are capitalized at the lower of the fair value and present value of the minimum lease payments at the inception of the lease term and disclosed as leased assets. Lease payments are apportioned between the finance charges and reduction of the lease liability based on the implicit rate of return. Finance charges are charged directly against income life of the assets at the following rates.

Operating Lease

Lease where the lesser effectively retains substantially all risks and benefits of the asset are classified as Operating lease. Operating lease payments are recognized as an expense in the Profit & Loss account on a Straight Line Basis over the Lease term.

10. Preliminary Expenses

Preliminary expenses are amortized as per applicable income tax rules.

11. Earnings per Share

In determining the Earnings Per share, the company considers the net profit after tax includes any post tax effect of any extraordinary / exceptional item. The number of shares used in computing basic earnings per share is the weighted average number of shares outstanding during the period.

The number of shares used in computing Diluted earnings per share comprises the weighted average number of shares considered for computing Basic Earnings per share and also the weighted number of equity shares that would have been issued on conversion of all potentially dilutive shares.

In the event of issue of bonus shares, or share split the number of equity shares outstanding is increased without an increase in the resources. The number of Equity shares outstanding before the event is adjusted for the proportionate change in the number of equity shares outstanding as if the event had occurred at the beginning of the earliest period reported.

12. Contingent Liabilities & Provisions

Provisions are recognized only when there is a present obligation as a result of past events and when a reliable estimate of the amount of obligation can be made.

Contingent Liability is disclosed for

- Possible obligation which will be confirmed only by future events not wholly within the control of the company or
- Present obligations arising from the past events where it is not probable that an outflow of resources will be required to settle the obligation or a reliable estimate of the amount of the obligation cannot be made.
- Contingent Assets are not recognized in the financial statements since this may result in the recognition of income that may never be realized.

C: NOTES ON FINANCIAL STATEMENTS

1. Contingent liabilities

There are no Contingent Liabilities during the reported period.
