This is with reference to your email pointing out the discrepancy regarding the timing of the submission of the Corporate Announcement under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, concerning the execution of the Partnership Agreement with TSOT Ventures Private Limited ("The Secret Of Tea").

We wish to clarify that the scheduling of the disclosure was closely linked to necessary internal administrative and operational flows. Due to a non-disclosure agreement with the counter party the company was contractually obligated to obtain formal prior clearances and permissions regarding the text of the communication before its public release.

The coordination required to secure these contractually mandated clearances, alongside the completion of vital technical protocols and internal verifications, naturally extended the time required to finalize and dispatch the disclosure.

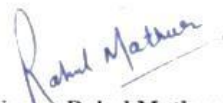

Dear Sir/Madam,

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, read with the applicable provisions thereof, we are pleased to inform the Exchange that MRC Agrotech Limited ("the Company") has entered into a strategic Partnership Agreement with TSOT Ventures Private Limited (carrying on business under the brand name "The Secret of Tea") on 31 August 2026.

Under the said Agreement, the Company has appointed TSOT Ventures Private Limited as a non-exclusive partner to list, supply, distribute, and promote its premium Temi Tea products through "The Secret of Tea" platform. The platform will act as an online retail channel managing a dedicated virtual store for the brand, while additionally reserving the right to scale market presence through strategic offline promotional channels such as exhibitions.

The key commercial and operational parameters of the Agreement are detailed below:

- **Commercial Margin:** The Company will supply its retail tea packets of Temi Tea to the partner at a pre-agreed retail margin on MRP.
- **Payment Terms:** To mitigate financial and credit risk, all transactions require 100% advance bank transfers executed prior to the shipping of products.
- **Logistics & Returns:** The Company shall handle product delivery to the partner's designated warehouse. Any instances of damaged or expired goods must be documented and reported to the Company within three (3) working days of inventory receipt for resolution via replacement or refund.
- **Tenure & Exit:** The Agreement commences on the Effective Date (31 August 2026) and will continue until terminated by either party by giving a 30 days' written notice. A cure period of fifteen (15) days is provided for material breaches.
