1. The present Application has been filed by the Committee of Creditors of M/s. Harshil Agrotech Limited through its sole member, Cultiva Trade Enterprise Private Limited, under Sections 27 and 60(5) of the Insolvency and Bankruptcy Code, 2016 read with Rule 11 of the NCLT Rules, 2016 for seeking replacement of Mr. Neeraj Kumar Bajaj, Resolution Professional, and appointment of Mr. Malav Ajmera as Resolution Professional in the CIRP of the Corporate Debtor with the following prayers: -
  - a. *Allow the present Application;*
  - b. *Replace the Respondent, Mr. Neeraj Kumar Bajaj, as the Resolution Professional in Company Petition (IB) No. 97 of 2026;*
  - c. *Appoint Mr. Malav Ajmera having registered no. IBBI/IPA-001-P-P01190/2018-2019/11908 with the Insolvency and Bankruptcy Board of India as the Resolution Professional in*

*place of Mr. Neeraj Kumar Bajaj for conducting the CIRP of the Corporate Debtor in CP(IB) No. 97 of 2026;*

*d. Pass such other and further orders as this Hon'ble Tribunalma deem fit and proper in the interest of justice.*

2. It is submitted that the Applicant constitutes 100% voting share of the Committee of Creditors. The Applicant has placed on record the written consent in Form AA of Mr. Malav Ajmera and seeks substitution of the existing Resolution Professional.
3. Issue notice to the Respondent. Ld. Counsel for the Respondent appeared and waived notice.
4. The Respondent is directed to file reply, if any, within 3 days. Rejoinder, if any, may be filed before next date.
