Sub: Non-Applicability of Regulation 23(9) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 for the quarter ended June 30, 2026.

Dear Sir / Madam,

Pursuant to Regulation 15(2) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended from time to time ("Listing Regulations"), we wish to inform you that the provisions relating to Corporate Governance, including Regulation 23 of the Listing Regulations, are not applicable to Spice Islands Industries Limited ("the Company").

The applicability of the aforesaid provisions is not attracted to the Company as, as on March 31, 2026, the paid-up share capital of the Company is ₹6,23,33,240/- (Rupees Six Crore Twenty-Three Lakh Thirty-Three Thousand Two Hundred Forty Only) and the net worth of the Company is ₹14,02,00,000/- (Rupees Fourteen Crore Two Lakh Only), which are below the prescribed thresholds of ₹10 Crores and ₹25 Crores, respectively, as applicable for the purpose of Regulation 15(2).

Regulation 15(2) of the Listing Regulations provides that the compliance with the Corporate Governance provisions specified, inter alia, under Regulations 17, 17A, 18, 19, 20, 21, 22, 23, 24, 24A, 25, 26 and 27, and clauses (b) to (i) of sub-regulation (2) of Regulation 46 and Para C, D and E of Schedule V, shall not apply to certain listed entities meeting the prescribed conditions.

Accordingly, the provisions of Regulation 23(9) relating to disclosure of related party transactions are not applicable to the Company for the quarter ended June 30, 2026, and consequently, the Company is not required to submit the
