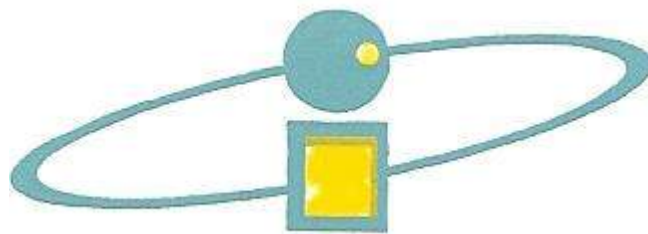

In accordance with the applicable provisions of the Companies Act, 2013 ("Act"), read with the Rules made thereunder and the Ministry of Corporate Affairs ('MCA') General Circular 14/2020 dated 08th April, 2020, 17/2020 dated 13th April, 2020, 20/2020 dated 05th May, 2020, 22/2020 dated 15th June, 2020, 33/2020 dated 28th September, 2020, 39/2020 dated 31st December, 2020, 02/2021 dated 13th January, 2021, 19/2021 dated 8th December, 2021, 21/2021 dated 14th December, 2021, 02/2022 dated 05th May, 2022, 10/2022 dated 28th December, 2022 issued by the Ministry of Corporate Affairs ('MCA') (collectively referred to as 'MCA Circulars') and SEBI Circular No. SEBI/HO/CFD/CMD1/CIR/P/2020/79, dated 12th May, 2020, SEBI/HO/CFD/CMD2/CIR/P/2021/11 dated 15th January, 2021, SEBI/HO/CFD/CMD2/CIR/P/2022/62 dated 13th May, 2022 and SEBI/HO/CFD/PoD-2/P/CIR/2023/4 dated 05th January, 2023, issued by the Securities and Exchange Board of India ("SEBI"), from time to time (hereinafter collectively referred to as ("the Circulars")), permitted the conduct of the Annual General Meeting ("AGM") through Video Conferencing ("VC") / Other Audio Visual Means ("OAVM"), without the physical presence of the Members at a common venue. The deemed venue for the AGM shall be the Registered Office of the Company. In compliance with the provisions of the Companies Act, 2013 ("Act"), SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations") MCA Circulars and SEBI Circulars this 34th AGM of the Company is being held through VC / OAVM. Members desirous of participating in the meeting through VC/OAVM, may refer to the procedures mentioned below in this AGM notice.
2. Pursuant to the provisions of the Act, a member entitled to attend and vote at the AGM is entitled to appoint a proxy to attend and vote on his/her behalf and the proxy need not be a Member of the Company. Pursuant to the General Circular No. 14/2020 dated 08th April, 2020, issued by the Ministry of Corporate Affairs, the facility to appoint proxy to attend and cast vote for the members is not available for this AGM and hence the Proxy Form and Attendance Slip are not annexed to this Notice. However, the Body Corporates are entitled to appoint Authorized Representatives to attend the AGM through VC / OAVM and participate there at and cast their votes through e-voting.
3. Institutional / Corporate Shareholders (i.e., other than individuals / HUF, NRI, etc.) are required to send a scanned copy (PDF/JPG Format) of its Board or governing body Resolution/Authorization etc., authorizing its representative to attend the AGM through VC / OAVM on its behalf and to vote through remote e-voting. The said Resolution/Authorization should be mailed to the company at Innogroup@gmail.com or to the scrutinizers of the Company at Csanishajhunjhunwala2017@gmail.com with a copy marked to evoting@nsdl.co.in.
4. Members attending the AGM through VC / OAVM shall be counted for the purpose of reckoning the quorum under Section 103 of the Act. In case of Joint Holders, the member whose name appears as First Holder in the order of names on the Register of Members of the Company will be entitled to vote.
5. Since the AGM will be held through VC / OAVM, the Route Map is not annexed in this Notice.
6. The Register of Members and share transfer books of the Company will remain closed from **Friday, September 24, 2026 to Tuesday, September 29, 2026 (both days inclusive)** as per Section 91 of the Companies Act, 2013 read with Rule 10 of the Companies (Management and Administration) Rules, 2014 and Regulation 42 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.
7. Brief profile, details of shareholding and inter-se relationship of Directors seeking appointment / re-appointment as required under Regulation 36 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and Secretarial Standards are provided as Annexure to this notice, if applicable.
8. The Securities and Exchange Board of India (SEBI) has mandated the submission of Permanent Account Number (PAN) and bank account details by every participant in securities market. Members holding shares in electronic form are, therefore, requested to submit the PAN and bank account details to their Depository Participants with whom they are maintaining their demat account(s). Members holding shares in physical form can submit their PAN details and bank account details to the Registrars and Share Transfer Agents of the Company. Hence, the shareholders are requested to immediately register their PAN and bank account details.

In accordance with Regulation 40 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended, the Company has stopped accepting any fresh transfer requests for securities held in physical form. Members holding shares of the Company in physical form are requested to kindly get their shares converted into de-mat/electronic form to get inherent benefits of de-materialization. Further, Members may please note that SEBI vide its Circular dated January 25, 2022 mandated listed companies to issue securities in de-mat form only while processing any service requests viz. issue of duplicate securities certificate; claim from Unclaimed Suspense Account; renewal/exchange of securities certificate; endorsement; sub-division/splitting of securities certificate; consolidation of securities certificates/folios; transmission and transposition. All shareholders holding shares in physical form are requested to demat their shares at the earliest.

9. The Members are requested to dematerialize their shareholdings with their Depository Participants as the Company's Shares are traded compulsorily under Demat mode in the Stock Exchanges.
10. Members are requested to:
 - (a) Intimate to the Company's Registrar and Share Transfer Agents– Purva Sharegistry (India) Private Limited, changes, if any, in their registered addresses and e-mail id at an early date, in case shares held in physical form;
 - (b) Intimate respective Depository Participant, changes, if any, in their registered addresses or e-mail id at an early date, in case of shares held in dematerialized form;
 - (c) Quote their folio numbers/client ID/DP ID in all correspondence; and
 - (d) Consolidate their holdings into one folio in the identical order of names.
 - (e) Update their PAN and Bank account details by sending a self-attested copy of the PAN along with original cancelled Cheque bearing their name on it or bank passbook/statement attested by their Bank to the Registrar and Share Transfer Agents of the Company.
11. SEBI vide its circular No. SEBI/HO/MIRSD/MIRSD_RTAMB/P/CIR/2021/655 dated 3rd November, 2021, SEBI/HO/MIRSD/MIRSD_RTAMB/P/CIR/2021/687 dated 14th December, 2021 and SEBI/HO/MIRSD/ MIRSD-PoD-1/P/CIR/2023/37 dated 16th March, 2023 has mandated that the shareholders holding shares in physical form are required to update their PAN, KYC details, bank details and nomination details with the RTA on or before 30th September, 2023, failing which the securities held by such shareholder will be frozen by the RTA. The securities once frozen will revert to normal status only upon receipt of requisite KYC documents or upon dematerialization of the said securities. Further, the said SEBI Circular has also mandated that the shareholders holding shares in physical form are required to compulsorily link their PAN and Aadhaar. Accordingly, the physical folios in which PAN and Aadhaar are not linked have been frozen by the RTA. The securities which have been frozen will revert to normal status only upon receipt of requisite KYC documents or upon dematerialization of the said securities. Necessary prior intimation(s) in this regard was provided to the Shareholders. Therefore, Members holding share(s) in physical form are requested to immediately update their KYC details / dematerialize their shareholding in the Company. A copy of the said circulars are available on the Company's website www.islconsulting.in.
12. As per the provisions of Section 72 of the Act, facility for making nominations is available to Individual(s) holding shares in the Company. Members holding shares in physical form may obtain the Nomination Form from the Registrars and Share Transfer Agents of the Company. Members holding shares in electronic form have to approach their depository participants for completing the nomination formalities.
13. Pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 (as amended) and Regulation 44 of SEBI (Listing Obligations & Disclosure Requirements) Regulations 2015 (as amended), and the Circulars issued by the Ministry of Corporate Affairs dated April 08, 2020, April 13, 2020 and May 05, 2020 the Company is providing facility of remote e-Voting to its Members in respect of the business to be transacted at the AGM. For this purpose, the Company has entered into an agreement with National Securities Depository Limited (NSDL) for facilitating voting through electronic means, as the authorized agency. The facility of casting votes by a member using remote e-Voting system as well as venue voting on the date of the AGM will be provided by NSDL.
14. Pursuant to SEBI Circular No. SEBI/HO/CFD/CMD/CIR/P/2020/242 dated 09th December, 2020 and under Regulation 44 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, every Listed Company is required to provide remote e-voting facility to its shareholders, in respect of all shareholders' resolutions. However, it has been observed that the participation by the public

non-institutional shareholders/retail shareholders is at a negligible level. Currently, there are multiple e-voting service providers (ESPs) providing e-voting facility to listed entities in India. This necessitates registration on various ESPs and maintenance of multiple user IDs and passwords by the shareholders. In order to increase the efficiency of the voting process, pursuant to a public consultation, it has been decided to enable e-voting to all the demat account holders, by way of a single login credential, through their demat accounts/ websites of Depositories/ Depository Participants. Demat account holders would be able to cast their vote without having to register again with the ESPs, thereby, not only facilitating seamless authentication but also enhancing ease and convenience of participating in e-voting process.

In terms of SEBI circular no. SEBI/HO/CFD/CMD/CIR/P/2020/242 dated December 9, 2020 on e-Voting facility provided by Listed Companies, Individual shareholders holding securities in demat mode are allowed to vote through their demat account maintained with Depositories and Depository Participants. Shareholders are advised to update their mobile number and email Id in their demat accounts in order to access e-Voting facility.

15. Members desirous of obtaining any information as regards to the Accounts are requested to send an email to Innogroup@gmail.com, 15 days in advance before the date of the Meeting (**i.e., on or before Monday, 14th September, 2026 by 05:00 P.M.**) to enable the Management to keep full information ready on the date of AGM.
16. As the Annual General Meeting of the Company is held through VC / OAVM, we therefore request the members to submit questions in advance relating to the business specified in this notice of AGM on the email ID Innogroup@gmail.com.
17. As per the green initiative taken by the Ministry of Corporate Affairs, the members who have not registered their email addresses, Company has provided facility to register/update the email addresses with the RTA of the Company on <https://www.purvashare.com/email-and-phone-updation/> or can get it registered with their respective Depository Participants (DP) to enable the Company to serve documents in electronic form.
18. In compliance with aforesaid MCA Circulars and SEBI Circulars, the Annual Report will be sent through electronic mode to only those Members whose E-mail ID's are registered with the Registrar and Share Transfer Agent of the Company / Depository participant.
19. Members of the Company holding shares either in physical form or in de-materialized forms as on **cut-off date i.e. Friday August 28, 2026** will receive Annual Report for the financial year 2025-26 through electronic mode.
20. In line with the aforesaid MCA Circulars, the Notice calling the AGM has been uploaded on the website of the Company at www.islconsulting.in. The Notice can also be accessed from the website of the Stock Exchange i.e. BSE Limited at www.bseindia.com and the AGM Notice is also available on the website of NSDL (agency for providing the Remote E – Voting facility) i.e. www.evoting.nsdl.com.
21. The results of the e-voting and Remote e- voting during the Annual General Meeting will be announced by the Chairperson or person authorized by the Chairperson **within two working days** from the date of conclusion of the Annual General Meeting. A copy of which will be posted on the Company's website and forwarded to the Stock Exchange.
22. The Registers maintained under the Act and all the documents referred to in the accompanying notice and explanatory statements, which are eligible for inspection, will be available electronically for inspection by the members up to the date of AGM. Members seeking to inspect such documents can send an e-mail to innogroup@gmail.com.
23. **Voting through Electronic means:**
In compliance with the provisions of Section 108 of the Companies Act, 2013 and Rule 20 of the Companies (Management and Administration) Rules, 2014 and SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, (including any statutory modifications, clarifications, exemptions or re-enactment thereof for the time being in force), the Company is pleased to provide the members the facility to exercise their votes for all the resolutions detailed in the Notice of the 34th Annual General Meeting scheduled to be held on **Tuesday, September 29, 2026 at 2:00 PM** by electronic means and the business may be transacted through

remote e-voting and e-voting system during the AGM. Those Members, who will be present in the AGM through VC / OAVM facility and have not cast their vote on the Resolutions through remote e-voting, and are otherwise not barred from doing so, shall be eligible to vote through e-voting system during the AGM.

The Company has engaged the services of NSDL as the authorized agency to provide the remote e-voting and e-voting during the AGM as per the instructions given below:

Vote by Remote e-Voting and e-voting during the AGM

The remote e-voting period begins on **Saturday September 26, 2026 (09:00 A.M. IST) and ends on Monday September 28, 2026 (5:00 P.M. IST)**. During this period shareholders of the Company, holding shares either in physical form or in dematerialized form, as on the cut-off date **Tuesday, September 22, 2026** may cast their vote electronically. The e-voting module shall be disabled by NSDL for voting thereafter.

The voting rights of Members shall be in proportion to their shares in the paid-up equity share capital of the company as on the cut-off date.

The Company has appointed Mrs. Anisha Jhunhunwala, Practicing Company Secretary, to act as the Scrutinizer, to scrutinize the voting during the AGM and remote e-voting process in a fair and transparent manner.

The results declared along with the scrutinizer's report shall be placed on the Company's website www.islconsulting.in and shall be communicated to the BSE Limited where the shares of the company are listed within the time prescribed by the law.

Any person, who acquires Shares of the Company and becomes Member of the Company after sending the Notice and holding Shares as of the cut-off date, may obtain login ID and password by sending a request at innogroup@gmail.com or evoting@nsdl.co.in. However, if he / she is already registered with NSDL to remote e-voting then he / she can use his / her existing user ID and password for casting vote. Any person who ceases to be the member of the Company as on cut-off date and in receipt of this notice, shall treat this AGM Notice for information purpose only.

The Members who have cast their vote by remote e-voting prior to the AGM may also attend/ participate in the AGM through VC / OAVM but shall not be entitled to cast their vote again. Once the vote on a Resolution is cast by the Member, the Member shall not be allowed to change it subsequently.

The Members can join the AGM in the VC/OAVM mode 30 minutes before and after the scheduled time of the commencement of the Meeting by following the procedure mentioned in the AGM Notice. The facility of participation at the AGM through VC/ OAVM will be made available for 1000 members on first come first served basis. This will not include large Shareholders (Shareholders holding 2% or more shareholding), Promoters, Institutional Investors, Directors, Key Managerial Personnel, the Chairpersons of the Audit Committee, Nomination and Remuneration Committee and Stakeholders Relationship Committee, Auditors etc. who are allowed to attend the AGM without restriction on account of first come first served basis.

The Members, whose names appear in the Register of Members / Beneficial Owners as on the record date (**cut-off date**) i.e. **Tuesday, September 22, 2026**, may cast their vote electronically. The voting right of shareholders shall be in proportion to their share in the paid-up equity share capital of the Company as on the cut-off date, being **Tuesday, September 22, 2026**.*

How do I vote electronically using NSDL e-Voting system?

The way to vote electronically on NSDL e-Voting system consists of "Two Steps" which are mentioned below:

Step 1 : Access to NSDL e-Voting system

A) Login method for e-Voting and joining virtual meeting for Individual shareholders holding securities in demat mode.

In terms of SEBI circular dated December 9, 2020 on e-Voting facility provided by Listed Companies, Individual shareholders holding securities in demat mode are allowed to vote through their demat account maintained with Depositories and Depository Participants. Shareholders are advised to update their mobile number and email Id in their demat accounts in order to access e-Voting facility.

Dear Members,

Your directors are pleased to present the 34th Annual Report along with the Audited Accounts of the Company for the financial year ended on March 31, 2026.

During the financial year ended March 31, 2026, the Company recorded Revenue from Operations of Rs. 1,857.81 lakhs as against Rs. 2,447.24 lakhs in the previous financial year, representing a decrease of approximately 24.70%. Other Income during the year stood at Rs. 6.04 lakhs, as compared to Rs. 9.53 lakhs in the previous year. Accordingly, the Total Income of the Company for the financial year 2025-26 stood at Rs. 1,863.85 lakhs, as against Rs. 2,456.77 lakhs in the financial year 2024-25. The total expenditure during the year decreased to Rs. 2,067.82 lakhs from Rs. 2,629.70 lakhs in the previous year.

The Company incurred a Loss before Tax of Rs. 203.97 lakhs during the financial year 2025-26, as compared to a loss before tax of Rs. 172.92 lakhs in the previous financial year. After considering tax expenses of Rs. 0.28 lakhs, the Company reported a Net Loss after Tax of Rs. 204.24 lakhs for the year under review, as against a net loss of Rs. 173.11 lakhs in the previous year.

The Earnings per Share (EPS) stood at (Rs. 0.85) for the financial year 2025-26 as compared to (Rs. 0.72) in the financial year 2024-25.

The overall financial performance reflects a decline in the Company's operating revenue during the year under review. Although the Company has reduced its total expenditure compared with the previous year, the reduction in revenue has resulted in an increase in the net loss for the year. The management continues to focus on improving operational efficiency, strengthening revenue generation and taking appropriate measures to improve the financial performance of the Company in the coming years.

DIVIDEND:

In order to conserve the financial resources, the Board of Directors of the Company do not recommend any dividend for the said financial year.

AMOUNT TRANSFER TO RESERVES AND SURPLUS:

The Company has transferred Rs. (204.24) lakhs to the Reserves and Surplus account.

CHANGE IN NATURE OF BUSINESS:

There is no change in the nature of business of the Company during the year under review.

MATERIAL CHANGES AND COMMITMENTS AFFECTING FINANCIAL POSITION BETWEEN THE END OF THE FINANCIAL YEAR AND DATE OF REPORT:

There have been no material changes and/or commitments affecting the financial position of the Company occurred between the end of the financial year to which this financial statement relates and the date of the report.

DISCLOSURE OF ORDERS PASSED BY REGULATORS OR COURTS OR TRIBUNAL:

During the year under review, no significant or material orders have been passed by the Regulators or Courts or Tribunals which can have impact on the going concern status and the Company's operations in future.

INTERNAL FINANCIAL CONTROL SYSTEM AND COMPLIANCE FRAMEWORK:

Pursuant to the provisions of Section 134(5)(e) of the Companies Act, 2013, the Company has established and maintained adequate internal financial controls commensurate with the nature, size, and complexity of its business operations. These controls are designed to ensure the orderly and efficient conduct of business, safeguarding of assets, prevention and detection of frauds and errors, accuracy and completeness of accounting records, and timely preparation of reliable financial information.

The Company's Internal Audit function operates independently and reports directly to the Audit Committee of the Board of Directors, thereby ensuring objectivity and impartiality in the evaluation of internal control processes. The Internal Auditors periodically review the adequacy and effectiveness of the Company's internal financial control systems, risk management processes, operational procedures, accounting practices, and compliance with applicable policies and statutory requirements.

Based on the recommendations of the Internal Auditors, the respective process owners undertake appropriate corrective and preventive actions to strengthen the internal control environment. Significant audit observations, if any, together with the status of corrective actions, are periodically reviewed by the Audit Committee. During the financial year under review, the Board reviewed the effectiveness of the internal financial controls and is of the opinion that the Company's internal financial control system was adequate and operating effectively. No material weaknesses or significant deficiencies were identified that could have adversely affected the Company's financial reporting or operational performance.

The Company has also established a comprehensive legal and regulatory compliance framework to ensure adherence to all applicable provisions of the Companies Act, 2013, SEBI Regulations (where applicable), and other statutory laws and regulations. The Board is satisfied that the compliance framework is adequate and has been operating effectively throughout the financial year.

MANAGEMENT DISCUSSION AND ANALYSIS REPORT

INDUSTRY STRUCTURE AND DEVELOPMENTS

The Indian economy demonstrated resilience during the financial year 2025-26 despite heightened geopolitical tensions, global trade uncertainties, volatile financial markets, and evolving macroeconomic conditions. Strong domestic demand, healthy government capital expenditure, resilient services sector growth, and sustained public investment supported overall economic activity. The Reserve Bank of India (RBI) estimated India's real GDP growth at around 6.5% for FY 2025-26, while inflation moderated during the year, creating room for calibrated monetary policy actions. The RBI accordingly adopted an accommodative monetary policy stance with calibrated reductions in the policy repo rate to support economic growth while maintaining price stability. Overall, India's macroeconomic fundamentals remained robust, supported by strong foreign exchange reserves, fiscal consolidation efforts, and a stable financial system.

The Non-Banking Financial Company (NBFC) sector continued to play a significant role in promoting financial inclusion and providing credit to sectors that remain relatively underserved by the traditional banking system. NBFCs continued to support retail borrowers, MSMEs, infrastructure, and capital market activities while complementing the formal banking sector in meeting the diverse financing requirements of the economy. The RBI continued to strengthen the regulatory framework for NBFCs by focusing on governance standards, risk management, cyber resilience, climate-related financial risks, customer protection, and technology-driven supervision under the Scale-Based Regulatory Framework, thereby enhancing the overall resilience and stability of the sector.

Investment and Credit Companies (NBFC-ICCs) continued to remain an important segment of the financial ecosystem by facilitating credit intermediation and supporting economic development through financing activities across various sectors. Well-capitalised NBFCs with prudent underwriting standards, sound governance practices, and effective risk management frameworks continued to demonstrate resilience amidst evolving market conditions. The sector is expected to benefit from increasing formalisation of the economy, growing digital adoption, expanding financial inclusion initiatives, and sustained demand for diversified credit products.

The Company continues to monitor the evolving economic and regulatory environment and remains committed to maintaining prudent lending practices, strengthening risk management systems, ensuring regulatory compliance, and leveraging emerging opportunities to deliver sustainable growth and long-term value to its stakeholders.

The Indian financial services sector continues to present significant growth opportunities, supported by sustained economic expansion, increasing financial inclusion, rapid digital transformation, regulatory reforms, and growing participation in the formal financial system. The continued focus of the Government and the Reserve Bank of India on strengthening the financial ecosystem, improving credit accessibility, and promoting digital lending and financial innovation is expected to create a favourable business environment for Non-Banking Financial Companies (NBFCs).

During the financial year ended March 31, 2026, the Company recorded Revenue from Operations of Rs. 1,857.81 lakhs as against Rs. 2,447.24 lakhs in the previous financial year, representing a decrease of approximately 24.70%. Other Income during the year stood at Rs. 6.04 lakhs, as compared to Rs. 9.53 lakhs in the previous year. Accordingly, the Total Income of the Company for the financial year 2025-26 stood at Rs. 1,863.85 lakhs, as against Rs. 2,456.77 lakhs in the financial year 2024-25. The total expenditure during the year decreased to Rs. 2,067.82 lakhs from Rs. 2,629.70 lakhs in the previous year.

The Company incurred a Loss before Tax of Rs. 203.97 lakhs during the financial year 2025-26, as compared to a loss before tax of Rs. 172.92 lakhs in the previous financial year. After considering tax expenses of Rs. 0.28 lakhs, the Company reported a Net Loss after Tax of Rs. 204.24 lakhs for the year under review, as against a net loss of Rs. 173.11 lakhs in the previous year.

The Earnings per Share (EPS) stood at (Rs. 0.85) for the financial year 2025-26 as compared to (Rs. 0.72) in the financial year 2024-25.

The overall financial performance reflects a decline in the Company's operating revenue during the year under review. Although the Company has reduced its total expenditure compared with the previous year, the reduction in revenue has resulted in an increase in the net loss for the year. The management continues to focus on improving operational efficiency, strengthening revenue generation and taking appropriate measures to improve the financial performance of the Company in the coming years.
