Aadhav Arjuna reviews civic issues, orders action on power cuts, TASMAC shops

Chennai, May 15: Tamil Nadu Minister Aadhav Arjuna on Thursday instructed electricity board officials not to carry out power cuts without prior public notice, stressing that residents must be informed about the reasons for electricity disruptions. The minister made the remarks after chairing a review meeting with government department officials and administrators from the Villivakkam constituency in Chennai. Senior officials, including Greater Chennai Corporation Commissioner Kumara Gurubaran, participated in the meeting. Speaking to reporters, Aadhav Arjuna said he reviewed long-pending civic issues in Villivakkam and directed officials to address them immediately. He noted that women in the constituency had

demanding the closure of more TASMAC liquor shops. Of the 11 TASMAC outlets in the constituency, one has already been shut following instructions from Chief Minister C. Joseph Vijay, he said. The minister also instructed police to invoke the Goondas Act against drug peddlers and stressed that CCTV cameras in police stations and public streets must remain functional at all times to strengthen public safety. Referring to frequent electricity disruptions in Chennai, he said residents often face power cuts lasting three to four hours without any announcement. He directed officials to ensure that the public is informed in advance

whenever electricity supply is interrupted. Aadhav Arjuna further ordered that desilting works of stormwater drains be completed between June and September this year, instead of beginning only during the monsoon season as in previous years. The minister emphasized that no political interference would be tolerated in government offices in his name or on behalf of the ruling Tamilaga Vettri Kazhagam (TVK). He reiterated the government's commitment to corruption-free governance and said ministers and MLAs should neither participate in nor recommend tenders. Highlighting the liquor

policy, he said the closure of TASMAC shops had resulted in a revenue loss of Rs.8,000 crore, but added that public safety and people's lives were more important than revenue. He also assured that employees affected by the closure of liquor shops would be provided alternative employment opportunities. Aadhav Arjuna also claimed that a large number of police personnel had voted for TVK through postal ballots in the recent election, alleging that they had faced pressure under the previous regime. He said the present government would work closely with government employees to ensure welfare schemes fully reach the people.

Collector warns against fake job racket in Tiruvallur

Tiruvallur, May 15: The Tiruvallur district administration has cautioned the public against falling prey to fake job advertisements and middlemen. In a statement, Tiruvallur Collector M. Prathap has advised residents not to share personal details or pay money to fraudulent agents promising employment opportunities. He noted that all services related to employment-such as registration,

renewal, unemployment assistance, additional registration, and change of address-are provided free of cost by the District Employment and Career Guidance Centres through the official portal of the Employment and Training Department. Applicants can directly access these services online through the official website: www.tnvelaivaiappu.gov.in. The Collector urged the public to use only

official platforms for job-related services and avoid being misled by fake advertisements or intermediaries.
