


Dear Sir / Madam,

This is in reference to the application submitted by Ambassador Intra Holdings Ltd (“Company”) for seeking Reclassification of Promoter Shareholders under the provisions of Regulation 31A of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

As per Regulation 31A(8)(c) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (SEBI LODR), in case of receipt of request for re-classification by the listed entity from the promoter(s) seeking re-classification, the disclosure is required to be submitted with the Stock Exchanges within 24 hours from the occurrence of the event w.r.t. to submission of the application by the Listed entity for seeking no-objection from recognized Stock Exchanges. The Company submitted the application with stock exchanges on February 13, 2026. However, it was observed that the aforesaid disclosure was submitted on June 04, 2026, whereas it should have been submitted on or before February 14, 2026.
