The Chairman of the 28th Annual General Meeting (AGM) of the Equity Shareholders of **"Shri Mahalaxmi Agricultural Developments Limited"** held on August 29, 2026, at 12:00 P.M. through Video Conferencing ("VC")/ Other Audio Visual Means ("OAVM").

I, Neha Poddar, Proprietor, Practicing Company Secretaries, Mumbai, was appointed as the Scrutinizer pursuant to Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 and pursuant to Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, for the purpose of scrutinizing the remote e-voting process and e-voting conducted during the 28th Annual General Meeting of the Company in a fair and transparent manner.

1. The remote E-Voting period remained open from 9.00 AM IST on Wednesday, August 26, 2026 up to 5.00 PM IST on Friday, August 28, 2026.
2. Electronic copy of the Annual Report 2020-21 and the Notice of the Annual General Meeting were sent to all members whose email addresses are registered with the Company / depository participant(s).
3. The voting rights were reckoned as on Friday, August 21, 2026, being the Cut-off date for the purpose of deciding the entitlements of members to cast their votes through remote e-voting at the 28th Annual General Meeting of the Company.
4. After the conclusion of the Annual General Meeting, the votes cast through remote e-voting and e-voting during the AGM were unblocked on August 29, 2026 in the presence of two witnesses who were not in the employment of the Company.
