SLP(C) No. 21688/2026

Ld. Counsel for the petitioner has taken fresh steps but has not filed fresh particulars of the sole respondent. Hence, Ld. Counsel for the petitioner to file fresh particulars within a week as last opportunity. Ld. Counsel for the petitioner, Mr. Pawan Sachdeva submits that they wish to file application for substituted service in respect of the sole

respondent. Ld. counsel to do the needful within a week, as last opportunity. If needful is done as above, issue notice/process as per rules and list on 30.10.2026, else Registry to process the matter for listing before the Hon'ble Judge in Chambers for necessary directions.
