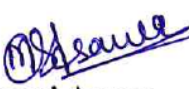

To, The Board of Directors of MALU PAPER MILLS LIMITED

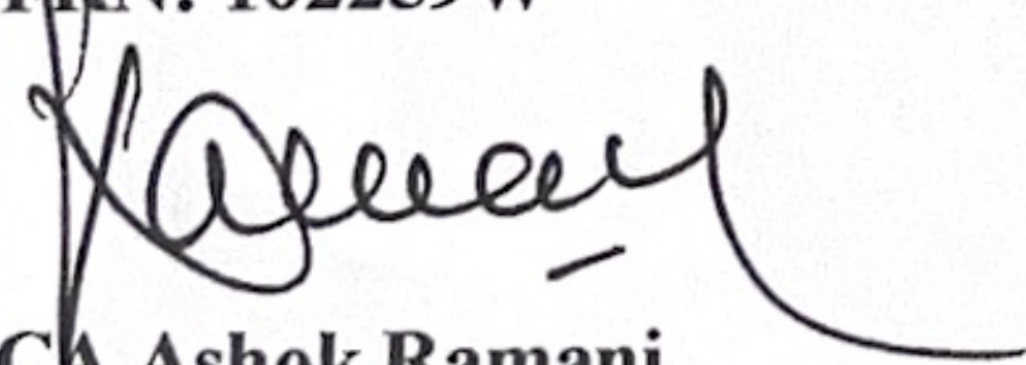

Notes on UFR :

- 1 The Unaudited Financial results for the quarter ended on June 30, 2026 of the Company have been reviewed by the Audit Committee and approved by the Board of Directors at meeting held on 23-07-2026. The Statutory Auditors have conducted a "Limited Review" of these results in terms of Regulation 33 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.
- 2 The company has officially marked a significant financial turnaround, reporting a net profit for the current quarter following a prolonged streak of consecutive quarterly losses. This turnaround highlights the successful execution of the company's operational restructuring plans and operational improvements. Like optimising product mix, the management successfully shifted focus toward high-margin paper variants, reducing dependency on low-yield commodities. While focusing quality upgrades across product lines, the company also focused on superior price realization, which allowed the company to command higher market premiums and defend margins against industry inflation.
- 3 The Company operates in only one segment i.e. paper and therefore as per Ind AS 108 segment reporting is not required.
- 4 Results for the quarter ended on June 30, 2026 are in accordance with Indian Accounting Standards ("Ind AS") as prescribed under section 133 of the Companies Act, 2013 read with relevant rules issued there under.
- 5 The figures of the quarter ended 31st March 2026 are the balancing figures between the audited figures of the full financial year and the published year to date figures for the 9 months ended on 31st December 2025.
