UPON hearing the counsel the Court made the following

O R D E R

1. Delay in reiling condoned.
2. Issue notice subject to the petitioner(s) depositing Rs. 6,00,000/- (Rupees Six Lakhs) in the Registry of this Court within a period of two weeks from today.

3. The amount so deposited shall be invested in an interest bearing Fixed Deposit, initially for a period of six months in a nationalised bank, on auto-renewal basis.

4. Pending disposal of the Transfer Petition, there shall be stay of further proceedings in the Complaint Case No. 30329 of 2024 titled as "*Eris Lifesciences Limited Vs. Krishna Pharmaceuticals*", pending before the Court of SCJ & A.C.J.M., Ahmedabad Civil Court, Ahmedabad. Ms. Kumud Lata Das, learned counsel for the petitioners, submits that warrants of arrest have been issued in Complaint Case Nos. 30329 of 2024 and 30331 of 2024 under Section 138 of Negotiable Instruments Act, 1881. In view of the submission, we direct that pending disposal of the Transfer Petition, warrants of arrest, if any, shall be suspended and no coercive steps shall be taken against the petitioners.
