Subject: Reminder to update KYC details pursuant to SEBI Master Circular No. SEBI/HO/38/13/(4)2026-MIRSD-POD/I/4298/2026 dated February 06, 2026 and SEBI Circular No. SEBI/HO/MIRSD/POD-1/P/CIR/2024/81 dated June 10, 2024

We refer to the above circulars issued by SEBI that mandate all the Listed Companies to record PAN, Address with PIN code, Mobile Number, Bank Account details and Specimen Signature of holders of physical securities. In addition, giving your Email ID and choice of Nomination are optional, however, the security holders are requested to register their email id to avail online services and register the Nomination as well. **This is applicable for all security holders holding shares in physical mode.**

1) The salient features and requirements of the circular are as follows:

In case of non-updation of PAN or Address with PIN code or Mobile Number or Bank Account Details or Specimen Signature in respect of physical folios: -

(i) The dividend will be paid to the shareholder (through electronic mode) only upon furnishing all the aforesaid details. Upon updation of these details, all the unpaid dividend with the Company (which is not transferred to IEPF) will be automatically paid to the shareholder.

(ii) Shareholders will be ELIGIBLE to lodge any grievance or avail of any service from the Company only upon furnishing all the aforesaid details.

In view of the above, we request you to submit at the earliest the KYC Form printed overleaf and Form ISR-1 duly signed along with the required supporting documents, as applicable.

The formats for registering Choice of Nomination and Updation of KYC details viz. Forms ISR-I, ISR-2, ISR-3, SH-13, SH-14 and SEBI circulars are available on our website as mentioned below:

2) Shareholder may use any ONE of the following modes for submission of the documents:

(i) In Person Verification (IPV): By producing the originals to the authorised person of the RTA, who will retain copies of the documents. Please note the registered shareholder(s) has to visit the office of the RTA for IPV and not his / her representative.

(ii) In hard copy: Shareholder may submit self-attested photocopy of the relevant documents with date.

(iii) With e-sign:

In case your email id is already registered with us, you may send the scanned copies of your KYC documents with additionally e-sign affixed on the documents at our dedicated email-id: Investor.helpdesk@in.mpms.mufig.com.
