This is to inform that the Company has received an order with reference no. F. No. GEN/ADJ/COMM/183/2026-Adjn dated 22nd May, 2026 from the office of the Principal Commissioner of Customs (Import), Air Cargo Complex, Andheri (East), Mumbai for dropping proceedings against the Company vide Show Cause Notice (SCN No. 808/2025-26 dated 06.02.2025).

The aforesaid order has confirmed that entire demand by Customs deptt. amounting to Rs. 3,52,79,282/- (Rupees Three Crores Fifty Two Lakhs Seventy Nine Thousand Two Hundred Eighty-Two) against the Company is not valid and all proceedings in the said matter have been dropped.
