**ORDER**

**COMP.APPL/74(CH)2026**

This is an Application filed under Rule 11 of the National Company Law Tribunal Rules, 2016 read with Sections 241, 242 and 244 of the Companies Act, 2013 in

CP No. 12/Chd/Hry/2026, which has been filed under Sections 241–242 of the Companies Act, 2013, seeking appropriate directions by the Applicants, Mr. Mohammadabbas Naushadali Patel and another.

2. Mr. Atul V. Sood, Advocate, appeared on behalf of the Applicants, and learned Senior Counsels Ms. Munisha Gandhi and Mr. Anand Chhibbar appeared on behalf of the Respondents Nos. 1 & 2.

3. The learned counsels prayed that Agenda Item No. 8 of the Impugned Board Meeting inter alia pertaining to “obtaining omnibus approval for related party transactions to be undertaken for FY 2026–27” and scheduled to be considered in the Board Meeting fixed for 22.05.2026, be made subject to the outcome of CP No. 12/Chd/Hry/2026.

4. We have heard the learned Senior Counsels and direct that any decision taken with respect to Agenda Item No. 8 in the Board Meeting scheduled for tomorrow, i.e., 22.05.2026, shall remain subject to the outcome of CP No. 12/Chd/Hry/2026.

5. After hearing the Ld. Counsel for the Applicant we find it appropriate to issue Notice in this Application.

**6. Issue Notice of this Petition to the Respondents** Ms. Munisha Gandhi Ld. Senior Advocate appears on behalf of R1 and Mr. Anand Chhibbar, Ld. Senior Counsel appears on behalf of R2 and accept the notice therefore, the requirements of issuance of notice to R1 and R2 is dispensed with.

7. **For remaining Respondents**, the applicant shall collect the notice from the Registry and send the same by speed post as well as by e-mail, if available, to

the Respondent attaching therewith copy of the application and the entire paper book and the copy of this order as well. The applicant shall file affidavit of service supported by postal receipt, tracking report and copy of e-mail within two weeks.

8. Reply be filed within two weeks after receipt of notice with a copy in advance to the counsel opposite. Rejoinder thereto, if any, be filed within one week thereafter, with a copy in advance to the counsel opposite.

9. List the matter before the Regular Bench on **16.07.2026**.
