Heard Mr. Rajul Shrivastava, learned counsel along with Mr. Preetam Shah, learned counsel for the claimant/petitioner and Ms. Awantika Manohar, learned counsel for respondent no.2- Insurance Company instructed by Mr. Bhupesh Sushil Rahul, Chairman-cum-Managing Director of the United India Insurance Company Limited.
2. Learned counsel for the Insurance Company, on instructions, stated that a further amount of Rs.20,00,000/- would be paid to the claimant/petitioner.
3. Learned counsel for the claimant/petitioner is also agreeable to receive the said amount.
4. Let the award be drawn up in the above terms. This amount of Rs.20,00,000/- is over and above the amount of Rs.33,28,000/- with 6% per annum interest, as ordered in the judgment of the High Court.

6. Two weeks' time is granted to draw up the settlement and the amount, as indicated above, will be paid to the claimant/petitioner within a week thereafter.
