Convening of AGM through Video Conferencing (“VC”) or any Other Audio-Visual Means (“OAVM”)

1. In terms of General Circular No. 2/2025 dated 22nd September, 2025 and other earlier circulars issued in this regard by the Ministry of Corporate Affairs (“MCA Circulars”) and in compliance with the provisions of the Companies Act, 2013 (“Act”) and the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirement) Regulation, 2015 (“Listing Regulations”), the 21st Annual General Meeting (AGM) of the Members of the Company will be held through VC/OAVM, so that members can attend and participate in the AGM from their respective locations. The deemed venue for the 21st AGM shall be the Registered Office of the Company.

The Members are therefore requested not to visit the Registered Office to attend the AGM.

Dispatch of Notice and Annual Report through electronic means

1. In compliance with the MCA Circulars read with Circular No. SEBI/ HO/CFD/PoD-2/P/CIR/2023/4 dated 5th January, 2023 and other earlier circulars issued in this regard by the Securities and Exchange Board of India (“SEBI Circulars”), Notice of the AGM along with the **Annual Report 2025-26** is being sent only through electronic mode to those Members whose name is recorded in the Register of Members / Register of Beneficial Owners as on **Friday, 4th September, 2026** and whose email addresses are registered with the Company / Registrar and Share Transfer Agent (“Bigshare Services Private Limited”/ “RTA”) or with the respective Depository Participant(s) for communication purposes to the Members, unless any member has requested for a hard copy of the same.
2. The Notice can also be accessed at the Company’s website at www.deeppoly.com and at the website of the Stock Exchange BSE Limited www.bseindia.com and at the website of CDSL (agency for providing the Remote e-Voting facility) at www.evotingindia.com.
3. Since the AGM will be held through VC/OAVM, the Route Map is not annexed in this Notice.

Proxy form

4. In terms of the MCA Circulars, physical attendance of members has been dispensed with and as such, the facility to appoint proxy to attend and cast vote for the members is not available for this AGM. Hence, **the Proxy Form and Attendance Slip are not annexed to the Notice**. However, Pursuant to Section 112 and Section 113 of the Companies Act, 2013, representatives of the President of India or the Governor of State or the Body Corporates are entitled to attend the AGM through VC/OAVM and cast their votes through e-voting.

5. The Explanatory Statement pursuant to Section 102 of the Companies Act, 2013, with respect to the special business set out in the Notice is annexed hereto.

E-Voting facility and joining of AGM through VC / OAVM

6. Pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 (as amended) and Regulation 44 of SEBI (Listing Obligations & Disclosure Requirements) Regulations 2015 (as amended), and the MCA Circulars, the Company is providing facility of remote e-voting to its Members in respect of the business to be transacted at the 21th AGM. Shareholders are requested to refer Page No.11 to 16 for detailed procedure for e-Voting and participation in the AGM through VC/OAVM. The detailed procedure for participation in the meeting through VC/OAVM is also available at the Company's website www.deeppoly.com
7. For this purpose, the Company has entered into an agreement with Central Depository Services (India) Limited ('CDSL') for facilitating voting through electronic means, as the authorized e-Voting's agency. The facility of casting votes by a member using remote e-voting as well as the e-voting system on the date of the AGM will be provided by CDSL.
8. In view of MCA & SEBI Circulars, printed copy of the Annual Report (including Notice) is not being sent to the Members.
9. AGM convened through VC/OAVM is in compliance with applicable provisions of the Companies Act, 2013 read with MCA & SEBI Circulars as stated above.
10. The voting period **begins on Saturday, 26th September, 2026 at 9.00 a.m.** and **ends on Tuesday, 29th September, 2026 at 5.00 p.m.** During this period shareholders of the Company, holding shares either in physical form or in dematerialized form, as on the **cut-off date Wednesday, 23rd September, 2026** may cast their vote electronically. The e-voting module shall be disabled by CDSL for voting thereafter.
11. Shareholders who have already voted prior to the meeting date would not be entitled to vote at the meeting venue.
12. The Members can join the AGM in the VC/OAVM mode 15 minutes before and after the scheduled time of the commencement of the Meeting by following the procedure mentioned in the Notice. The facility of participation at the AGM through VC/OAVM will be made available to at least 1000 members on first come first served basis. This will not include large Shareholders (Shareholders holding 2% or more shareholding), Promoters, Institutional Investors, Directors, Key Managerial Personnel, the Chairpersons of the Audit Committee, Nomination and Remuneration Committee and Stakeholders Relationship Committee, Auditors etc. who are allowed to attend the AGM without restriction on account of first come first served basis.

Cut-off Date Voting

14. The voting rights of the members shall be in proportion to their share in the paid-up equity share capital of the Company as on the cut-off date i.e. **Wednesday, 23rd September, 2025.**

Quorum

15. The attendance of Members attending the AGM through VC/OAVM will be counted for the purpose of reckoning quorum under Section 103 of the Companies Act, 2013.

Scrutinizer for conducting E-Voting

16. The Company has appointed **Mr. Utkarsh Shah proprietor of M/s. Utkarsh Shah & Co. (Membership No. F13259, COP:21815), Practicing Company Secretary, Ahmedabad** to act as the Scrutinizer for conducting the remote e-voting process as well as the e-voting system on the date of the AGM, in a fair and transparent manner.

Voting Result

17. The voting results shall be declared within two working days from the conclusion time of the Meeting. The results declared along with the Scrutinizer's Report will be placed on the website of the Company at immediately after the result is declared by the Chairman or any other person authorised by the him in this regard and will simultaneously be sent to BSE Limited and where equity shares of the Company are listed.

PREVENT FRAUDULENT TRANSACTIONS

18. To prevent fraudulent transactions, members are advised to exercise due diligence and notify the Company of any change in address or demise of any member as soon as possible. Members are also advised not to leave their demat account(s) dormant for long. Periodic statement of holdings should be obtained from the concerned Depository Participant and holdings should be verified.
19. The Securities and Exchange Board of India (SEBI) has mandated the submission of Permanent Account Number (PAN) by every participant in securities market. Members holding shares in electronic form are, therefore, requested to submit the PAN to their Depository Participants with whom they are maintaining their demat accounts.

M/s. S.N. SHAH & ASSOCIATES have confirmed their eligibility and qualification required under Section 139, 141 and other applicable provisions of the Companies Act, 2013 and rules made thereunder (including any statutory modification(s) or re-enactment(s) thereof for the time being in force). As required under Regulation 33(d) of SEBI (LODR) Regulations, 2015 the Auditors have confirmed that they hold a valid certificate issued by the Peer Review Board of the Institute of Chartered Accountants of India.

The Notes to the Financial Statements referred in the Auditors' Report are self-explanatory except following qualification:

Qualification	Clarification from Board of Directors
The Current Financial Assets: Trade Receivables reported in the financial results include trade receivable of Rs. 308.06 Lacs outstanding in respect of which the company has initiated legal procedure for recovery. The company has considered these outstanding trade receivables as good for recovery at the value at which they have been stated in the financial statement. In our opinion, the necessary provision for doubtful debts should have been made by the company. Non-provision of such doubtful debts of Rs. 308.06 Lacs has resulted in an overstatement of profit and an overstatement of the outstanding balance of current trade receivables and shareholder's fund by Rs. 308.06 Lacs.	The company has taken appropriate measures for recovery from respective parties and taken legal recourse. However, no amount could be recovered from the party. Considering the efforts made for recovery and legal action taken the management is hopeful of recovery in coming financial year. However, if it becomes reasonably certain that it is not possible to recover from the parties then management will consider to make appropriate provision for doubtful debt or may write off as bad debts.
The monetary items denominated in foreign currencies outstanding as at the end of the reporting period, have not been restated by the company at the exchange rates prevailing as at the end of the reporting period in accordance with Ind-AS-21 "The Effects of Changes in Foreign Exchange Rates. Non-restatement of foreign currencies denominated financial items have resulted into overstatement/understatement of respective foreign currency denominated financial items as at the end of the financial year and consequent profits for the year and accumulated balances of profits as at the end of the financial year.	The net effect of restatement of foreign currency denominated assets and liabilities as at the end of the year was not material enough to have a significant effect on profitability for the year and net worth of the company as at the end of the year. And hence management deemed it appropriate not to restate outstanding balance of foreign currency denominated assets and liabilities. However, the management has considered non-compliance and will take appropriate action in the coming year to restate foreign currency denominated assets and liabilities in compliance with Ind-AS-21. Though management has not restated foreign currency denominated assets and liabilities in compliance with Ind-AS-21 on the assumption of material effect on profitability and net worth in our opinion. The Foreign currency denominated assets and liabilities should have been restated.

Secretarial Auditors:

Pursuant to the provisions of Section 204 of the Companies Act, 2013 read with Rule 9 of the Companies (Appointment and Remuneration of Managerial Personnel) Rules 2014, your Company had engaged the services of **M/s. Utkarsh Shah & Co. (Membership No.F12526, COP: 26241)**, a firm of Company Secretaries in Practice to undertake the Secretarial Audit of the Company for the financial year ended 31st March, 2026. The Secretarial Audit Report in **Form No. MR - 3** for the financial year ended 31st March,

2025 is annexed to this report as '**Annexure - C**'.

Pursuant to Section 134(3)(f)(ii) of the Companies Act, 2013, the Board's explanations to the qualifications, reservations, and observations made by the Secretary in Practice in the Secretarial Audit Report for the year under review are as follows:

1. Non-implementation of System Driven Disclosures (SDD)

The Board notes the observation regarding non-implementation of the System Driven Disclosures mechanism under Regulation 7(2) read with Schedule VII of the SEBI (PIT) Regulations, 2015. The Company acknowledges the lapse and states that it has already initiated the process of coordinating with its Registrar and Transfer Agent (RTA) and the Depositories to enable the SDD mechanism at the earliest. The Company reaffirms its commitment to full compliance with the applicable SEBI circulars on this matter going forward.

2. Non-publication of financial results in newspapers

The Board notes the delay/non-publication of the Company's financial results in newspapers within the stipulated timelines as required under Regulation 47 of the SEBI (LODR) Regulations, 2015. This was on account of inadvertent oversight/administrative constraints during the relevant period. The Company has since strengthened its internal compliance calendar and coordination with the Company Secretary and publication agencies to ensure timely publication of financial results in future, in accordance with the prescribed timelines.

3. Delay in obtaining shareholders' approval for appointment of Mr. Niranjana Jain, as Independent Director.

The Board notes the observation regarding the delay in obtaining shareholders' approval for the appointment of Mr. Niranjana Navratnam Jain (DIN: 00282842) as an Additional (Independent) Director within the timeline prescribed under Regulation 17(1C) of the SEBI (LODR) Regulations, 2015, i.e., on or before 18/03/2026. The delay was on account of the timing of the Company's general meetings not coinciding with the prescribed window and was not intentional or motivated by any mala fide intent. The Company confirms that the appointment of Mr. Niranjana Navratnam Jain (DIN: 00282842) has since been placed before the shareholders for approval at the ensuing General Meeting, and the Company shall be more diligent in ensuring adherence to such statutory timelines in future.

Internal Auditor

The Internal Auditor has carried out the periodic internal audit as per the Scope Work.

Frauds Reported by Auditors

During the year under review, no instance of fraud in the Company was reported by the Auditors.

1. COMPLIANCE OF CORPORATE GOVERNANCE REPORT

Your directors' present the Company's Report on Corporate Governance for the Financial Year ended 31st March, 2026 in compliance with the provisions of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('Listing Regulations').

2. THE COMPANY'S PHILOSOPHY ON CORPORATE GOVERNANCE

Corporate Governance is a synthesis of business elements & ethics encompassing accountability, transparency, fairness, responsibility, risk management, sustainability & so on, that not only enhances the organizational growth and values but also generates trust among all its shareholders and other stakeholders.

(i) INDEPENDENT DIRECTORS: -

Independent Directors play an important role in the governance processes of the Board. They bring with them their expertise and experience for fruitful discussions and deliberations at the Board. This betters the decision-making process at the Board.

The Independent Directors have been appointed for a fixed term of 5 (five) years from their respective dates of appointment with an option to retire from the office at any time during the term of appointment. Their appointment has been approved by the Members of the Company. The Independent Directors have confirmed that they meet with the criteria of independence laid down under the Act, the Code and Listing Regulations.

(j) LIMIT ON NUMBER OF DIRECTORSHIP: -

None of the Director of the Company is holding Directorship in more than 10 Public Limited Companies and none of an Independent Directors serve as an Independent Director in more than 7 (Seven) Listed Companies.

None of the Director of the Company is appointed in more than 10 Committees or is acting as Chairman in more than 5 (Five) Committees across all the Companies in which he is a director.

(k) SEPARATE MEETING OF INDEPENDENT DIRECTOR: -

In accordance with provisions of Regulation 25(3) of the SEBI Listing Regulation read with Schedule IV of the Companies Act, 2013 the Independent Directors separately met on 5th February 2026, without the attendance of Non-Independent Directors and Management Personnel of the Company. The meeting was held with the objective of reviewing the performance of Non-Independent Directors, the Board as a whole and the Chairman of the Company.

They will also have a separate meeting with the Chairman of the Board, to discuss issues and concerns, if any.

(l) ISSUANCE OF LETTER OF APPOINTMENT: -

The Independent Directors are given a formal appointment letter inter alia containing the term of appointment, role, duties and responsibilities, time commitment, remuneration, insurance, code of conduct, training and development, performance evaluation process, disclosure, confidentiality, etc.

(m) BOARD'S ROLE: -

The Board's role is to:

- (1) provide entrepreneurial leadership, set strategic objectives, and ensure that the necessary financial and human resources are in place for the Company to meet its objectives;
- (2) establish a framework of prudent and effective controls which enables risks to be assessed and managed, including safeguarding of shareholders' interests and the Company's assets;
- (3) identify the key stakeholder groups and recognize that their perceptions which may affect the Company's reputation;
- (4) set the Company's values and standards (including ethical standards), and ensure that obligations to shareholders and other stakeholders are understood and met;
- (5) Consider sustainability issues, e.g. environmental, governance and social factors, as part of its strategic formulations
- (6) review and approve the recommended remuneration framework and packages for the Board and key management personnel;
- (7) review the performance of the Board, set the criteria for selection of directors and to nominate directors for shareholders' approval; and
- (8) Ensure that communications with shareholders are accurate, adequate and timely.

To assist the Board in the execution of its responsibilities, the Board has constituted various Board committees, namely the Audit Committee, Nomination and Remuneration Committee, Shareholders/ Investors Grievances Committee, Corporate Social Responsibility Committee and Risk Management Committee.

The role and function of each committee is described in subsequent sections in this report. While these committees are delegated with certain responsibilities, the ultimate responsibility for the final decision lies with the entire Board.

(n) CHAIRMAN'S RESPONSIBILITY: -

- vi. To encourage constructive relations within the Board and between the Board and management;
- vii. To facilitate the effective contribution of non-executive directors in particular; and
- viii. To promote high standards of corporate governance.

(o) AGENDA FOR BOARD MEETING: -

Agenda and Notes on Agenda are circulated to the Directors at least 7 days in advance, in the defined Agenda format. All material information is incorporated in the Agenda papers for facilitating meaningful discussion.

The Board business generally includes consideration of important corporate actions and events including: -

- Quarterly and Annual Financial results announcements;
- Oversight of the performance of the business;
- Declaration of Dividends, if any;
- Review of the functioning of the Committees; and
- Other strategic, transactional and governance matters as required under the Act, Listing Regulations.

The followings are generally tabled for information, review and approval of the Board:

- Annual Operating Plans & Budgets;
- The information on recruitment and remuneration of Senior Officers just below the level of Board of Directors, including Appointment or Removal of Chief Financial Officer and the Company Secretary;
- Show cause Notices, Demand Notices, Prosecution Notices and Penalty Notices, which are materially important;
- Fatal or Serious accidents, dangerous occurrences, any material effluent or pollution problems;
- Any issue, which involves possible public or product liability claims of substantial nature, including any judgement or order which, may have passed strictures on the conduct of the listed entity or taken an adverse view regarding another enterprise that may have negative implications on the entity;
- Details of any Joint Venture or Collaboration Agreement;
- Transactions that involve substantial payment towards goodwill, brand equity, or intellectual property;
- Significant labour problems and their proposed solutions;
- Sale of investments, subsidiaries, assets which are material in nature and not in normal course of business;
- Quarterly details of foreign exchange exposures and the steps taken by management to limit the risks of adverse exchange rate movement, if material;

- Non-compliance of any regulatory, statutory or listing requirements and shareholders service such as non-payment of dividend, delay in share transfer etc.;

(q) POST MEETING FOLLOW-UP MECHANISM: -

The Company has an effective post meeting follow-up, review and reporting process mechanism for the decisions taken by the Board/Committees. Important decisions taken at the Board/Committee meetings are communicated to the concerned Functional Heads promptly. Action Taken Report on previous meeting(s) is placed at the immediately succeeding meeting of the Board/Committee for noting by the Board/Committee members.

(r) COMPLIANCE REPORT: -

While preparing the Agenda adequate care is taken to ensure adherence to all applicable laws and regulations including the Companies Act, 2013 read with rules framed thereunder and Secretarial standard issued by ICSI. The Board periodically reviews all statutory compliance reports of all laws applicable to the Company.

(s) ACCESS TO INFORMATION: -

The Directors have separate and independent access to the Company's management and the Company Secretary at all times. The Directors are entitled to request from management and should be provided with such information as needed to make informed decisions in a timely manner. The Board is informed of all material events and transactions as and when they occurred.

Should the Directors, whether individually or collectively, require independent professional advice; such professionals will be selected with the approval of the Chairman of the respective Committees requiring such advice, and is appointed at the expenses of the Company.

The Company Secretary attends all the Board and Board Committee meetings and attends to the Corporate Secretarial Administration matters, ensuring that the Board procedures are followed and that applicable rules and regulations are complied with.

(t) CHAIRMAN AND MANAGING DIRECTOR: -

Mr. Rameshbhai Bhimjibhai Patel – Chairman and Managing Director, leads the Board to ensure effectiveness of all aspects of its role. The Chairman sets the meeting agenda and ensures that the Directors are provided with complete, adequate and timely information. The Chairman ensures that discussions and deliberations are effective and promote a culture of openness and debate at Board meetings. The Chairman encourages constructive relations within the Board and between the Board and Management. The Chairman also facilitates the effective contribution of the Non-Executive Directors and promotes high standards of corporate governance. He is responsible for executing the strategic plans set out by the Board and ensures that the Directors are regularly kept updated and informed of the business.

7. reviewing and monitoring the auditor's independence and performance, and effectiveness of audit process;
8. approval or any subsequent modification of transactions of the listed entity with related parties;
9. scrutiny of inter-corporate loans and investments;
10. valuation of undertakings or assets of the listed entity, wherever it is necessary;

16. recommend to the Board a framework of remuneration and specific remuneration packages for all Directors of the Company, Key Managerial Personnel (KMP) and other Senior Management Personnel;
17. review the service contracts of the Executive Directors;
18. carry out its duties in the manner that it deems expedient, subject always to any regulations or restrictions that may be imposed upon the NRC by the Board of Directors from time to time;
19. reviewing and enhancing on the compensation structure to incentive performance base for key executives;
20. ensure that the remuneration packages are comparable within the industry and comparable Companies and include a performance-related element coupled with appropriate and meaningful measures of assessing individual Executive Director's performance.
21. facilitate the transparency, accountability and reasonableness of the remuneration of Director and Senior Management Personnel.
22. recommend to the Board a framework of remuneration for the Directors,
23. all aspects of remuneration, including but not limited to Directors' fees, salaries, allowances, bonuses, options and benefits-in-kind shall be covered by the Nomination and Remuneration Committee.

MANAGEMENT DISCUSSION AND ANALYSIS REPORT

Financial Year 2025-26

A. Overview of the Global Economy

The global chemical industry enters FY 2025-26 in a phase of gradual stabilisation rather than a sharp rebound. After growth of approximately 1.9% in 2025, global chemical production growth is projected at around 2% for 2026, as the industry continues to work through a prolonged downcycle marked by overcapacity, soft end-market demand and geopolitical and trade-related uncertainty. Industry bodies such as the American Chemistry Council and Cefic note that while commodity chemicals continue to face pressure from aggressive capacity additions (particularly out of China), specialty chemicals and segments tied to clean technology, semiconductors and artificial intelligence are expected to see a relatively stronger recovery.

Persistent overcapacity in basic chemicals continues to weigh on operating rates and margins, especially in regions with higher energy and feedstock costs such as Europe. In response, global chemical companies are prioritising cash flow, restructuring portfolios, rationalising low-return assets and shifting investment toward higher-margin specialty chemicals. North America is expected to see a modest recovery from around mid-2026, while Europe is expected to move from contraction in 2025 to marginal growth in 2026, aided by fiscal stimulus and infrastructure spending in select economies.

Geopolitical tensions, including the ongoing conflict in Europe and periodic flare-ups in West Asia, continue to inject volatility into energy and feedstock prices, and trade policy shifts (including tariff actions by major economies) remain a key swing factor for global trade flows. Even so, easing inflationary pressure across most advanced economies, resilient consumer sentiment and continuing investment in AI-linked and sustainability-linked chemistries provide a cautiously constructive backdrop for the year.

B. Overview of the Indian Economy

India remains the fastest-growing major economy in the world through FY 2025-26. Real GDP growth for FY 2025-26 has been placed in the range of 7.3%-7.7% by the Reserve Bank of India, the IMF and other multilateral agencies, supported by resilient private consumption, sustained infrastructure spending, GST reform benefits and easing inflation, which has remained comfortably within the RBI's 2%-6% tolerance band. Growth for FY 2026-27 is expected to moderate to a still-robust 6.4%-6.9% as some of the current cyclical tailwinds fade, even as India continues to outpace other large economies within the G20.

Within this backdrop, India's chemical industry continues to be one of the standout performers. The domestic chemicals and petrochemicals sector is now estimated at roughly USD 200-240 billion and has been growing at a CAGR in the 9%-12% range over the last several years, comfortably ahead of general industrial growth. Specialty chemicals, which form a growing share of the domestic market, continue to expand faster than bulk chemicals, driven by demand from agrochemicals, pharmaceuticals, personal care, electronics and automotive end-uses, as well as global supply-chain diversification away from China. Government initiatives, including production-linked incentive schemes, planned dedicated chemical parks under the Union Budget 2026-27, and continued 100% FDI under the automatic route for most chemical categories, are expected to further support capacity addition and export competitiveness over the course of the year.

C. Outlook

The outlook for FY 2025-26 is one of steady, broad-based improvement rather than a sharp cyclical upswing. Global trade is expected to remain a key growth engine, though growth in merchandise trade volumes will continue to be shaped by tariff actions, regional realignment of supply chains and the pace of monetary easing across major economies. Central banks, including the RBI, are expected to maintain a broadly accommodative-to-neutral stance as inflation stays contained, which should support consumption and

investment demand through the year.

For the Company's core markets, continuing capacity additions in India's plastics, packaging and textile value chains, rising per-capita plastic consumption, and the increasing shift toward sustainable and bio-degradable materials are expected to sustain demand for masterbatches and compounds. The pace and effectiveness of policy support, together with the trajectory of crude-linked input costs, will remain the key variables to watch over the year.

D. Industry Structure and Developments

The Company continues to serve customers in more than 25 countries worldwide. Masterbatch — comprising pigments and additives used to impart colour and specific performance characteristics to end products — remains a vital input for the global plastics industry. The Company continues to be recognised as a brand and market leader in the manufacture of masterbatches, with a presence across practically every segment: White, Black, Colour, Additive and Antifab (filler) masterbatches, spanning plastics and textile applications including household goods, furniture, bulk and film packaging, roof coverings, flexible and rigid packaging (containers and pouches), non-woven bags, and PET (POY/PSF) fibre masterbatch for textile and yarn applications. The Company also continues to contribute to environmental sustainability through its range of bio-degradable raw materials aimed at helping manufacturers reduce plastic waste — a differentiator that few competitors match across all these categories simultaneously.

The Company's strong application-support capability continues to enable close coordination with customers on new product development, giving it a deep understanding of evolving customer requirements. The use of masterbatches in the production process continues to offer customers cost-effectiveness, ease of use, consistent colour outcomes and a cleaner production environment.

According to the Indian Brand Equity Foundation (IBEF), India's plastics industry remains one of the country's most significant manufacturing sectors, with per-capita plastic consumption continuing to rise. The industry comprises over 50,000 processing units employing more than 50 lakh people, and contributes an estimated ₹3.5 lakh crore to the Indian economy, with 80%-90% of manufacturing units in the small and medium enterprise segment. The sector remains highly fragmented, with a large unorganised base and a smaller organised segment. Government initiatives such as Atmanirbhar Bharat, Make in India, Swachh Bharat and Digital India continue to support growth in plastics production, with industry estimates continuing to project substantial revenue expansion for the sector by 2027.

E. Opportunities and Threats

Opportunities:

- **Network area:** The Company continues to benefit from a diverse product portfolio and a wide network for sales, marketing and distribution across fill volumes and geographies.
- **Management:** An experienced management team and well-qualified senior executives continue to guide the Company's strategy and execution.
- **Alternative fuel utilisation:** Regions with abundant alternative fuels such as coal can support increased chemical and petrochemical production through coal-gasification technology, helping meet rising petrochemical demand.
- **Market:** A stable revenue base from manufacturing and institutional sales, together with a wide online and offline distribution network, continues to support the Company's push into new domestic and export markets.
- **Technological developments:** Continuing adoption of new technologies across the chemicals value chain — including growing use of blockchain for supply-chain transparency and time-specific product traceability — creates both opportunities and competitive risks.

Threats:

- High competition: The plastics industry remains highly competitive, with both organised and unorganised players intensifying capacity build-up, making market-share gains harder to achieve. The Company continues to respond through regular market reviews and new product development.
- Manpower: Sourcing skilled and competent manpower for the plastics industry remains a common challenge, irrespective of company size or brand.
- Price undercutting: Intense competition continues to result in price undercutting by competitors seeking to protect market share, pressuring industry margins.
- New entrants: Continued entry of new organised players is expected to further intensify competition within the organised segment.

F. Segment-wise or Product-wise Performance

The Company continues to operate in a single reportable segment — the manufacturing of Masterbatch and Polymer compounds.

Future Outlook:

For FY 2025-26, the Company's outlook is to continue expanding its product range to meet evolving requirements in both Indian and global markets, with continued emphasis on specialty and sustainable (bio-degradable) product lines.

G. Risks and Concerns

The polymer industry continues to carry a specific set of risk characteristics that require careful evaluation and mitigation. The Company continues to operate a proactive Risk Management System covering the entire process — from capital investment decisions to monitoring of competitor activity and new market entrants. Continual reforms and sustained emphasis on technological development are expected to further reduce the Company's exposure to these risks over the course of the year.

H. Material Developments in Human Resources / Industrial Relations

Industrial relations are expected to remain harmonious and cordial through FY 2025-26. The Company continues to regard its human resources as its most valuable asset and remains committed to attracting, developing and retaining talent through a positive, engaging work environment and systematic training programmes. Cooperation and contribution from employees at all levels continue to be recognised and supported by management.

Internal Control Systems and Their Adequacy

The Company continues to maintain an independent Internal Audit function supported by a well-established risk management framework, operating under the Internal Audit Charter approved by the Audit Committee. The Company continues to engage a reputable external firm to support the Internal Audit function in carrying out audit reviews.

The Audit Committee continues to meet quarterly to review Internal Audit reports, follow up on action plans for past significant audit issues and monitor compliance with the audit plan, with the Chairperson holding periodic one-on-one meetings with the Chief Internal Auditor on key matters.

Additional control measures continued during the year include: budgets prepared for all operational levels; approval by the Commercial Director for any material variance from budget; approval by the Managing Director for any major policy change; and review of any deficiency in achieving targets at management meetings.

Discussion on Financial Performance with Respect to Operational Performance

The financial performance of the Company for Financial Year 2025-26 is set out in the Directors' Report accompanying this Annual Report.

Material Developments in Human Resources / Industrial Relations, Including Number of People Employed

The cordial employer-employee relationship has continued through the year under review, with the Company continuing to accord special attention to its human resources.

QUALIFIED OPINION

We have audited the standalone financial statements of **DEEP POLYMERS** ("the Company"), which comprise the Standalone Balance Sheet as at March 31, 2026, the Standalone Statement of Profit and Loss (Including Other Comprehensive Income), the Standalone Statement of Changes In Equity and the Standalone Statement of Cash Flows for the year then ended and notes to the standalone financial statements, including a summary of material accounting policies and other explanatory information (hereinafter referred to as "Standalone Financial Statements").

In our opinion and to the best of our information and according to the explanations given to us, the aforesaid standalone financial statements except "for effect of compliance of Ind-AS 21 regarding restatement of foreign currency Assets and liability as at the end of the year and the effect for the possible effects of matter described in the basis for qualified opinion" give the information required by the Companies Act, 2013 ("Act") in the manner so required and give a true and fair view in conformity with the accounting principles generally accepted in India including Indian Accounting Standards ('Ind AS') specified under Section 133 of the Act read with the Companies (Indian Accounting Standards) Rules, 2015 as amended, of the state of affairs of the Company as at March 31, 2026, and its profit and other comprehensive income, changes in equity and its cash flows for the year ended on that date.

BASIS FOR QUALIFIED OPINION:

1. The Current Financial Assets: Trade Receivables reported in the financial results include trade receivable of Rs. 308.06 Lacs outstanding in respect of which the company has initiated legal procedure for recovery. The company has considered these outstanding trade receivables as good for recovery at the value at which they have been stated in the financial statement. In our opinion, the necessary provision for doubtful debts should have been made by the company. Non-provision of such doubtful debts of Rs. 308.06 Lacs has resulted in an overstatement of profit and an overstatement of the outstanding balance of current trade receivables and shareholder's fund by Rs. 308.06 Lacs.
2. The monetary items denominated in foreign currencies outstanding as at the end of the reporting period, have not been restated by the company at the exchange rates prevailing as at the end of the reporting period in accordance with Ind-AS-21 "The Effects of Changes in Foreign Exchange Rates. Non-restatement of foreign currencies denominated financial items have resulted into overstatement/understatement of respective foreign currency denominated financial items as at the end of the financial year and consequent profits for the year and accumulated balances of profits as at the end of the financial year.

We conducted our audit in accordance with the Standards on Auditing (SAs) specified under section 143(10) of the Act. Our responsibilities under those Standards are further described in the Auditor's Responsibilities for the Audit of the Standalone Financial Statements section of our report.

We are independent of the Company in accordance with the Code of Ethics issued by the Institute of Chartered Accountants of India together with the ethical requirements that are relevant to our audit of the standalone financial statements under the provisions of the Act and the Rules thereunder, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the Code of Ethics. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

KEY AUDIT MATTERS:

CORPORATE INFORMATION:	
DEEP POLYMERS LIMITED is a public company domiciled in India and is incorporated under the provisions of the Companies Act applicable in India. The registered office of the company is located at Gandhinagar, Gujarat, India. The shares of the company are listed in one recognized stock exchanges in India i.e. the Bombay Stock Exchange Limited ('BSE') The company is engaged in the manufacturing of Masterbatches since 1992 and Antifab Filler Masterbatches since 2004.	
NOTE 1: MATERIAL ACCOUNTING POLICIES:	
I	BASIS OF PREPARATION & PRESENTATION OF FINANCIAL STATEMENTS
a)	Accounting Conventions: The financial statements of the Company have been prepared in accordance with Indian Accounting Standards (Ind AS) notified under the Companies (Indian Accounting Standards) Rules, 2015 and with Companies (Indian Accounting Standards) (Amendment) Rules, 2017 and such further amendments as notified and as applicable and comply in all material aspects with the relevant provisions of the Companies Act, 2013 to the extent applicable to it. The Financial Statements have been prepared on a historical cost basis except the following assets and liabilities which have been measured at fair values: • Certain Financial Assets and Liabilities that are measured at Fair Value and • Defined Benefit Plans that are measured at Fair Value The accounting policies are applied consistently to all the periods reported in the financial statements unless otherwise stated.
b)	Use of Estimates: The preparation of financial statements requires management to make estimates and assumptions that are believed to be reasonable under the circumstances and such estimates and assumptions may affect the reported amount of assets and liabilities, classification of assets and liabilities into non-current and current and disclosures relating to contingent liabilities as at the date of financial statements and the reported amounts of income and expenses during the reporting period. Although the financial statements have been prepared based on the management's best knowledge of current events and procedures/actions, the actual results may differ on the final outcome of the matter/transaction to which the estimates relate.

c)	1. Property, Plant and Equipment (PPE):
	The cost of an item of property, plant and equipment is recognized as an asset if, and only if: (a) it is probable that future economic benefits associated with the item will flow to the company; and (b) the cost of the item can be measured reliably. The acquisition of property, plant and equipment, directly increasing the future economic benefits of any particular existing item of property, plant and equipment, which are necessary for the Company to obtain the future economic benefits from its other assets, are recognized as Property, Plant and Equipment. The Freehold land is carried/stated at historical cost/cost of acquisition. The other items of Property, Plant and Equipment are stated at cost of acquisition/construction (less Accumulated Depreciation and Impairment, if any). The cost of Property, Plant and Equipment comprises of their purchase prices including freight, duties, taxes or levies, directly attributable to cost of bringing the assets to their working conditions for their intended use. The Company capitalises its Property, Plant and Equipment at a value net of GST/Other Tax Credits received/receivable during the year in respect of eligible item of Property, Plant and Equipment. Subsequent costs are included in the carrying amount of respective Property, Plant and Equipment or recognized as separate assets as appropriate, only if such costs increase the future economic benefits from the existing items beyond their previously assessed standard of performance and cost of such items can be measured reliably. Machinery spares that meet the definition of Property, Plant & Equipment are capitalised and depreciated over the useful life of the principal item of an asset. All other repair and maintenance costs, including regular servicing, are recognised in the Statement of Profit and Loss as incurred. The items of Property, Plant and Equipment that are under construction/erection or not fully acquired and therefore not available for productive use are classified as “Capital Work in Progress” under Building, Furniture and fixture, Property, Plant and Equipment and solar and are/will be transferred to respective item of Building, Furniture and fixture, Property, Plant and Equipment and solar plant on completion of the construction/erection/acquisition activities. Advances given to acquire property, plant and equipment are stated as non-current assets and

subsequently transferred to respective Building, Furniture and fixture, Property, Plant and Equipment and solar plant and CWIP on acquisition of related assets.

The carrying amounts of items of Property, Plant & Equipment have been eliminated from the books of account on disposal and the profits/(losses) arising from the disposal are recognised in the Statement of Profit and Loss of the period.

Old trucks were sold during the current financial year. The sale value is subtracted straight from the cost since there are insufficient specifics regarding the cost and depreciation thereon.

3. Right-of-use Assets:

The ROU asset is initially measured at cost, comprising the initial measurement of the lease liability, lease payments made at or before the commencement date (less any lease incentives received), initial direct costs incurred, and an estimate of costs to dismantle and remove the underlying asset or restore the site.

In cases where lease payments are made fully in advance at or before the commencement date and no lease liability exists on initial recognition, the cost of the right-of-use asset includes such prepaid lease payments together with any initial direct costs and estimated restoration costs, if applicable.

Subsequently, the ROU asset is measured at cost less accumulated depreciation and accumulated impairment losses, if any. Depreciation is recognised on a straight-line basis over the shorter of the lease

	term and the useful life of the underlying asset, unless ownership of the underlying asset is expected to transfer to the Company at the end of the lease term. The Company assesses the ROU asset for impairment in accordance with the requirements of Indian Accounting Standard (Ind AS) 36.
	4. Investment Properties:
	The property that is held by the company for rental yields or for capital appreciation for the relevant period is classified as investment property. The investment property is initially recognized at cost and subsequently carried at cost less accumulated depreciation and accumulated impairment losses, if any. Subsequent expenditures on such assets are capitalized to the asset's carrying value only when it is probable that future economic benefits associated with the expenditure will flow to the company or such cost are incurred to comply with regulatory requirements or have been incurred in connection with continued use of such assets and cost of such items can be measured reliably. All other repairs and maintenance cost are expensed as and when incurred.
	5. Intangible Assets:
	The Intangible Assets of Accounting Software, Server Software, Website Development resulting in future economic benefits have been recognised at their cost of acquisition and subsequently are carried at cost less accumulated amortisation and accumulated impairment losses, if any. On the basis of the availability of these assets for their intended use, relevant contractual agreements and technological changes that may affect the usefulness of these assets, the useful lives of these assets have been assumed to be of six years from the date of their acquisition. The estimated useful life is reviewed annually by the management of the company.
	6. Depreciation & Amortization:
	The Depreciation on tangible items of Property, Plant and Equipment is provided on written down value method for the period of acquisition/construction i.e. from the period from which such assets were available for their intended use on pro-rata basis on the basis of useful life of each of the items of Property, Plant and Equipment as per Schedule II of the Companies Act, 2013 and in the manner specified in Schedule II of the Companies Act, 2013 except freehold land and other related development on that land. The intangible assets have been amortized on pro-rata basis over period of their estimated useful lives on written down value basis i.e. @ 39.30% assuming useful life of six years.

d)	Inventories The Inventories of Raw Materials have been valued at cost. Finished Goods have been valued at cost or net realisable value whichever is lower. Costs in respect of all items of inventories have been computed on FIFO method which is considered upon lot used for manufacturing. The cost of Raw Materials comprises of the purchase price including duties and taxes, freight inwards and other expenditure directly attributable to the acquisition. The purchase price does not include GST/Other Tax credits availed of by the Company during the year. The cost of Finished Goods includes cost of conversion and other costs incurred in bringing the inventories to their present location and conditions. The Finished Goods are valued at cost after availing of GST/Other Tax credits on input materials.
e)	Revenue Recognition: Revenue is measured at the fair value of the consideration received or receivable from the customers/parties net of returns, rebates, value added taxes and discount to the customers and amounts collected on behalf of third parties. The Revenue is recognised to the extent that it is probable that the economic benefits will flow to the Company and the revenue can be measured reliably, regardless of when the payment is being made. Sale of Goods: The revenue from the sale of goods is recognized at transaction price when the company had transferred the property in Goods to the buyer for a price and all significant risks and rewards of ownership had been transferred to the buyer and no significant uncertainty existed as to the amount of consideration that would be derived from such sale. The recognition event is usually the dispatch of goods to the buyer such that the Company retains no effective control over the goods dispatched. Interest Income: Income from investments and deposits, where appropriate, is taken into revenue in full on declaration or accrual on time basis and tax deducted at source thereon is treated as advance tax. The interest income from a financial asset is recognized when it is probable that the economic benefits will flow to the company and the amount interest income can be measured reliably.

	Dividend Income: Dividend income is recognized in statement of profit and loss only when the right to receive payment is established. Export Incentives: Export incentives receivable under various schemes are accounted on accrual basis.
f)	Foreign Currency Transactions The Company's financial statements have been prepared and presented in Indian Rupees (₹) which is also its functional currency. The transactions in foreign currency initially have been recorded using the rate of exchange prevailing on the date of transactions. The differences arising on the settlement/restatement of the foreign currency denominated Financial Assets/Liabilities into Indian Rupees have been recognized as expenses/income (net) of the year and carried to the statement of profit and loss. The monetary items denominated in foreign currencies outstanding as at the end of the reporting period, are not translated at the exchange rates prevailing as at the end of the reporting period.
g)	Investments in Associates Investments in associates company is recognized at cost as per Ind AS 28 "Separate Financial Statements" initially and subsequently carried at cost less accumulated impairment losses measured at the end of each year, if any. Company has invested in Associate company named Deep Additives Private Limited which is merged with Deep Polyalloy Limited (Previously known as Deep Masterbatch Limited). The Company had 9,90,000 equity shares in Deep Additives Private Limited. On arrangement of merger scheme of Deep Additives Private Limited and Deep Masterbatch Limited, the company has received equity shares in ratio of 1:146 of Deep Polyalloy Limited (Previously known as Deep Masterbatch Limited). The company has recorded investment in equity shares at face value.
h)	Employee Benefits: 1. Short Term Obligations: Short term employee benefits like wages, salaries, production incentives and other monetary and non-monetary benefits are recognized in the period during which services are rendered by the employees and are recognized at the value at which liabilities have been settled or are expected to be settled.

	2. Post-Employment and Other Long -Term Employee Benefits: 2.1 Contribution to Provident Fund & ESIC: The Company's contribution to the Provident Fund and ESIC is remitted as per the applicable provisions relating to the Employee Provident Fund Scheme and ESIC and such contributions are charged to the Statement of Profit & Loss of the period to which contributions relates. 2.2 Defined Benefit Plan for Gratuity: The Company operates defined benefit plans for Gratuity. The Liabilities in respect of retirement benefits to eligible employees in the form of Gratuity are provided on the basis of Actuarial Valuation as per Ind AS-19 "Employee Benefits". The employee's gratuity fund scheme is managed by Life Insurance Corporation of India, Pension and Group Schemes Department. The cost of providing defined benefits plans in the form of gratuity is determined using the Projected Unit Credit Method with actuarial valuation being carried out at each reporting date. The remeasurements, comprising of actuarial gains and losses, the effect of the asset ceiling (excluding amounts included in net interest on the net defined benefit liability) and the return on plan assets (excluding amounts included in net interest on the net defined benefit liability), are recognised immediately in the balance sheet with a corresponding debit or credit to retained earnings through OCI in the period in which they occur. The remeasurements are not reclassified to profit or loss in subsequent periods. The changes in net defined benefit obligations in the form of services costs comprising of current service cost, past service cost, net interest cost and gains/(losses) on curtailments and settlements are recognized in the Statement of Profit & Loss.
i)	Borrowing Costs Borrowing costs that are directly attributable to the acquisition or constructed of qualifying assets are capitalizes as part of such assets. A qualifying asset is one that necessarily takes substantial period of time to get ready for its intended use. Interest income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalization. All other borrowing costs are interest and ancillary costs incurred in connection with the arrangement of borrowings. The borrowing costs are recognised in the Statement of Profit and Loss in the period in which they are incurred.

j)	Operating Segment The Company identifies operating segments on the basis of dominant source, nature of risks and returns and the internal organization. The operating segments are the segments for which separate financial information is available and for which operating profit/loss amounts are evaluated regularly by the Managing Director/Chief Executive Officer who is Company's chief operating decision maker in deciding how to allocate resources and in assessing performance. The dominant source of income of the company is from the sale of masterbatches of various colour and Antifab filler of various quality which do not materially differ in respect of risk perception and the return realized/to be realized. Further, the geographical/regulatory environment in which the company operates are materially differ considering the assets employed and the risk and return associated in respect of each of the geographical area. The Group's business segments are identified based on the geographic locations of its units and the internal business reporting system as per Ind AS-108-"Operating Segments", Business segments of the company are primarily categorized as: Rakanpur, Santej and Hajipur
k)	Taxes On Income: 1. Current Tax: The provision for current tax is made as per the provisions of the Income Tax Act, 1961. Taxes on income have been determined based on the tax rates and tax laws that have been enacted or substantively enacted by the financial statements date. The current tax liabilities and assets are measured at the amounts expected to be paid or to be recovered from the taxation authorities as at the financial statements date. The current tax liabilities and assets are offset where the company has a legally enforceable right to offset and intends either to settle on a net basis or to realise the assets and settle the liabilities simultaneously. The current income tax relating to items recognized outside profit or loss is recognized either in the Other Comprehensive Income or in Other Equity directly.

	2. Deferred Tax: Deferred tax is provided on temporary differences between the tax bases of assets and liabilities as per the provisions of the Income Tax Act, 1961 and their carrying amounts for financial reporting purposes as at the financial statements date. Deferred tax liabilities are recognized for all taxable temporary timing differences. Deferred tax assets are recognized for all deductible taxable temporary timing differences, the carry forward of unused tax losses and unused tax credits to the extent to which future taxable profits are expected to be available against which the deductible temporary differences and the carry forward of unused tax losses and unused tax credits can be utilized/set-off. Deferred tax is calculated at the tax rates that are expected to apply in the period when the liability is settled or the asset is realised based on the tax rates and tax laws that have been enacted or substantially enacted by the end of the reporting period.
l)	Impairment of Tangible & Intangible Assets: Assets that are subject to depreciation or amortization are reviewed for impairment. Company assesses, at each reporting date, whether there is an indication that an asset may have been impaired. If any indication exists, or when annual impairment testing for an asset is required, the company estimates the asset's recoverable amount. An asset's recoverable amount is the higher of an asset's or cash-generating unit's (CGU) fair value less costs of disposal and its value in use. Recoverable amount is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets. Impairment loss is recognized when the carrying amount of an asset exceeds recoverable amount.
m)	Provisions, Contingent Liabilities and Contingent Assets The Company recognises a provision when it has a present obligation as a result of a past event that probably requires an outflow of the Company's resources embodying economic benefits at the time of settlement and a reliable estimate can be made of the amount of the obligation. The provisions are measured at the best estimate of the amounts required to settle the present obligation as at the financial statement date and are not discounted to its present value. Contingent liabilities are disclosed when there is a possible obligation arising from past events, the existence of which will be confirmed only on the occurrence or non-occurrence of one or more

	future uncertain events not wholly or substantially within the control of the Company or a present obligation that arises from the past events where it is either not probable that an outflow of resources will be required to settle the obligation or a reliable estimate of the amount cannot be made. When demand notices are issued by the Government Authorities and demand is disputed by the company and it is probable that the company will not be required to settle/pay such demands then these are classified as disputed obligations under contingent liabilities. Contingent Assets, if any, are not recognised in the financial statements. If it becomes certain that inflow of economic benefit will arise then such asset then relative income are recognised in financial statements.
n)	Current/Non-Current Classifications: The Company presents assets and liabilities in the balance sheet on the basis of their classifications into current and non-current. Assets: An asset is treated as current when it is: • Expected to be realised or intended to be sold or consumed in normal operating cycle • Held primarily for the purpose of trading • Expected to be realised within twelve months after the reporting period • Cash or cash equivalent unless restricted from being exchanged or used to settle a liability for at least twelve months after the reporting period. All other assets are classified as non-current. Liabilities: A liability is treated as current when it is: • Expected to be settled in normal operating cycle • Held primarily for the purpose of trading • Due to be settled within twelve months after the reporting period • No unconditional right to defer the settlement of the liability for at least twelve months after the reporting period. All other liabilities are classified as non-current.

o)	Financial Instruments, Financial Assets, Financial Liabilities and Equity Instruments
	The financial assets and financial liabilities are recognised when the Company becomes a party to the contractual provisions of the relevant instrument and are initially measured at fair value. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets and financial liabilities measured at fair value through profit or loss) are added to or deducted from the fair value on initial recognition of financial assets or financial liabilities. A. Financial Assets: Initial Recognition: Financial Assets include Investments, Trade Receivables, Security Deposits, Cash and Cash Equivalents and eligible current and non-current assets. The financial assets are initially recognized at the transaction price when the Company becomes party to contractual obligations. The transaction price includes transaction costs unless the asset is being value at fair value through the Statement of Profit and Loss. Subsequent Measurement: The subsequent measurement of financial assets depends upon the initial classification of financial assets. For the purpose of subsequent measurement, financial assets are classified as under: i. Financial Assets at Amortized Cost where the financial assets are held solely for collection of cash flows and contractual terms of the assets give rise on specified dates to cash flows that are solely payments of principal and interest on principal amount outstanding. ii. Fair value through other comprehensive income (FVTOCI), where the financial assets are held not only for realization of principal and interest but also from the sale of such assets. Such assets are subsequently measured at fair value, with unrealised gains and losses arising from changes in the fair value being recognised in other comprehensive income. iii. Fair value through profit or loss (FVTPL), where the assets are managed in accordance with an approved investment strategy that triggers purchase and sale decisions based on the fair value of such assets. Such assets are subsequently measured at fair value, with unrealised gains and losses arising from changes in the fair value being recognised in the Statement of Profit and Loss in the period in which they arise. Trade Receivables, Security Deposits, Cash and Cash Equivalents, Investments in Equity where

reliable data for fair value is not available and eligible current and non-current assets are classified for measurement at amortized cost.

Investments in quoted equity instruments are classified for measurement at FVTPL.

De-recognition of Financial Assets:

Financial Assets are derecognized when the contractual rights to cash flows from the financial assets expire or the financial asset is transferred and the transfer qualifies for de-recognition. On de-recognition of the financial assets in its entirety, the difference between the carrying amount (measured at the date of de-recognition) and the consideration received (including any new asset obtained less any new liability assumed) shall be recognized in the Statement of Profit and Loss.

Impairment:

If the recoverable amount of an asset (or cash-generating unit/Fixed Assets) is estimated to be less than its carrying amount, the carrying amount of the asset (or cash-generating unit) is reduced to its recoverable amount. An impairment loss is recognized immediately in profit or loss, unless the relevant asset is carried at a re-valued amount if any, in which case the impairment loss is treated as a revaluation decrease.

Financial assets, other than those at Fair Value through Profit and Loss (FVTPL), are assessed for indicators of impairment at the end of each reporting period. Financial assets are considered to be impaired when there is objective evidence that, as a result of one or more events that occurred after the initial recognition of the financial asset, the estimated future cash flows of the investment have been affected.

The company uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximizing the use of relevant observable inputs and minimizing the use of unobservable inputs.

	All assets and liabilities for which fair value is measured or disclosed in the financial statements are categorised within the fair value hierarchy, described as follows, based on the lowest level input that is significant to the fair value measurement as a whole: Level 1 — Quoted (unadjusted) market prices in active markets for identical assets or liabilities Level 2 — Valuation techniques for which the lowest level input that is significant to the fair value measurement is directly or indirectly observable. Level 3 — Valuation techniques for which the lowest level input that is significant to the fair value measurement is unobservable. For assets and liabilities that are recognised in the financial statements on a recurring basis, the Company determines whether transfers have occurred between levels in the hierarchy by re-assessing categorisation (based on the lowest level input that is significant to the fair value measurement as a whole) at the end of each reporting period. For the purpose of fair value disclosures, the Company has determined classes of assets and liabilities on the basis of the nature, characteristics and risks of the asset or liability and the level of the fair value hierarchy as explained above.
q)	Cash and Cash Equivalents-For the Purpose of Cash Flow Statements: Cash and cash equivalent in the balance sheet comprise cash at banks and in hand and short-term deposits with an original maturity of three months or less or deposits with bank held as margin money against the import of goods or as security against the supply of goods, which are subject to an insignificant risk of changes in value.
r)	Operating Cycle: Based on the activities of the company and normal time between incurring of liabilities and their settlement in cash or cash equivalents and acquisition/right to assets and their realization in cash or cash equivalents, the company has considered its operating cycle as 12 months for the purpose of classification of its liabilities and assets as current and non-current.
s)	Events Subsequent to Financial Statements Period: Events after the reporting period are those events, both favourable and unfavourable that have occurred between the end of the reported financial statements year and the date when financial statements are approved for issue by the Board of Directors of the company.

	Events after the reporting period can be identified as those that provide evidence of conditions that existed as at the end of the financial year i.e. adjusting events after the financial year end and those are indicative of conditions that arose after the financial year end i.e. non-adjusting events after the financial year end. The company adjusts the amounts of assets, liabilities, incomes and expenses recognised in the financial statements of the reporting period to reflect the effects of adjusting events to the respective assets, liabilities, incomes and expenses of the reporting period. The non-adjusting events are not recognised in the financial statement of the reporting period but the nature of event and an estimate of its financial effect are disclosed in the notes of accounts.
t)	Earnings Per Share:
	The Company presents basic and diluted earnings per share details for its ordinary shares. Basic earning per share is calculated by dividing the net profit after tax for the year attributable to the ordinary shareholders of the company by weighted number of ordinary shares outstanding for applicable period during the year. Diluted earnings per share is calculated considering the effect of dilution if any to ordinary share during the year.

d) Income tax demand

In the financial year 2021-22, Deep plast industries a partnership firm was merged with the company vide resolution dated 13th September, 2021 by members of the company with all assets, liability, expense and incomes with effect from “effective date”. The merged partnership firm has income tax

credit in the form of TDS, TCS, Advance Tax and self-assessment tax for the financial year 2021-22 which the company has claimed its return of income for Assessment year 2022-23. However, CPC, Income tax department Bengaluru while processing the same return has not allowed credit of such taxes paid and hence raised demand of Rs. 373.17 Lacs. The Company has representation before the income tax department for wrongful non-allowance of tax credit and it is expected as once the department rectifies the mistake. It is expected that, there will be no income tax liability on account of this and hence there is no provision made for such income tax demand in the booked of accounts. And the Same has been disclosed in the contingent liability.

	Trade Receivables:		
	Credit risk refers to the risk of default on its obligation by the counterparty resulting in a financial loss to the Company. The maximum exposure to the credit risk as at the reporting date is primarily from trade receivables. Trade receivables are unsecured and are derived from revenue earned from customers from		

sale of goods. Trade receivables generally are impaired after three years when recoverability is considered doubtful based on general trend. The Company considers that trade receivables stated in the financial statements are not impaired and past due for each reporting dates under review are of good credit quality subject to outcome of the litigations where the company has initiated legal proceedings for recovery.

Other Financial Assets:

Credit risk relating to cash and cash equivalents is considered negligible since the counterparties are banks which are majorly owned by Government of India and have oversight of Reserve Bank of India. The Company considers the credit quality of term deposits with banks to be good and the company reviews these banking relationships on an ongoing basis.

The Company considers all other financial assets as at the financial statement dates to be of good credit quality.

II. Liquidity Risk:

The company's principal sources of liquidity are from Short Term Bank Borrowings, Cash and Cash Equivalents and Cash generated from operations.

The Short- term liquidity requirements consist mainly of Trade Payables, Expense Payables, Employee Dues, Servicing of Interest on Short -Term and Long -Term Borrowings and payment of instalments of term loans and vehicle loans and other payments arising during the normal course of business.

III. Foreign Exchange Rate Risk:

The Company undertakes transactions denominated in foreign currency mainly for purchase of raw materials and sale of goods which are subject to the risk of exchange rate fluctuations. Financial assets and liabilities denominated in foreign currency are also subject to reinstatement risks.

IV. Interest Rate Risk:

Interest rate risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market interest rates. The Company's exposure to the risk of changes in market interest rates relates primarily to the Company's long-term debt obligations with floating interest rates.

The Company manages its capital structure and makes adjustments to it in light of changes in economic conditions and the requirements of the financial covenants. QUALIFIED OPINION

We have audited the consolidated financial statements of **DEEP POLYMERS** ("the Company"), which comprise the Consolidated Balance Sheet as at March 31, 2026, the Consolidated Statement of Profit and Loss (Including Other Comprehensive Income), the Consolidated Statement of Changes In Equity and the Consolidated Statement of Cash Flows for the year then ended and notes to the consolidated financial statements, including a summary of material accounting policies and other explanatory information (hereinafter referred to as "Consolidated Financial Statements").

In our opinion and to the best of our information and according to the explanations given to us, the aforesaid consolidated financial statements except "for effect of compliance of Ind-AS 21 regarding restatement of foreign currency Assets and liability as at the end of the year and the effect for the possible effects of matter described in the basis for qualified opinion" give the information required by the Companies Act, 2013 ("Act") in the manner so required and give a true and fair view in conformity with the accounting principles generally accepted in India including Indian Accounting Standards ('Ind AS') specified under Section 133 of the Act read with the Companies (Indian Accounting Standards) Rules, 2015 as amended, of the state of affairs of the Company as at March 31, 2026, and its profit and other comprehensive income, changes in equity and its cash flows for the year ended on that date.

BASIS FOR QUALIFIED OPINION:

1. The Current Financial Assets: Trade Receivables reported in the financial results include trade receivable of Rs. 308.06 Lacs outstanding in respect of which the company has initiated legal procedure for recovery. The company has considered these outstanding trade receivables as good for recovery at the value at which they have been stated in the financial statement. In our opinion, the necessary provision for doubtful debts should have been made by the company. Non-provision of such doubtful debts of Rs. 308.06 Lacs has resulted in an overstatement of profit and an overstatement of the outstanding balance of current trade receivables and shareholder's fund by Rs. 308.06 Lacs.
2. The monetary items denominated in foreign currencies outstanding as at the end of the reporting period, have not been restated by the company at the exchange rates prevailing as at the end of the reporting period in accordance with Ind-AS-21 "The Effects of Changes in Foreign Exchange Rates. Non-restatement of foreign currencies denominated financial items have resulted into overstatement/understatement of respective foreign currency denominated financial items as at the end of the financial year and consequent profits for the year and accumulated balances of profits as at the end of the financial year.

We conducted our audit in accordance with the Standards on Auditing (SAs) specified under section 143(10) of the Act. Our responsibilities under those Standards are further described in the Auditor's Responsibilities for the Audit of the Consolidated Financial Statements section of our report.

We are independent of the Company in accordance with the Code of Ethics issued by the Institute of Chartered Accountants of India together with the ethical requirements that are relevant to our audit of the consolidated financial statements under the provisions of the Act and the Rules thereunder, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the Code of Ethics. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

KEY AUDIT MATTERS:

Key audit matters are those matters that, in our professional judgment, were of most significance in our audit of the consolidated financial statements of the current period. These matters were addressed in the context of our audit of the consolidated financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters. In addition to the matters described in the Basis for Qualified Opinion Section, we have determined the matters described below to be the key audit matters to be communicated in our report.

Our opinion on the consolidated financial statements does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the consolidated financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the consolidated financial statements or our knowledge obtained in the audit or otherwise appears to be materially misstated. If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these consolidated financial statements.

DEEP POLYMERS LIMITED is a public company domiciled in India and is incorporated under the provisions of the Companies Act applicable in India. The registered office of the company is located at Gandhinagar, Gujarat, India. The shares of the company are listed in one recognized stock exchanges in India i.e. the Bombay Stock Exchange Limited ('BSE') The company is engaged in the manufacturing of Masterbatches since 1992 and Antifab Filler Masterbatches since 2004.	
NOTE 1: MATERIAL ACCOUNTING POLICIES:	
I	BASIS OF PREPARATION & PRESENTATION OF FINANCIAL STATEMENTS
a)	Accounting Conventions: The financial statements of the Company have been prepared in accordance with Indian Accounting Standards (Ind AS) notified under the Companies (Indian Accounting Standards) Rules, 2015 and with Companies (Indian Accounting Standards) (Amendment) Rules, 2017 and such further amendments as notified and as applicable and comply in all material aspects with the relevant provisions of the Companies Act, 2013 to the extent applicable to it. The Financial Statements have been prepared on a historical cost basis except the following assets and liabilities which have been measured at fair values: • Certain Financial Assets and Liabilities that are measured at Fair Value and • Defined Benefit Plans that are measured at Fair Value The accounting policies are applied consistently to all the periods reported in the financial statements unless otherwise stated.
b)	Use of Estimates: The preparation of financial statements requires management to make estimates and assumptions that are believed to be reasonable under the circumstances and such estimates and assumptions may affect the reported amount of assets and liabilities, classification of assets and liabilities into non-current and current and disclosures relating to contingent liabilities as at the date of financial statements and the reported amounts of income and expenses during the reporting period. Although the financial statements have been prepared based on the management's best knowledge of current events and procedures/actions, the actual results may differ on the final outcome of the matter/transaction to which the estimates relate.

c)	1. Property, Plant and Equipment (PPE):
	The cost of an item of property, plant and equipment is recognized as an asset if, and only if: (a) it is probable that future economic benefits associated with the item will flow to the company; and (b) the cost of the item can be measured reliably. The acquisition of property, plant and equipment, directly increasing the future economic benefits of any particular existing item of property, plant and equipment, which are necessary for the Company to obtain the future economic benefits from its other assets, are recognized as Property, Plant and Equipment. The Freehold land is carried/stated at historical cost/cost of acquisition. The other items of Property, Plant and Equipment are stated at cost of acquisition/construction (less Accumulated Depreciation and Impairment, if any). The cost of Property, Plant and Equipment comprises of their purchase prices including freight, duties, taxes or levies, directly attributable to cost of bringing the assets to their working conditions for their intended use. The Company capitalises its Property, Plant and Equipment at a value net of GST/Other Tax Credits received/receivable during the year in respect of eligible item of Property, Plant and Equipment. Subsequent costs are included in the carrying amount of respective Property, Plant and Equipment or recognized as separate assets as appropriate, only if such costs increase the future economic benefits from the existing items beyond their previously assessed standard of performance and cost of such items can be measured reliably. Machinery spares that meet the definition of Property, Plant & Equipment are capitalised and depreciated over the useful life of the principal item of an asset. All other repair and maintenance costs, including regular servicing, are recognised in the Statement of Profit and Loss as incurred. The items of Property, Plant and Equipment that are under construction/erection or not fully acquired and therefore not available for productive use are classified as “Capital Work in Progress” under Building, Furniture and fixture, Property, Plant and Equipment and solar and are/will be transferred to respective item of Building, Furniture and fixture, Property, Plant and Equipment and solar plant on completion of the construction/erection/acquisition activities. Advances given to acquire property, plant and equipment are stated as non-current assets and

subsequently transferred to respective Building, Furniture and fixture, Property, Plant and Equipment and solar plant and CWIP on acquisition of related assets.

The carrying amounts of items of Property, Plant & Equipment have been eliminated from the books of account on disposal and the profits/(losses) arising from the disposal are recognised in the Statement of Profit and Loss of the period.

Old trucks were sold during the current financial year. The sale value is subtracted straight from the cost since there are insufficient specifics regarding the cost and depreciation thereon.

3. Right-of-use Assets:

The ROU asset is initially measured at cost, comprising the initial measurement of the lease liability, lease payments made at or before the commencement date (less any lease incentives received), initial direct costs incurred, and an estimate of costs to dismantle and remove the underlying asset or restore the site.

In cases where lease payments are made fully in advance at or before the commencement date and no lease liability exists on initial recognition, the cost of the right-of-use asset includes such prepaid lease payments together with any initial direct costs and estimated restoration costs, if applicable.

Subsequently, the ROU asset is measured at cost less accumulated depreciation and accumulated impairment losses, if any. Depreciation is recognised on a straight-line basis over the shorter of the lease

	term and the useful life of the underlying asset, unless ownership of the underlying asset is expected to transfer to the Company at the end of the lease term. The Company assesses the ROU asset for impairment in accordance with the requirements of Indian Accounting Standard (Ind AS) 36.
	4. Investment Properties:
	The property that is held by the company for rental yields or for capital appreciation for the relevant period is classified as investment property. The investment property is initially recognized at cost and subsequently carried at cost less accumulated depreciation and accumulated impairment losses, if any. Subsequent expenditures on such assets are capitalized to the asset's carrying value only when it is probable that future economic benefits associated with the expenditure will flow to the company or such cost are incurred to comply with regulatory requirements or have been incurred in connection with continued use of such assets and cost of such items can be measured reliably. All other repairs and maintenance cost are expensed as and when incurred.
	5. Intangible Assets:
	The Intangible Assets of Accounting Software, Server Software, Website Development resulting in future economic benefits have been recognised at their cost of acquisition and subsequently are carried at cost less accumulated amortisation and accumulated impairment losses, if any. On the basis of the availability of these assets for their intended use, relevant contractual agreements and technological changes that may affect the usefulness of these assets, the useful lives of these assets have been assumed to be of six years from the date of their acquisition. The estimated useful life is reviewed annually by the management of the company.
	6. Depreciation & Amortization:
	The Depreciation on tangible items of Property, Plant and Equipment is provided on written down value method for the period of acquisition/construction i.e. from the period from which such assets were available for their intended use on pro-rata basis on the basis of useful life of each of the items of Property, Plant and Equipment as per Schedule II of the Companies Act, 2013 and in the manner specified in Schedule II of the Companies Act, 2013 except freehold land and other related development on that land. The intangible assets have been amortized on pro-rata basis over period of their estimated useful lives on written down value basis i.e. @ 39.30% assuming useful life of six years.

d)	Inventories The Inventories of Raw Materials have been valued at cost. Finished Goods have been valued at cost or net realisable value whichever is lower. Costs in respect of all items of inventories have been computed on FIFO method which is considered upon lot used for manufacturing. The cost of Raw Materials comprises of the purchase price including duties and taxes, freight inwards and other expenditure directly attributable to the acquisition. The purchase price does not include GST/Other Tax credits availed of by the Company during the year. The cost of Finished Goods includes cost of conversion and other costs incurred in bringing the inventories to their present location and conditions. The Finished Goods are valued at cost after availing of GST/Other Tax credits on input materials.
e)	Revenue Recognition: Revenue is measured at the fair value of the consideration received or receivable from the customers/parties net of returns, rebates, value added taxes and discount to the customers and amounts collected on behalf of third parties. The Revenue is recognised to the extent that it is probable that the economic benefits will flow to the Company and the revenue can be measured reliably, regardless of when the payment is being made. Sale of Goods: The revenue from the sale of goods is recognized at transaction price when the company had transferred the property in Goods to the buyer for a price and all significant risks and rewards of ownership had been transferred to the buyer and no significant uncertainty existed as to the amount of consideration that would be derived from such sale. The recognition event is usually the dispatch of goods to the buyer such that the Company retains no effective control over the goods dispatched. Interest Income: Income from investments and deposits, where appropriate, is taken into revenue in full on declaration or accrual on time basis and tax deducted at source thereon is treated as advance tax. The interest income from a financial asset is recognized when it is probable that the economic benefits will flow to the company and the amount interest income can be measured reliably.

	Dividend Income: Dividend income is recognized in statement of profit and loss only when the right to receive payment is established. Export Incentives: Export incentives receivable under various schemes are accounted on accrual basis.
f)	Foreign Currency Transactions The Company's financial statements have been prepared and presented in Indian Rupees (₹) which is also its functional currency. The transactions in foreign currency initially have been recorded using the rate of exchange prevailing on the date of transactions. The differences arising on the settlement/restatement of the foreign currency denominated Financial Assets/Liabilities into Indian Rupees have been recognized as expenses/income (net) of the year and carried to the statement of profit and loss. The monetary items denominated in foreign currencies outstanding as at the end of the reporting period, are not translated at the exchange rates prevailing as at the end of the reporting period.
g)	Investments in Associates Company had invested in Associate company named Deep Additives Private Limited which is merged with Deep Polyalloy Limited (Previously known as Deep Masterbatch Limited). The Company had 9,90,000 equity shares in Deep Additives Private Limited. On arrangement of merger scheme of Deep Additives Private Limited and Deep Masterbatch Limited, the company has received equity shares in ratio of 1:146 of Deep Polyalloy Limited (Previously known as Deep Masterbatch Limited). The company has recorded investment in equity shares at face value.
h)	Employee Benefits: 1. Short Term Obligations: Short term employee benefits like wages, salaries, production incentives and other monetary and non-monetary benefits are recognized in the period during which services are rendered by the employees and are recognized at the value at which liabilities have been settled or are expected to be settled. 2. Post-Employment and Other Long -Term Employee Benefits: 2.1 Contribution to Provident Fund & ESIC: The Company's contribution to the Provident Fund and ESIC is remitted as per the applicable

	provisions relating to the Employee Provident Fund Scheme and ESIC and such contributions are charged to the Statement of Profit & Loss of the period to which contributions relates.
	2.2 Defined Benefit Plan for Gratuity:
	The Company operates defined benefit plans for Gratuity. The Liabilities in respect of retirement benefits to eligible employees in the form of Gratuity are provided on the basis of Actuarial Valuation as per Ind AS-19 “Employee Benefits”. The employee’s gratuity fund scheme is managed by Life Insurance Corporation of India, Pension and Group Schemes Department. The cost of providing defined benefits plans in the form of gratuity is determined using the Projected Unit Credit Method with actuarial valuation being carried out at each reporting date. The remeasurements, comprising of actuarial gains and losses, the effect of the asset ceiling (excluding amounts included in net interest on the net defined benefit liability) and the return on plan assets (excluding amounts included in net interest on the net defined benefit liability), are recognised immediately in the balance sheet with a corresponding debit or credit to retained earnings through OCI in the period in which they occur. The remeasurements are not reclassified to profit or loss in subsequent periods. The changes in net defined benefit obligations in the form of services costs comprising of current service cost, past service cost, net interest cost and gains/(losses) on curtailments and settlements are recognized in the Statement of Profit & Loss.
i)	Borrowing Costs
	Borrowing costs that are directly attributable to the acquisition or constructed of qualifying assets are capitalizes as part of such assets. A qualifying asset is one that necessarily takes substantial period of time to get ready for its intended use. Interest income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalization. All other borrowing costs are interest and ancillary costs incurred in connection with the arrangement of borrowings. The borrowing costs are recognised in the Statement of Profit and Loss in the period in which they are incurred.
j)	Operating Segment
	The Company identifies operating segments on the basis of dominant source, nature of risks and returns and the internal organization. The operating segments are the segments for which separate

	financial information is available and for which operating profit/loss amounts are evaluated regularly by the Managing Director/Chief Executive Officer who is Company's chief operating decision maker in deciding how to allocate resources and in assessing performance. The dominant source of income of the company is from the sale of masterbatches of various colour and Antifab filler of various quality which do not materially differ in respect of risk perception and the return realized/to be realized. Further, the geographical/regulatory environment in which the company operates are materially differ considering the assets employed and the risk and return associated in respect of each of the geographical area. The Group's business segments are identified based on the geographic locations of its units and the internal business reporting system as per Ind AS-108-"Operating Segments", Business segments of the company are primarily categorized as: Rakanpur, Santej and Hajipur
k)	Taxes On Income: 1. Current Tax: The provision for current tax is made as per the provisions of the Income Tax Act, 1961. Taxes on income have been determined based on the tax rates and tax laws that have been enacted or substantively enacted by the financial statements date. The current tax liabilities and assets are measured at the amounts expected to be paid or to be recovered from the taxation authorities as at the financial statements date. The current tax liabilities and assets are offset where the company has a legally enforceable right to offset and intends either to settle on a net basis or to realise the assets and settle the liabilities simultaneously. The current income tax relating to items recognized outside profit or loss is recognized either in the Other Comprehensive Income or in Other Equity directly. 2. Deferred Tax: Deferred tax is provided on temporary differences between the tax bases of assets and liabilities as per the provisions of the Income Tax Act, 1961 and their carrying amounts for financial reporting purposes as at the financial statements date.

	Deferred tax liabilities are recognized for all taxable temporary timing differences. Deferred tax assets are recognized for all deductible taxable temporary timing differences, the carry forward of unused tax losses and unused tax credits to the extent to which future taxable profits are expected to be available against which the deductible temporary differences and the carry forward of unused tax losses and unused tax credits can be utilized/set-off. Deferred tax is calculated at the tax rates that are expected to apply in the period when the liability is settled or the asset is realised based on the tax rates and tax laws that have been enacted or substantially enacted by the end of the reporting period.
l)	Impairment of Tangible & Intangible Assets: Assets that are subject to depreciation or amortization are reviewed for impairment. Company assesses, at each reporting date, whether there is an indication that an asset may have been impaired. If any indication exists, or when annual impairment testing for an asset is required, the company estimates the asset's recoverable amount. An asset's recoverable amount is the higher of an asset's or cash-generating unit's (CGU) fair value less costs of disposal and its value in use. Recoverable amount is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets. Impairment loss is recognized when the carrying amount of an asset exceeds recoverable amount.
m)	Provisions, Contingent Liabilities and Contingent Assets The Company recognises a provision when it has a present obligation as a result of a past event that probably requires an outflow of the Company's resources embodying economic benefits at the time of settlement and a reliable estimate can be made of the amount of the obligation. The provisions are measured at the best estimate of the amounts required to settle the present obligation as at the financial statement date and are not discounted to its present value. Contingent liabilities are disclosed when there is a possible obligation arising from past events, the existence of which will be confirmed only on the occurrence or non-occurrence of one or more future uncertain events not wholly or substantially within the control of the Company or a present obligation that arises from the past events where it is either not probable that an outflow of resources will be required to settle the obligation or a reliable estimate of the amount cannot be made. When demand notices are issued by the Government Authorities and demand is disputed by the

	company and it is probable that the company will not be required to settle/pay such demands then these are classified as disputed obligations under contingent liabilities. Contingent Assets, if any, are not recognised in the financial statements. If it becomes certain that inflow of economic benefit will arise then such asset then relative income are recognised in financial statements.
n)	Current/Non-Current Classifications:

profit or loss) are added to or deducted from the fair value on initial recognition of financial assets or financial liabilities.

A. Financial Assets:

Initial Recognition:

Financial Assets include Investments, Trade Receivables, Security Deposits, Cash and Cash Equivalents and eligible current and non-current assets. The financial assets are initially recognized at the transaction price when the Company becomes party to contractual obligations. The transaction price includes transaction costs unless the asset is being value at fair value through the Statement of Profit and Loss.

Subsequent Measurement:

The subsequent measurement of financial assets depends upon the initial classification of financial assets. For the purpose of subsequent measurement, financial assets are classified as under:

- i. Financial Assets at Amortized Cost where the financial assets are held solely for collection of cash flows and contractual terms of the assets give rise on specified dates to cash flows that are solely payments of principal and interest on principal amount outstanding.
- ii. Fair value through other comprehensive income (FVTOCI), where the financial assets are held not only for realization of principal and interest but also from the sale of such assets. Such assets are subsequently measured at fair value, with unrealised gains and losses arising from changes in the fair value being recognised in other comprehensive income.
- iii. Fair value through profit or loss (FVTPL), where the assets are managed in accordance with an approved investment strategy that triggers purchase and sale decisions based on the fair value of such assets. Such assets are subsequently measured at fair value, with unrealised gains and losses arising from changes in the fair value being recognised in the Statement of Profit and Loss in the period in which they arise.

Trade Receivables, Security Deposits, Cash and Cash Equivalents, Investments in Equity where reliable data for fair value is not available and eligible current and non-current assets are classified for measurement at amortized cost.

Investments in quoted equity instruments are classified for measurement at FVTPL.

De-recognition of Financial Assets:

Financial Assets are derecognized when the contractual rights to cash flows from the financial assets

expire or the financial asset is transferred and the transfer qualifies for de-recognition. On de-recognition of the financial assets in its entirety, the difference between the carrying amount (measured at the date of de-recognition) and the consideration received (including any new asset obtained less any new liability assumed) shall be recognized in the Statement of Profit and Loss.

Impairment:

If the recoverable amount of an asset (or cash-generating unit/Fixed Assets) is estimated to be less than its carrying amount, the carrying amount of the asset (or cash-generating unit) is reduced to its recoverable amount. An impairment loss is recognized immediately in profit or loss, unless the relevant asset is carried at a re-valued amount if any, in which case the impairment loss is treated as a revaluation decrease.

Financial assets, other than those at Fair Value through Profit and Loss (FVTPL), are assessed for indicators of impairment at the end of each reporting period. Financial assets are considered to be impaired when there is objective evidence that, as a result of one or more events that occurred after the initial recognition of the financial asset, the estimated future cash flows of the investment have been affected.

B. Financial Liabilities:

Initial Recognition:

Financial Liabilities are initially recognized at fair value plus any transaction costs, (if any) which are attributable to acquisition of the financial liabilities.

Subsequent Measurement:

Financial Liabilities are classified for subsequent measurement into following categories:

(i) Financial liabilities at Amortized Cost:

- Other Financial Liabilities

Amortized cost for financial liabilities represents amount at which financial liability is measured at initial recognition minus the principal repayments, plus or minus cumulative amortization using the effective interest method of any differences between the initial

	amount and maturity amount. (ii) Financial liabilities at Fair Value through Profit or Loss: Financial liabilities held for trading are measured at Fair Value through Profit or Loss De-recognition of Financial Liabilities: Financial liabilities shall be derecognized when, and only when, it is extinguished i.e. when the obligation specified in the contract is discharged or cancelled or expires.
p)	Fair Value Measurement: The Company measures financial instruments, such as, derivatives at fair value at each financial statement date. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either: • In the principal market for the asset or liability, or in the absence of a principal market, in the most advantageous market for the asset or liability • The principal or the most advantageous market must be accessible by the Company. The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest. A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use. The company uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximizing the use of relevant observable inputs and minimizing the use of unobservable inputs. All assets and liabilities for which fair value is measured or disclosed in the financial statements are categorised within the fair value hierarchy, described as follows, based on the lowest level input that is significant to the fair value measurement as a whole: Level 1 — Quoted (unadjusted) market prices in active markets for identical assets or liabilities Level 2 — Valuation techniques for which the lowest level input that is significant to the fair value

	measurement is directly or indirectly observable. Level 3 — Valuation techniques for which the lowest level input that is significant to the fair value measurement is unobservable. For assets and liabilities that are recognised in the financial statements on a recurring basis, the Company determines whether transfers have occurred between levels in the hierarchy by re-assessing categorisation (based on the lowest level input that is significant to the fair value measurement as a whole) at the end of each reporting period. For the purpose of fair value disclosures, the Company has determined classes of assets and liabilities on the basis of the nature, characteristics and risks of the asset or liability and the level of the fair value hierarchy as explained above.
q)	Cash and Cash Equivalents-For the Purpose of Cash Flow Statements: Cash and cash equivalent in the balance sheet comprise cash at banks and in hand and short-term deposits with an original maturity of three months or less or deposits with bank held as margin money against the import of goods or as security against the supply of goods, which are subject to an insignificant risk of changes in value.
r)	Operating Cycle: Based on the activities of the company and normal time between incurring of liabilities and their settlement in cash or cash equivalents and acquisition/right to assets and their realization in cash or cash equivalents, the company has considered its operating cycle as 12 months for the purpose of classification of its liabilities and assets as current and non-current.
s)	Events Subsequent to Financial Statements Period: Events after the reporting period are those events, both favourable and unfavourable that have occurred between the end of the reported financial statements year and the date when financial statements are approved for issue by the Board of Directors of the company. Events after the reporting period can be identified as those that provide evidence of conditions that existed as at the end of the financial year i.e. adjusting events after the financial year end and those are indicative of conditions that arose after the financial year end i.e. non-adjusting events after the financial year end.

	The company adjusts the amounts of assets, liabilities, incomes and expenses recognised in the financial statements of the reporting period to reflect the effects of adjusting events to the respective assets, liabilities, incomes and expenses of the reporting period. The non-adjusting events are not recognised in the financial statement of the reporting period but the nature of event and an estimate of its financial effect are disclosed in the notes of accounts.
t)	Earnings Per Share: The Company presents basic and diluted earnings per share details for its ordinary shares. Basic earning per share is calculated by dividing the net profit after tax for the year attributable to the ordinary shareholders of the company by weighted number of ordinary shares outstanding for applicable period during the year. Diluted earnings per share is calculated considering the effect of dilution if any to ordinary share during the year.

III Rights, Preferences and Restrictions Attached to Shares:

The company has a single class of equity shares. Accordingly, all equity shares rank equally with regard to dividends and shares in the company's residual assets. The equity shares are entitled to receive dividend as declared from time to time subject to payment of dividend to preference shareholders. The voting rights of an equity shareholder on a poll (not on showoff hands) are in proportion to its share of the paid-up equity capital of the company. Voting rights cannot be exercised in respect of shares on which any call or other sums presently payable have not been paid.

Failure to pay any amount called up on shares may lead to forfeiture of the shares.

Financial Risk Management:			
The company activities are exposed various financial risks: credit risk, liquidity risk, foreign exchange fluctuation risk, Interest rate risk and Market Risk. The Company’s primary focus is to foresee the unpredictability of financial markets and seek to minimize potential adverse effects on its financial performance.			
I. Credit Risk:			
Trade Receivables:			
Credit risk refers to the risk of default on its obligation by the counterparty resulting in a financial loss to the Company. The maximum exposure to the credit risk as at the reporting date is primarily from trade			

receivables. Trade receivables are unsecured and are derived from revenue earned from customers from sale of goods. Trade receivables generally are impaired after three years when recoverability is considered doubtful based on general trend. The Company considers that trade receivables stated in the financial statements are not impaired and past due for each reporting dates under review are of good credit quality subject to outcome of the litigations where the company has initiated legal proceedings for recovery.

Other Financial Assets:

Credit risk relating to cash and cash equivalents is considered negligible since the counterparties are banks which are majorly owned by Government of India and have oversight of Reserve Bank of India. The Company considers the credit quality of term deposits with banks to be good and the company reviews these banking relationships on an ongoing basis.

The Company considers all other financial assets as at the financial statement dates to be of good credit quality.

II. Liquidity Risk:

The company's principal sources of liquidity are from Short Term Bank Borrowings, Cash and Cash Equivalents and Cash generated from operations.

The Short- term liquidity requirements consist mainly of Trade Payables, Expense Payables, Employee Dues, Servicing of Interest on Short -Term and Long -Term Borrowings and payment of instalments of term loans and vehicle loans and other payments arising during the normal course of business.

III. Foreign Exchange Rate Risk:

The Company undertakes transactions denominated in foreign currency mainly for purchase of raw materials and sale of goods which are subject to the risk of exchange rate fluctuations. Financial assets and liabilities denominated in foreign currency are also subject to reinstatement risks.

IV. Interest Rate Risk:

Interest rate risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market interest rates. The Company's exposure to the risk of changes in market interest rates relates primarily to the Company's long-term debt obligations with floating interest rates.

- Interest rate sensitivity:

The following table demonstrates the sensitivity to a reasonably possible change in interest rates on loans and borrowings. With all other variables held constant, the Company's profit before tax is affected

V. Market Risk:

Market risk is the risk that changes in market prices, liquidity and other factors that could have an adverse effect on realizable fair values or future cash flows to the Company. The Company's activities expose it primarily to the financial risks of changes in foreign currency exchange rates and interest rates as future specific market changes cannot be normally predicted with reasonable accuracy.

i) Capital Management

For the purpose of the Company's capital management, capital includes issued equity capital and all other equity reserves attributable to the equity holders of the Company. The primary objective of the Company's capital management is to ensure that it maintains a strong credit rating and healthy capital ratios in order to support its business and maximize return to stakeholders through the optimization of the debt and equity balance.

The Company manages its capital structure and makes adjustments to it in light of changes in economic conditions and the requirements of the financial covenants. The Company monitors capital using a gearing ratio, which is net debt divided by total capital plus net debt. The Company includes, within net debt, interest bearing loans and borrowings, trade and other payables, less cash and short-term deposits. (Rs. In Lacs)
