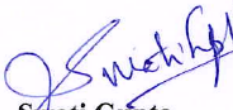

The fund received till June 30, 2026 has been utilized for the objects for which the funds have been raised.

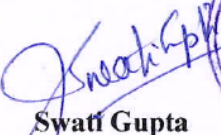

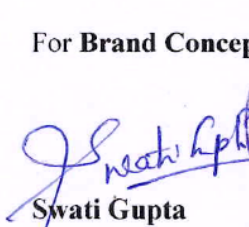
