Independent Auditor's Review Report on Unaudited Quarterly Financial Results of Anmol India Limited Pursuant to the Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (as amended)

To Board of Directors of Anmol India Limited

1. We have reviewed the accompanying statement of unaudited financial results of Anmol India Limited ('the Company') for the quarter ended 30 June 2026 ('the Statement') being submitted by the Company pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015, as amended ('the Listing Regulations').
2. 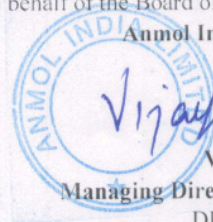
