3. Dispatch of Notice convening the AGM:

As informed by the Company, the Notice of AGM of the Company dated 28th August 2026 along with Annual Report for the financial year 2025-26, were sent on 02nd September 2026 through email to all the entitled Shareholders (as on cut-off date, which was fixed as 28th August 2026) whose email addresses were registered with the Company/Registrar & Share Transfer Agent or the Depositories.

Further, the Public Advertisements with respect to completion of dispatch of Notice and Annual Report 2025-26 were published on 3rd September 2026 in an English Newspaper i.e., Financial Express (English) and in Regional Language Newspaper i.e., Financial Express (Regional Language).

4. Cut-off and Remote e-voting process:

The Company has availed the E-Voting facility (Remote E-Voting and E-Voting at AGM) from Bigshare Services Private Limited ("Big Share"). The Company had also uploaded the Notice of AGM and Annual Report on the website i.e. www.wealth-firstonline.com/investor-relations to facilitate the shareholders to cast their vote through remote e-voting.

As per the Notice of AGM, the Shareholders of the Company holding Equity Shares as on Thursday, 17th September 2026 (*Cut-off date for voting*) were entitled for E-Voting on the resolutions.

The remote e-voting period commenced on Monday, 21st September 2026 (09:00 A.M. IST) and ended on Wednesday, 23rd September 2026 (05:00 P.M. IST) both days inclusive; thereafter the Big Share e-voting platform was blocked and then re-opened during the AGM.

The Company has also provided the facility of e-voting at the AGM for the Members who had not cast their vote by remote e-voting.

5. Counting Process:
