The Exchange passed an interim order in connection with the non-accessibility of the Company's earlier Registered Office situated at:

The non-accessibility of the said premises was purely temporary and arose due to circumstances beyond the Company's control. To ensure uninterrupted regulatory compliance and business continuity, the Company has shifted its Registered Office to the following address:
