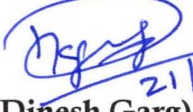

Government of Maharashtra, vide its Gazette Notification dated February 27, 2026 had allocated one intra-state transmission project, wherein REC Power Development and Consultancy Limited (RECPDCL) has been appointed to act as Bid Process Coordinator (BPC) for the purpose of Establishment of 400 kV GIS Solapur/Paranda Switching Station (Dist. - Dharashiv). In view of the above, Dharashiv Power Transmission Limited has been incorporated on July 21, 2026. After selection of the successful bidder in accordance with the Tariff Based Competitive Bidding (TBCB) guidelines, said company would be transferred to the successful bidder along with all assets & liabilities.
