1. Hon'ble Mr. Justice P. S. Narasimha pronounced the Reportable Judgment of the Bench comprising His Lordship and Hon'ble Mr. Justice Alok Aradhe.

2. The operative portion of the Judgment is reproduced hereunder :-

"24. In conclusion, we direct the MoEF&CC to take into account the above-referred principles for determination and imposition of environmental compensation, as also the Rules that operate in the field, to formulate the necessary guidelines to be issued under Rule 17(2) of the Solid Waste Management Rules, 2026.

25. The MoEF&CC shall file an affidavit and shall place on record the progress in the making and the issuance of the regulations.

26. List these appeals on 29.09.2026."
