O R D E R

1. We have heard the learned Attorney General for India and the learned Senior Counsel appearing for the parties.
2. The learned Attorney General of India has supplied a note incorporating the offer of the OMCs on the allocation methodology of Q4 ESY 25-26 to all the bidders. The same is taken on record and shall form a part and parcel of

this order.

3. Pending the final order to be passed in the present Special Leave Petitions, we give our imprimatur to the suggestion made by the learned Attorney General for India by way of an interim arrangement.

4. This order is being passed without prejudice to the contentions of the parties and without equities being compromised.
