1. Leave granted.

2. After hearing the learned counsel appearing for the parties briefly, it appears to us that in the interest of justice and equity, the matter requires to be heard and decided by the High Court afresh. We are not assigning reasons and/or noticing the facts so that any prejudice is caused to the parties.

3. We may, however, hasten to add that, according to respondents, the matter ought to be referred to the National Green Tribunal instead of the High Court. Such objection, in our considered opinion, can be raised and shall be considered by the High Court. We do not express any opinion in relation thereto.

4. For the reasons aforesaid, the appeal is allowed. The impugned judgment dated 10.12.2025 is set aside, and the matter is remitted to the High Court for fresh

adjudication.

5. The parties are directed to appear before the High Court on 31.07.2026.
